A RESOLUTION

- 1 Recognizing and commending the Bleckley/Pulaski Forestry Unit on being named the
- 2 Georgia Forestry Commission 2012 Southern Unit of the Year and inviting its members to
- 3 appear before the House of Representatives; and for other purposes.
- 4 WHEREAS, the mission of the Georgia Forestry Commission is "To provide leadership,
- 5 service, and education in the protection and conservation of Georgia's forest resources"; and
- 6 WHEREAS, each year, one forestry unit is selected as the Georgia Forestry Commission's
- 7 Southern Unit of the Year based on various measures of accomplishment that are weighed
- 8 and voted upon by the Georgia Forestry Commission's leadership; and
- 9 WHEREAS, the Bleckley/Pulaski Forestry Unit's most notable achievements include
- 10 assisting on 2,486 acres of prescribed burning, plowing 173 miles of firebreaks, harrowing
- 328 miles, issuing 1,031 permits from the unit for 16,259 acres, selling and delivering
- 12 342,383 seedlings, delivering 34 educational programs in the community, publishing articles
- 13 in the local paper, judging two FFA Forestry Field Day events, including the State
- 14 Competition, and receiving 217 hours of training in FY12 on safety, equipment operation,
- and environmental issues; and
- 16 WHEREAS, the forestry unit also maintained outstanding wildlife protection of Bleckley and
- 17 Pulaski County's 163,765 forested acres, responding to 132 wildfires that burned a total of
- 18 336 acres with an average fire size of 2.55 acres, which is nearly half of the state average of
- 19 4.98 acres; and
- 20 WHEREAS, due to the outstanding accomplishments of the Bleckley/Pulaski Forestry Unit
- 21 in the year 2012, the unit was selected as the Georgia Forestry Commission's Southern Unit
- 22 of the Year; and

WHEREAS, the recognized forestry unit consists of dedicated GFC Professionals Ranger 1

- 24 Kerry Smith, Ranger 1 Joey Gross, and Ranger 1 Sean Sills, now Central Response Center
- 25 manager, serving under the leadership of Chief Ranger David Brown; and
- 26 WHEREAS, the accomplishments of the Bleckley/Pulaski Forestry Unit are a clear
- 27 indication of the dedication and team work present at the unit, the ability of the unit to
- 28 establish and maintain mutually beneficial relationships with local partners, and the
- 29 consistently high level of forestry service provided by the unit over the course of many years.
- 30 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 31 the members of this body commend the Bleckley/Pulaski Forestry Unit for being named the
- 32 Georgia Forestry Commission 2012 Southern Unit of the Year and invite the dedicated
- 33 professionals of the Bleckley/Pulaski Forestry Unit to appear before the House of
- 34 Representatives on a date and time designated by the Speaker of the House of
- 35 Representatives.
