**AS PASSED SENATE**

**A BILL TO BE ENTITLED**

**AN ACT**

1 To amend an Act to reconstitute the Board of Education of Hancock County, approved  
 2 April 5, 1993 (Ga. L. 1993, p. 4524), as amended, so as to change the description of the  
 3 education districts; to provide for definitions and inclusions; to provide for the continuation  
 4 in office of current members; to provide for the submission of this Act for preclearance  
 5 pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended; to repeal  
 6 conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act to reconstitute the Board of Education of Hancock County, approved April 5, 1993  
 10 (Ga. L. 1993, p. 4524), as amended, is amended by revising Section 2 as follows:

11 "SECTION 2.

12 (a) For the purpose of electing members of the board of education other than the  
 13 chairperson, the Hancock County School District shall be divided into four education  
 14 districts. Education Districts 1, 2, 3, and 4 shall be and correspond to those four numbered  
 15 districts described in and attached to and made a part of this Act and further identified as  
 16 'Plan: hancockccsb-2013 Plan Type: Local Administrator: Hancock User: bak'. The  
 17 chairperson shall be elected by the electors of the entire school district.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
 20 provided in the report of the Bureau of the Census for the United States decennial  
 21 census of 2010 for the State of Georgia. The separate numeric designations in a district  
 22 description which are underneath a VTD heading shall mean and describe individual  
 23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
 24 United States decennial census of 2010 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the  
 26 description of any district refers to a named city, it shall mean the geographical  
 27 boundaries of that city as shown on the census maps for the United States decennial  
 28 census of 2010 for the State of Georgia.

29 (2) Any part of the Hancock County School District which is not included in any district  
 30 described in subsection (a) of this section shall be included within that district contiguous  
 31 to such part which contains the least population according to the United States decennial  
 32 census of 2010 for the State of Georgia.

33 (3) Any part of the Hancock County School District which is described in subsection (a)  
 34 of this section as being included in a particular district shall nevertheless not be included  
 35 within such district if such part is not contiguous to such district. Such noncontiguous  
 36 part shall instead be included within that district contiguous to such part which contains  
 37 the least population according to the United States decennial census of 2010 for the State  
 38 of Georgia."

39 **SECTION 2.**

40 (a) Those members of the Board of Education of Hancock County who are serving as such  
 41 on the effective date of this Act and any person selected to fill a vacancy in any such office  
 42 shall continue to serve as such members until the regular expiration of their respective terms  
 43 of office and upon the election and qualification of their respective successors.

44 (b) Education Districts 1, 2, 3, and 4, as they existed immediately prior to the effective date  
 45 of this Act, shall continue to be designated as Education Districts 1, 2, 3, and 4, respectively,  
 46 but as newly described under this Act, and on and after the effective date of this Act, such  
 47 members of the board serving from those former education districts shall be deemed to be  
 48 serving from and representing their respective districts as newly described under this Act.

49 **SECTION 3.**

50 The Board of Education of Hancock County shall through its legal counsel cause this Act to  
 51 be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as  
 52 amended, not later than 45 days after the date on which this Act is approved by the Governor  
 53 or otherwise becomes law without such approval.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
