

Senate Bill 226

A BILL TO BE ENTITLED
AN ACT

1 To amend Chapter 16 of Title 45 of the Official Code of Georgia Annotated, relating to
2 coroners, so as to change certain provisions relating to investigation fees; to provide for
3 changes to compensation options of coroners; to provide for related matters; to repeal
4 conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6 SECTION 1.

7 Chapter 16 of Title 45 of the Official Code of Georgia Annotated, relating to coroners, is
8 amended by revising subsection (c) of Code Section 45-16-11, relating to additional
9 compensation, as follows:

10 (c) The minimum salaries provided for under this Code section shall be in addition to any
11 fees, including the death investigation fee provided for under subsection (b) of Code
12 Section 45-16-27, paid by the county governing authority to the coroner on a per-call basis
13 and in addition to any expenses.

14 SECTION 2.

15 Said chapter is further amended by revising subsections (b) and (b.1) of Code Section
16 45-16-27, relating to when inquests are required, investigation fees and costs, and
17 photographs and video recordings not subject to disclosure, as follows:

18 "(b) On and after January 1, 2007, coroners shall be entitled to an investigation fee of
19 \$175.00 where no jury is impaneled or a fee of \$250.00 where a jury is impaneled and shall
20 be paid upon receipt of a monthly statement to the county treasury. A deputy coroner shall
21 receive the same fee as the coroner for the performance of services in place of the coroner
22 and shall be paid upon receipt of a monthly statement to the county treasury. Such fee shall
23 be paid within ten days after receipt of the coroner's monthly statement by the county
24 where the investigation or inquest is held except in counties where the coroner receives an

25 annual salary established through local legislation, in which case no fee shall be imposed
 26 upon the county by such salaried coroner or deputy coroner.

27 (b.1) ~~Any A local Acts Act~~ providing for the compensation of ~~the various coroners a~~
 28 coroner shall remain in full force and effect, except as otherwise provided in this
 29 subsection. In in those instances where such local Acts provide Act provides for a salary
 30 in an amount ~~which is~~ less than the amount of compensation such coroner would be entitled
 31 to pursuant to subsection (b) of this Code section, ~~in which case the coroner may select on~~
 32 ~~an annual basis beginning January 1, 2007, elect~~ to be compensated pursuant to subsection
 33 (b) of this Code section in lieu of the compensation or by the salary provided for by local
 34 Act. The coroner shall provide written notice to the county governing authority of such
 35 election no later than October 1 of any year to be effective January 1 of the next calendar
 36 year."

SECTION 3.

38 All laws and parts of laws in conflict with this Act are repealed.
