Senate Resolution 413

A RESOLUTION

- 1 Urging adult citizens of Georgia to strongly consider preparing an advance directive for
- 2 health care that appoints their health care agent and states their treatment preferences; and
- 3 for other purposes.
- 4 WHEREAS, a Georgia advance directive for health care is a voluntarily executed, written
- 5 document that allows an adult to designate a health care agent to make health care decisions
- 6 when the adult cannot or does not want to make health care decisions for himself or herself
- 7 and allows the adult to state his or her treatment preferences if he or she has a terminal
- 8 condition or is in a state of permanent unconsciousness and cannot communicate; and
- 9 WHEREAS, health care agents must be willing and able to serve, willing to follow the
- 10 treatment preferences discussed with the person or documented in the person's advance
- directive for health care, and able to weigh the benefits and burdens of treatments should the
- 12 person be unsure about his or her treatment preferences; and
- 13 WHEREAS, adults should also communicate their treatment preferences to their primary
- 14 care provider and give their physician a copy of their completed advance directive for health
- 15 care; and
- 16 WHEREAS, an advance directive for health care can help ease the burden of those who have
- 17 to make treatment decisions on behalf of others; and
- 18 WHEREAS, adults who have an advance directive for health care have the freedom to
- 19 change their appointed health care agent or their treatment preferences, or both, at any time;
- 20 and
- 21 WHEREAS, the State of Georgia joins other national, state, and community organizations
- 22 in recognizing April 16, 2013, as the annual Health Care Decisions Day, which has been

23 established to encourage advance care planning for all adults with decision-making capacity;

- 24 and
- 25 WHEREAS, health care providers should encourage their patients to complete an advance
- 26 directive for health care and provide support to those who request assistance.
- 27 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 28 GEORGIA that the members of this body encourage Georgians who have serious medical
- 29 conditions to talk with their doctors about available treatment options, specifically
- 30 life-sustaining treatments, and the benefits and burdens of such treatments.
- 31 BE IT FURTHER RESOLVED that the members of this body urge all adult Georgians to
- 32 consider what treatments they would want if they were rendered unable to make or
- 33 communicate their own health care decisions; to complete and maintain an advance directive
- 34 for health care and keep multiple copies in a safe, accessible place; to provide a copy of their
- 35 advance directive for health care for their physician and hospital to include in their medical
- 36 record; and to appoint a health care agent who they trust to carry out their wishes and help
- 37 make the decisions necessary to preserve their well-being.
