A RESOLUTION

- 1 Commending the March of Dimes and recognizing March 13, 2013, as March of Dimes Day
- 2 at the state capitol; and for other purposes.
- 3 WHEREAS, the March of Dimes Foundation is a pioneer in improving the health of infants
- 4 and women of childbearing age by preventing birth defects, premature birth, and infant
- 5 mortality; and
- 6 WHEREAS, the March of Dimes was founded in 1938 to fight polio, and funded the
- 7 development of two vaccines that virtually eliminated the crippling disease, and in 1958,
- 8 having achieved its initial mission, shifted its attention from polio to the prevention of
- 9 preterm birth, the greatest contributing factor to newborns dying within their first month of
- 10 life; and
- 11 WHEREAS, nearly half a million babies are born preterm every year in the United States,
- and over 19,400 preterm births occurred in Georgia in 2009, a figure which represents one
- in every eight babies born in this state and a nearly 2 percent increase in preterm births since
- 14 1999; and
- 15 WHEREAS, these dire statistics were a major reason for Georgia's receiving a grade of "D"
- in a 2012 report by the March of Dimes on premature birth rates among the states in the
- 17 nation; and
- 18 WHEREAS, the March of Dimes supported the Association of State and Territorial Health
- 19 Officials (ASTHO) Challenge calling for an 8 percent reduction in preterm births in Georgia
- 20 by 2014, and healthier starts in the lives of thousands of infants; and
- 21 WHEREAS, as of 2012, the March of Dimes has helped Georgia achieve this goal resulting
- in a 10 percent reduction among all births, and with the continued support from the March

23 of Dimes, Georgia will continue along this current trajectory, achieving a 15 percent decrease

- 24 in preterm birth by 2014; and
- 25 WHEREAS, volunteers and staff of the March of Dimes will be at the capitol on March 13,
- 26 2013, to raise awareness among legislators about the serious consequences of preterm birth
- and to advocate for policies to address this significant public health challenge.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 the members of this body commend the efforts of the March of Dimes and its selfless
- 30 volunteers for their past, present, and future work on behalf of mothers and babies in this
- 31 state, throughout the nation, and around the world, and recognize March 13, 2013, as March
- 32 of Dimes Day at the state capitol.
- 33 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 34 and directed to transmit an appropriate copy of this resolution to the March of Dimes Georgia
