A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating a new charter for the City of Glennville, approved August 21,
- 2 1911 (Ga. L. 1911, p. 1228), as amended, particularly by an Act approved March 28, 1985
- 3 (Ga. L. 1985, p. 4756), so as to change the description of the wards; to provide for definitions
- 4 and inclusions; to provide for manner of election; to provide for the continuation in office
- 5 of current members; to provide for the submission of this Act for preclearance under
- 6 Section 5 of the federal Voting Rights Act of 1965, as amended; to provide for related
- 7 matters; to repeal conflicting laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

- 10 An Act creating a new charter for the City of Glennville, approved August 21, 1911
- 11 (Ga. L. 1911, p. 1228), as amended, particularly by an Act approved March 28, 1985
- 12 (Ga. L. 1985, p. 4756), is amended by revising subsection (a) of Section 34 as follows:
- 13 "(a)(1) For the purpose of electing members of the council, the City of Glennville shall
- be divided into four wards which shall be and correspond to those four numbered districts
- described in and attached to and made a part of this Act and further identified as
- 16 'Plan: glennville-import-2013 Plan Type: local Administrator: glennville User: bak'.
- 17 (2) For the purposes of such plan:
- 18 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
- provided in the report of the Bureau of the Census for the United States decennial
- 20 census of 2010 for the State of Georgia. The separate numeric designations in a district
- description which are underneath a VTD heading shall mean and describe individual
- Blocks within a VTD as provided in the report of the Bureau of the Census for the
- United States decennial census of 2010 for the State of Georgia; and
- 24 (B) Except as otherwise provided in the description of any district, whenever the
- description of any district refers to a named city, it shall mean the geographical

boundaries of that city as shown on the census maps for the United States decennial census of 2010 for the State of Georgia.

- (3) Any part of the City of Glennville which is not included in any district described in paragraph (1) of this subsection shall be included within that district contiguous to such part which contains the least population according to the United States decennial census
- of 2010 for the State of Georgia.

32 (4) Any part of the City of Glennville which is described in paragraph (1) of this 33 subsection as being included in a particular district shall nevertheless not be included 34 within such district if such part is not contiguous to such district. Such noncontiguous 35 part shall instead be included within that district contiguous to such part which contains 36 the least population according to the United States decennial census of 2010 for the State

of Georgia."

38 SECTION 2.

- 39 (a) Those members of the City Council of the City of Glennville who are serving as such on
- 40 the effective date of this Act and any person selected to fill a vacancy in any such office shall
- 41 continue to serve as such members until the regular expiration of their respective terms of
- 42 office and upon the election and qualification of their respective successors.
- 43 (b) Wards 1, 2, 3, and 4, as they existed immediately prior to the effective date of this Act,
- shall continue to be designated as Wards 1, 2, 3, and 4, respectively, but as newly described
- 45 under this Act, and on and after the effective date of this Act, such members of the council
- serving from those former wards shall be deemed to be serving from and representing their
- 47 respective wards as newly described under this Act.

48 SECTION 3.

- 49 The governing authority of the City of Glennville shall through its legal counsel cause this
- 50 Act to be submitted for preclearance under the federal Voting Rights Act of 1965, as
- amended, no later than 45 days after the date on which this Act is approved by the Governor
- or otherwise becomes law without such approval.

54 All laws and parts of laws in conflict with this Act are repealed.
