The House Committee on Intragovernmental Coordination - Local Legislation offers the following substitute to HB 614:

A BILL TO BE ENTITLED AN ACT

1 To amend an Act entitled the "Unincorporated DeKalb County Community Improvement 2 District Act of 1998," approved April 2, 1998 (Ga. L. 2009, p. 3549), so as to provide a 3 definition for the governing authority of the City of Brookhaven; to provide for the 4 composition of the district board upon the incorporation of some portion of the district; to 5 provide for future expansion of the district; to provide for debt of the district; to provide for 6 cooperation of the district with the City of Brookhaven; to provide for powers of the district 7 board; to provide for the adoption of a dissolution resolution; to repeal conflicting laws; and 8 9 for other purposes.

11 **SECTION 1.** 12 An Act entitled the "Unincorporated DeKalb County Community Improvement District Act of 1998," approved April 2, 1998 (Ga. L. 1998, p. 4228), as amended, particularly by an Act 13 14 approved May 6, 2009 (Ga. Dissolution.

87 (a) The district activated under the provisions of this Act may be dissolved. The88 conditions for such dissolution shall be:

(1) The adoption of a resolution approving of the dissolution of the community
improvement district by the governing authority of DeKalb County, the governing
authority of the City of Brookhaven, and the governing authority of the City of
Dunwoody; and

93 (2) The written consent to the dissolution of the community improvement district by:

94 (A) Two-thirds (67 percent) of the owners of real property within the district which are
95 subject to taxes, fees, and assessments levied by the board of the district; and

96 (B) The owners of real property constituting at least 75 percent by value of all real
97 property within the district which are to be subject to taxes, fees, and assessments
98 levied by the board, and, for this purpose, value shall be determined by the most recent
99 approved county ad valorem tax digest.

- The written consent provided for in subparagraphs (A) and (B) of this paragraph shall be
 submitted to the DeKalb County Tax Commissioner, who shall certify whether such
 written consent has been satisfied with respect to the proposed district dissolution.
- 103 (b) At the official caucus of electors at which board members are to be elected in the sixth 104 year following creation of the district and every sixth year thereafter, the question shall be 105 put to the electors present to dissolve the community improvement district. Upon an 106 affirmative vote of a majority of the electors present and voting, who shall represent at least 75 percent of the votes cast on the basis of value of all real property within the district, the 107 108 board shall send a ballot to each owner of real property within the district subject to taxes, 109 fees, and assessments levied by the board for a vote on the dissolution. Upon receipt of 110 ballots consenting to the dissolution from a majority of those real property owners, who shall represent at least 75 percent of the assessed value of said properties, the board shall 111 request dissolution by the governing authority of DeKalb County, the governing authority 112 of the City of Brookhaven, and the governing authority of the City of Dunwoody and shall 113 forward said ballots to the DeKalb County Tax Commissioner for certification. 114

(c) In the event that successful action is taken pursuant to this section to dissolve the district, the dissolution shall become effective at such time as all debt obligations of the district have been satisfied. Following a successful dissolution action and until the dissolution becomes effective, no new projects may be undertaken, obligations or debts incurred, or property acquired. 13

120 (d) Upon a successful dissolution action, all noncash assets of the district other than public facilities or land or easements to be used for such public facilities, as described in Section 2 121 122 of this Act, shall be reduced to cash and, along with all other cash on hand, shall be applied to the repayment of any or all debt obligations of the district. Any cash remaining after all 123 outstanding obligations are satisfied shall be refunded to each property owner in direct 124 125 proportion to the total amount in taxes, fees, or assessments paid for the property relative 126 to the total revenues paid by all properties in the district. (e) When a dissolution becomes effective, the governing authority of DeKalb County shall 127 128 take title to all property previously in the ownership of the district and located in the

129 unincorporated portion of the district, the governing authority of the City of Brookhaven

shall take title to all property previously in the ownership of the district and located in theincorporated portion of the district located in the City of Brookhaven, and the governing

132 authority of the City of Dunwoody shall take title to all property previously in the

133 ownership of the district and located in the incorporated portion of the district located in

the City of Dunwoody. All taxes, fees, and assessments of the district shall cease to be

135 levied and collected.

136 (f) The district may be reactivated in the same manner as an original activation."

138 All laws and parts of laws in conflict with this Act are repealed.
