**AS PASSED**

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act incorporating the City of Port Wentworth, approved February 6, 1957  
2 (Ga. L. 1957, p. 2003), as amended, particularly by an Act approved May 12, 2008  
3 (Ga. L. 2008, p. 3734), and an Act approved May 6, 2009 (Ga. L. 2009, p. 3564), so as to  
4 change the description of the council districts; to provide for definitions and inclusions; to  
5 provide for manner of election; to provide for the continuation in office of current members;  
6 to provide for the submission of this Act for preclearance under Section 5 of the federal  
7 Voting Rights Act of 1965, as amended; to provide for related matters; to repeal conflicting  
8 laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 style="text-align:center">**SECTION 1.**

11 An Act incorporating the City of Port Wentworth, approved February 6, 1957 (Ga. L. 1957,  
12 p. 2003), as amended, particularly by an Act approved May 12, 2008 (Ga. L. 2008, p. 3734),  
13 and an Act approved May 6, 2009 (Ga. L. 2009, p. 3564), is amended by revising  
14 subsections (b), (c), and (e) of Section 4A as follows:

15 "(b) For purposes of electing members of the city council, other than the mayor and the  
16 two at-large councilmembers, the City of Port Wentworth is divided into four council  
17 districts. One member of the council shall be elected from each such district. The four  
18 council districts shall be and correspond to those four numbered districts described in and  
19 attached to and made a part of this Act and further identified as 'Plan: portwentworth-2013  
20 Plan Type: Local Administrator: Port Wentworth User: bak'.

21 (c)(1) For the purposes of such plan:

22 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
23 provided in the report of the Bureau of the Census for the United States decennial  
24 census of 2010 for the State of Georgia. The separate numeric designations in a district  
25 description which are underneath a VTD heading shall mean and describe individual

26 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
 27 United States decennial census of 2010 for the State of Georgia; and

28 (B) Except as otherwise provided in the description of any district, whenever the  
 29 description of any district refers to a named city, it shall mean the geographical  
 30 boundaries of that city as shown on the census maps for the United States decennial  
 31 census of 2010 for the State of Georgia.

32 (2) Any part of the City of Port Wentworth which is not included in any district  
 33 described in subsection (b) of this section shall be included within that district contiguous  
 34 to such part which contains the least population according to the United States decennial  
 35 census of 2010 for the State of Georgia.

36 (3) Any part of the City of Port Wentworth which is described in subsection (b) of this  
 37 section as being included in a particular district shall nevertheless not be included within  
 38 such district if such part is not contiguous to such district. Such noncontiguous part shall  
 39 instead be included within that district contiguous to such part which contains the least  
 40 population according to the United States decennial census of 2010 for the State of  
 41 Georgia."

42 "(e) In order to be elected or appointed as a member of the city council from a district, a  
 43 person must have resided in that council district for at least six months prior to the election  
 44 or appointment thereto and, if elected, must receive a plurality of votes cast for that office  
 45 in that district only and not at large. Only electors who are residents of the council district  
 46 may vote for a member of the council for the district. At the time of qualifying for election  
 47 as a member of the city council for a council district, each candidate for such office shall  
 48 specify the council district for which that person is a candidate. A person elected or  
 49 appointed as member of the city council from a council district must continue to reside in  
 50 that district during that person's term of office or that office shall become vacant; provided,  
 51 however, that, if, as the result of the enactment of a new district plan during such member's  
 52 term of office to reapportion or redistrict the council districts following a United States  
 53 decennial census, the residence of a member of the city council is no longer within the  
 54 boundaries of the district which such member was elected to represent, such member may  
 55 continue to represent such district for the remainder of such member's term of office."

56 **SECTION 2.**

57 (a) Those members of the city council of the City of Port Wentworth who are serving as  
 58 such on the effective date of this Act and any person selected to fill a vacancy in any such  
 59 office shall continue to serve as such members until the regular expiration of their respective  
 60 terms of office and upon the election and qualification of their respective successors.

61 (b) Council Districts 1, 2, 3, and 4, as they existed immediately prior to the effective date  
62 of this Act, shall continue to be designated as Council Districts 1, 2, 3, and 4, respectively,  
63 but as newly described under this Act, and on and after the effective date of this Act, such  
64 members of the council serving from those former council districts shall be deemed to be  
65 serving from and representing their respective council districts as newly described under this  
66 Act.

67 **SECTION 3.**

68 The governing authority of the City of Port Wentworth shall through its legal counsel cause  
69 this Act to be submitted for preclearance under the federal Voting Rights Act of 1965, as  
70 amended, no later than 45 days after the date on which this Act is approved by the Governor  
71 or otherwise becomes law without such approval.

72 **SECTION 4.**

73 All laws and parts of laws in conflict with this Act are repealed.
