1 Honoring the life and memory of the late Representative William "Quincy" Murphy,

2 expressing regret at his passing, and inviting his family to appear before the House of

3 Representatives; and for other purposes.

WHEREAS, news of the passing of Representative William "Quincy" Murphy is received
with deep regret by this body; and

6 WHEREAS, the life led by this distinguished gentleman rendered him dear to the hearts of

7 his family, friends, colleagues, and fellow citizens alike; and

8 WHEREAS, Representative Murphy was born in Atlanta, Georgia, and reared in Edgefield 9 County, South Carolina. He was a graduate of North Carolina A & T State University, where 10 he earned a Bachelor of Science Degree in Economics. He was President and Chief 11 Executive Officer of Quincy Murphy & Associates, an affiliate of the Allstate Insurance 12 Company, and had been in the insurance and financial services business in Augusta since 13 1979; and

14 WHEREAS, Representative Murphy had a history of community and civic service. He was a Chairman of the Augusta/Richmond County Communities in Schools. He was a member 15 16 of the Augusta and National Associations of Life Underwriters, the Georgia Association of Black Elected Officials, the National Conference of State Legislatures, Alpha Mu 17 Boulé-Sigma Pi Phi Fraternity, Omega Psi Phi Fraternity, Inc., State Treasurer of the Georgia 18 Legislative Black Caucus, the Rotary Club of Augusta, the Augusta Chapter of the American 19 20 Red Cross, and the former Chairman of the Augusta/Richmond County Legislative 21 Delegation; and

WHEREAS, he was an Executive Secretary and Training Officer of the Augusta Association
of Basketball Officials and a member of Southern Intercollegiate Athletic Conference
Basketball and Football Officials Association and the Optimist Club of Richmond County.

28 WHEREAS, his awards included three years recognition as an Allstate Financial Leader and 29 Quality Agent and 19 years as a recipient of the Honors Ring. He was named 2005 Man of 30 the Year by Mt. Canaan Baptist Church in Edgefield County, South Carolina, where he was reared, 2005 Man of the Year by Kappa Alpha Psi Fraternity, Augusta Alumni Chapter, 31 32 Presidential Award for Outstanding Service to Community and State by 100 Black Men of 33 Augusta Inc., Community Citizen's Award for Outstanding Service to the CSRA by National Association of University Women, 4th Annual Brother Commissioner Lee Norris Beard 34 35 Humanitarian Award by Alpha Phi Alpha, Alpha Chi Lambda Chapter, 2008 Psi Omega 36 Chapter of Omega Psi Phi Fraternity, Inc. Citizen of the Year Award, and the 2009 CSRA Business League Henry L. Howard Government Service Award; and 37

38 WHEREAS, on his first offer for public office in 2002, Representative Murphy was elected

39 to the Georgia General Assembly as the State Representative from House District 97. In

40 2004 he was unopposed for re-election to the reapportioned new House District 120. In the

41 House of Representatives, he served on the Higher Education, Insurance, Transportation, and

42 Appropriations Committees. Representative Murphy also chaired the Georgia House

43 Democratic Caucus Higher Education Policy Committee; and

44 WHEREAS, Representative Murphy was a member of Augusta's historic Tabernacle Baptist

45 Church where he was a Deacon, Trustee Ministry Chairman, and Church Treasurer. He was

46 married to the former Linda Dianne Dunton, with whom he had two children, Jennifer Alisha

47 and William Quincy, III; and

WHEREAS, while in life he commanded the esteem of his fellow Georgians, in his death wemingle our sympathies with the grief of his family, friends, and fellow citizens.
