A RESOLUTION

1 Recognizing and commending Ms. Rochelle Callender on her accomplishments within the
2 DeKalb County community; and for other purposes.

3 WHEREAS, Ms. Rochelle Callender was born in St. Paul, Minnesota, and was placed in the
4 foster care system at the age of two; she experienced four foster homes until the age of 18;
5 and

6 WHEREAS, she and her family moved to the Decatur area 24 years ago in response to a
7 career advancement opportunity with the IBM Corporation; and

8 WHEREAS, dedicated to the quality of life of DeKalb County residents, Ms. Callender
9 initiated and spearheaded a broad team of subdivision leaders and community residents to
10 collaborate with the county commissioners and a former CEO, resulting in \$1 million for the
11 funding of a new park on Flat Shoals Parkway; the funding also included enhancements to
12 the Dottie Bridges Tennis Center; and

13 WHEREAS, she launched a "Friends of the Park" group in 2012, a volunteer group of
14 residents committed to safety, beautification, and events; and

15 WHEREAS, Ms. Callender was appointed to the Recreation, Parks, and Cultural Affairs
16 Citizen Advisory Board where she had actively served for three years; and

17 WHEREAS, she is currently responsible for the transformation of global pipeline and
18 reporting at IBM Corporation, and she recently celebrated her thirty-eighth year with the
19 company in September; and

20 WHEREAS, Ms. Callender has received many awards through her years at IBM, including
21 "Best of IBM" which recognizes employees for their extraordinary accomplishments; and

22 WHEREAS, her other community responsibilities include being president of the Hartwood
23 Estates Homeowner's Association, founding member of the Prayer Shawl Ministry at the
24 Spirit and Truth Sanctuary, and member of the National Coalition of 100 Black Women
25 where she focuses on the "Legacy Program"; and

26 WHEREAS, Ms. Rochelle Callender had the challenge and pleasure to raise six children, two
27 birth children, three stepchildren, and one foster daughter, and is a proud grandmother to two
28 boys.

29 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
30 the members of this body recognize and commend Ms. Rochelle Callender on her
31 commitment to live, work, and serve in DeKalb County and her efforts in raising the quality
32 of life for all community residents.
