A BILL TO BE ENTITLED
AN ACT

1 To amend an Act reincorporating the City of Winder, Georgia, in the County of Barrow,
2 approved March 25, 1974 (Ga. L. 1974, p. 3476), as amended, particularly by an Act
3 approved May 5, 2006 (Ga. L. 2006, p. 4624), so as to change the corporate limits of such
4 city; to provide for related matters; to repeal conflicting laws; and for other purposes.

5 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 An Act reincorporating the City of Winder, Georgia, in the County of Barrow, approved
8 March 25, 1974 (Ga. L. 1974, p. 3476), as amended, particularly by an Act approved
9 May 5, 2006 (Ga. L. 2006, p. 4624), is amended by revising Section 1-2.1 by designating the
10 existing text as subsection (a) and adding a new subsection to read as follows:

11 "(b) In addition to the other territory described in this charter, the corporate limits of the
12 City of Winder shall also include the following parcels of property:
