# A BILL TO BE ENTITLED AN ACT

1	To provide a new charter for the City of Chickamauga in Walker County, Georgia; to provide
2	for incorporation, boundaries, and powers of the city; to provide for a governing authority
3	of such city and the powers, duties, authority, election, terms, method of filling vacancies,
4	compensation, qualifications, prohibitions, and removal from office relative to members of
5	such governing authority; to provide for inquiries and investigations; to provide for
6	organization and procedures; to provide for ordinances and codes; to provide for
7	administrative responsibilities; to provide for boards, commissions, and authorities; to
8	provide for a city manager, a police chief, a city attorney, a city clerk, a city auditor, and
9	other personnel; to provide for rules and regulations; to provide for a municipal court and the
10	judge or judges thereof; to provide for practices and procedures; to provide for taxation and
11	fees; to provide for franchises, service charges, and assessments; to provide for bonded and
12	other indebtedness; to provide for accounting and budgeting; to provide for the acquisition
13	and sale of property; to provide for penalties; to provide for an independent school system;
14	to provide for definitions and construction; to provide for other matters relative to the
15	foregoing; to provide for severability; to repeal a specific Act; to repeal conflicting laws; and
16	for other purposes.

#### 17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

18	ARTICLE I
19	INCORPORATION AND POWERS
20	SECTION 1.10.

The City of Chickamauga in Walker County, Georgia, and the inhabitants thereof, are reincorporated by the enactment of this charter and are hereby constituted and declared a body politic and corporate under the name and style City of Chickamauga, Georgia, and by that name shall have perpetual succession.

27	Corporate boundaries.	

28 (a) The boundaries of the city shall be those existing on the effective date of the adoption 29 of this charter with such alterations as may be made from time to time in the manner 30 provided by law. The boundaries of the city at all times shall be shown on a map, a written 31 description, or any combination thereof, to be retained permanently in the office of the city 32 clerk and to be designated, as the case may be: "Official Map (or Description) of the 33 corporate limits of the City of Chickamauga, Georgia." Photographic, typed, or other copies 34 of such map or description certified by the city clerk shall be admitted as evidence in all 35 courts and shall have the same force and effect as with the original map or description. 36

36 (b) The mayor and council may provide for the redrawing of any such map by ordinance to
37 reflect lawful changes in the corporate boundaries. A redrawn map shall supersede for all
38 purposes the entire map or maps which it is designated to replace.

#### **SECTION 1.12.**

#### Powers and construction.

(a) The city shall have all powers possible for a city to have under the present or future
Constitution and laws of this state as fully and completely as though they were specifically
enumerated in this charter. The city shall have all the powers of self-government not
otherwise prohibited by this charter or by general law.

(b) The powers of the city shall be construed liberally in favor of the city. The specific
mention or failure to mention particular powers shall not be construed as limiting in any way
the powers of the city. These powers shall include, but not be limited to, the following:

48 (1) Animal regulations. To regulate and license or to prohibit the keeping or running
49 at-large of animals and fowl, and to provide for the impoundment of same if in violation
50 of any ordinance or lawful order; to provide for the disposition by sale, gift, or humane
51 destruction of animals and fowl when not redeemed as provided by ordinance; and to
52 provide punishment for violation of ordinances enacted hereunder;

(2) Appropriations and expenditures. To make appropriations for the support of the
government of the city; to authorize the expenditure of money for any purposes
authorized by this charter and for any purpose for which a municipality is authorized by
the laws of the State of Georgia; and to provide for the payment of expenses of the city;
(3) Building regulation. To regulate and to license the erection and construction of
buildings and all other structures; to adopt building, housing, plumbing, electrical, gas,

and heating and air conditioning codes; and to regulate all housing, and building tradesto the extent permitted by general law;

(4) Business regulation and taxation. To levy and to provide for the collection of
regulatory fees and taxes on privileges, occupations, trades, and professions as authorized
by Title 48 of the O.C.G.A., or other such applicable laws as are or may hereafter be
enacted; to permit and regulate the same; to provide for the manner and method of
payment of such regulatory fees and taxes; and to revoke such permits after due process
for failure to pay any city taxes or fees;

(5) Condemnation. To condemn property, inside or outside the corporate limits of the
city, for present or future use and for any corporate purpose deemed necessary by the
mayor and council, utilizing procedures enumerated in Title 22 of the O.C.G.A., or such
other applicable laws as are or may hereafter be enacted;

(6) Contracts. To enter into contracts and agreements with other governmental entities
and with private persons and entities;

(7) Emergencies. To establish procedures for determining and proclaiming that an
emergency situation exists within or without the city, and to make and carry out all
reasonable provisions deemed necessary to deal with or meet such an emergency for the
protection, safety, health, or well-being of the citizens of the city;

- (8) Environmental protection. To protect and preserve the natural resources,
  environment, and vital areas of the city, the region, and the state through the preservation
  and improvement of air quality, the restoration and maintenance of water resources, the
  control of erosion and sedimentation, the management of stormwater and establishment
  of a stormwater utility, the management of solid and hazardous waste, and other
  necessary actions for the protection of the environment;
- (9) Ethics. To adopt ethics ordinances and regulations governing the conduct of
  municipal elected officials, appointed officials, and employees; establishing procedures
  for ethics complaints and setting forth penalties for violations of such rules and
  procedures;

(10) Fire regulations. To fix and establish fire limits and from time to time to extend,
enlarge, or restrict the same; to prescribe fire safety regulations not inconsistent with
general law, relating to both fire prevention and detection and to firefighting; and to
prescribe penalties and punishment for violations thereof;

(11) Garbage fees. To levy, fix, assess, and collect a garbage, refuse, and trash collection
and disposal, and other sanitary service charge, tax, or fee for such services as may be
necessary in the operation of the city from all individuals and entities residing in or doing
business therein benefiting from such services; to enforce the payment of such charges,

- taxes, or fees; and to provide for the manner and method of collecting such servicecharges;
- 97 (12) General health, safety, and welfare. To define, regulate, and prohibit any act,
  98 practice, conduct, or use of property which is detrimental to health, sanitation,
  99 cleanliness, welfare, and safety of the inhabitants of the city, and to provide for the
  100 enforcement of such standards;

(13) Gifts. To accept or refuse gifts, donations, bequests, or grants from any source for
any purpose related to powers and duties of the city and the general welfare of its
citizens, on such terms and conditions as the donor or grantor may impose;

104 (14) Health and sanitation. To prescribe standards of health and sanitation and to105 provide for the enforcement of such standards;

(15) Jail sentences. To provide that persons given jail sentences in the city's municipal
court may work out such sentences in any public works or on the streets, roads, drains,
and other public property in the city; to provide for commitment of such persons to any
jail; to provide for the use of pretrial diversion and any alternative sentencing allowed by
law; or to provide for commitment of such persons to any county work camp or county
jail by agreement with the appropriate county officials;

- (16) Motor vehicles. To regulate the operation of motor vehicles and exercise control
  over all traffic, including parking upon or across the streets, roads, alleys, and walkways
  of the city;
- (17) Municipal agencies and delegation of power. To create, alter, or abolish
  departments, boards, offices, commissions, and agencies of the city, and to confer upon
  such agencies the necessary and appropriate authority for carrying out all the powers
  conferred upon or delegated to the same;
- (18) Municipal debts. To appropriate and borrow money for the payment of debts of the
  city and to issue bonds for the purpose of raising revenue to carry out any project,
  program, or venture authorized by this charter or the laws of the State of Georgia;

(19) Municipal property ownership. To acquire, dispose of, lease, and hold in trust or
otherwise any real, personal, or mixed property, in fee simple or lesser interest, inside or
outside the corporate limits of the city;

- (20) Municipal property protection. To provide for the preservation and protection of
  property and equipment of the city and the administration and use of same by the public;
  and to prescribe penalties and punishment for violations thereof;
- (21) Municipal utilities. To acquire, lease, construct, operate, maintain, sell, and dispose
  of public utilities, including, but not limited to, a system of waterworks, sewers and
  drains, sewage disposal, stormwater management, gas works, electric distribution
  systems, cable television and other telecommunications, transportation facilities, public

- airports, and any other public utility; to fix the taxes, charges, rates, fares, fees,
  assessments, regulations, and penalties; and to provide for the withdrawal of service for
  refusal or failure to pay the same;
- (22) Nuisance. To define a nuisance and provide for its abatement whether on public orprivate property;
- (23) Penalties. To provide penalties for violation of any ordinances adopted pursuant tothe authority of this charter and the laws of the State of Georgia;
- 139 (24) Planning and zoning. To provide comprehensive city planning for development by
- zoning; and to provide subdivision regulation and the like as the mayor and council deem
  necessary and reasonable to insure a safe, healthy, and aesthetically pleasing community;
- (25) Police and fire protection. To exercise the power of arrest through duly appointed
  police officers, and to establish, operate, or contract for a police and a firefighting
  agency;
- (26) Public hazards: removal. To provide for the destruction and removal of any
  building or other structure which is or may become dangerous or detrimental to the
  public;
- (27) Public improvements. To provide for the acquisition, construction, building,
  operation, and maintenance of public ways, parks and playgrounds, recreational facilities,
  cemeteries, public buildings, libraries, public housing, parking facilities, or charitable,
  cultural, educational, recreational, conservation, sport, detentional, penal, and medical
  institutions, agencies, and facilities; and to provide any other public improvements, inside
  or outside the corporate limits of the city, and to regulate the use of public improvements;
  and for such purposes, property may be acquired by condemnation under Title 22 of the
- 155 O.C.G.A., or such other applicable laws as are or may hereafter be enacted;
- (28) Public peace. To provide for the prevention and punishment of loitering, disorderly
  conduct, drunkenness, riots, and public disturbances;
- (29) Public transportation. To organize and operate such public transportation systemsas are deemed beneficial;
- (30) Public utilities and services. To grant franchises or make contracts for, or impose
  taxes on, public utilities and public services, and to prescribe the rates, fares, regulations,
  and standards and conditions of service applicable to the service to be provided by the
  franchise grantee or contractor, insofar as not in conflict with applicable regulations of
  the Public Service Commission;
- (31) Regulation of roadside areas. To prohibit or regulate and control the erection,
   removal, and maintenance of signs, billboards, trees, shrubs, fences, buildings, and any
   and all other structures or obstructions upon or adjacent to the rights of way of streets and

roads or within view thereof, within or abutting the corporate limits of the city; and toprescribe penalties and punishment for violation of such ordinances;

170 (32) Retirement. To provide and maintain a retirement plan for officers and employees171 of the city;

(33) Roadways. To lay out, open, extend, widen, narrow, establish or change the grade
of, abandon or close, construct, pave, curb, gutter, adorn with shade trees, or otherwise
improve, maintain, repair, clean, prevent erosion of, and light the roads, alleys, and
walkways within the corporate limits of the city; to grant franchises and rights of way
throughout the streets and roads and over the bridges and viaducts for the use of public
utilities; and to require real estate owners to repair and maintain in a safe condition the
sidewalks adjoining their lots or lands and to impose penalties for failure to do so;

(34) Sewer fees. To levy a fee, charge, or sewer tax as necessary to assure the acquiring,
constructing, equipping, operating, maintaining, and extending of a sewage disposal plant
and sewerage system, and to levy on those to whom sewers and sewerage systems are
made available a sewer service fee, charge, or sewer tax for the availability or use of the
sewers; to provide for the manner and method of collecting such service charges and for
enforcing payment of the same; and to charge, impose, and collect a sewer connection fee
or fees to those connected with the system;

(35) Solid waste disposal. To provide for the collection and disposal of garbage, rubbish,
and refuse and to regulate the collection and disposal of garbage, rubbish, and refuse by
others; and to provide for the separate collection of glass, tin, aluminum, cardboard,
paper, and other recyclable materials and to provide for the sale of such items;

(36) Special areas of public regulation. To regulate or prohibit junk dealers, the 190 manufacture and sale of alcoholic beverages; to regulate the transportation, storage, and 191 192 use of combustible, explosive, and inflammable materials and other hazardous materials 193 to the extent allowed by federal and state law, the use of lighting and heating equipment, 194 and any other business or situation which may be dangerous to persons or property; to regulate and control the conduct of peddlers and itinerant traders, theatrical performances, 195 exhibitions, and shows of any kind, by taxation or otherwise; to license and tax 196 197 professional fortune telling, palmistry, and massage parlors; and to restrict adult bookstores to certain areas; 198

(37) Special assessments. To levy and provide for the collection of special assessmentsto cover the costs for any public improvements;

201 (38) Taxes: ad valorem. To levy and provide for the assessment, valuation, revaluation,
202 and collection of taxes on all property subject to taxation;

203 (39) Taxes: other. To levy and collect such other taxes as may be allowed now or in the204 future by law;

(40) Taxicabs. To regulate and license vehicles operated for hire in the city; to limit the
number of such vehicles; to require the operators thereof to be licensed; to require public
liability insurance on such vehicles in the amounts to be prescribed by ordinance; and to
regulate the parking of such vehicles;

(41) Urban redevelopment. To organize and operate an urban redevelopment program; 209 210 (42) Other powers. To exercise and enjoy all other powers, functions, rights, privileges, and immunities necessary or desirable to promote or protect the safety, health, peace, 211 212 security, good order, comfort, convenience, or general welfare of the city and its 213 inhabitants; to exercise all implied powers necessary or desirable to carry into execution all powers granted in this charter as fully and completely as if such powers were fully 214 stated herein; and to exercise all powers now or in the future authorized to be exercised 215 216 by other municipal governments under other laws of the State of Georgia; and any listing of particular powers in this charter shall not be held to be exclusive of others or restrictive 217 of general words and phrases granting powers, but shall be held to be in addition to such 218 powers unless expressly prohibited to municipalities under the Constitution or applicable 219 laws of the State of Georgia. 220

## SECTION 1.13.

Exercise of powers.

All powers, functions, rights, privileges, and immunities of the city, its officers, agencies, or employees shall be carried into execution as provided by this charter. If this charter makes no provision, such shall be carried into execution as provided by ordinance or as provided by pertinent laws of the State of Georgia.

227	ARTICLE II
228	GOVERNMENT STRUCTURE; ELECTIONS and REMOVAL
229	SECTION 2.10.
230	Mayor and council; authority; number.

The legislative authority of the government of the city, except as otherwise specifically provided in this charter, shall be vested in a governing body to be composed of a mayor and five councilmembers. The governing body established shall in all respects be a successor to and continuation of the governing authority under prior law.

14 LC 28 7111ER 235 **SECTION 2.11.** 236 Terms and qualifications for office. 237 The mayor and councilmembers shall serve for terms of four years and until their respective successors are elected and qualified. No person shall be eligible to serve as mayor or 238 239 councilmember unless that person shall have been a resident of the area comprising the 240 corporate limits of the city for a continuous period of at least 12 months immediately prior to the date of the election for mayor or councilmember, shall continue to reside therein 241

during that person's period of service, shall be current on all taxes and other sums owed to the city, and shall continue to be registered and qualified to vote in municipal elections of the

244 city. The terms of the councilmembers shall be staggered as provided by prior law.

## SECTION 2.12.

Vacancy; filling of vacancies.

 $247 \quad (a) \ The office of mayor or councilmember shall become vacant upon the incumbent's death,$ 

resignation, forfeiture of office, or removal from office in any manner authorized by thischarter or the general laws of the State of Georgia.

(b) Upon the suspension from the office of mayor in any manner authorized by this charter or the general laws of the State of Georgia, the mayor pro tempore shall assume the office of mayor for the duration of the suspension and the mayor pro tempore with council approval may appoint a temporary council member for the duration of the suspension of the

253 may appoint a temporary councilmember for the duration of the suspension of the mayor.

(c) Upon the suspension from the office of councilmember in any manner authorized by this
charter or the general laws of the State of Georgia, the mayor with council approval may
appoint a successor for the duration of the suspension of the councilmember.

(d) In the event that the office of mayor shall become vacant, the mayor pro tempore shall
assume the office of mayor for the duration of the term and the mayor pro tempore with
council approval shall appoint a successor councilmember for the duration of the
councilmember term of the term vacated by the mayor pro tempore.

(e) In the event that the office of councilmember shall become vacant, the mayor with
council approval shall appoint a successor councilmember for the duration of the term of the
vacating councilmember.

264 265	Compensation and expenses.
205	Compensation and expenses.
266	The mayor and councilmembers shall receive compensation and expenses for their services
267	as provided by ordinance. The mayor and council may provide by ordinance for the
268	provision of insurance, retirement, workers' compensation, and other employee benefits to
269	the mayor and councilmembers and may provide by ordinance for the reimbursement of
270	expenses actually and necessarily incurred by the mayor and councilmembers in carrying out
271	their official duties. The effective date of any such ordinance shall be as provided by the

275	Holding other office; voting when financially interested.
276	(a) Elected and appointed officers of the city are trustees and servants of the residents of the
277	city and shall act in a fiduciary capacity for the benefit of such residents.
278	(b) Except as authorized by law, neither the mayor nor any councilmember shall hold any
279	other city office or city employment during the term for which that person was elected.
280	(c) Neither the mayor nor any councilmember shall vote upon or sign any ordinance,
281	resolution, contract, or other matter in which that person is financially interested.
292	
282	SECTION 2.15.
283	Registrations; conduct of elections.
284	The mayor, with council approval, is authorized to appoint a city registrar to receive voter
285	registration of city electors and an election superintendent to conduct city elections.
286	<b>SECTION 2.16.</b>
287	Elections.
288	(a) All elections shall be held and conducted in accordance with Chapter 2 of Title 21 of the
289	O.C.G.A., the "Georgia Election Code," as now or hereafter amended.
290	(b) Political parties shall not conduct primaries for city offices and all names of candidates
291	for city offices shall be listed without party designations as provided in Code
292	Section 21-2-139 of the O.C.G.A.

293 (c) All elections for mayor and all councilmembers shall be at-large by the voters of the entire city. The candidate for mayor who receives the most votes cast in the applicable 294 295 election shall be elected to a term of office. When the three councilmember positions are 296 open, all who qualify for office will merely qualify for a council position. The three candidates receiving the highest number of votes in the election shall be declared the winners 297 298 of the three open council positions. When the other two councilmember positions are open, 299 all who qualify for office will merely qualify for a council position. The two candidates receiving the highest number of votes in the election shall be declared the winners of the two 300 301 open council positions. In the event that there shall be a tie for the last available position, 302 there shall be a run-off between the two or more candidates receiving the identical number of votes. The special election shall be held and conducted in accordance with Chapter 2 of 303

304 Title 21 of the O.C.G.A., the "Georgia Election Code," as now or hereafter amended.

## **SECTION 2.17.**

306 Prohibitions; disclosure; use of public property.

307 (a) Prohibitions - No elected official, appointed officer, or employee of the city or any308 agency or political entity to which this charter applies shall knowingly:

309 (1) Engage in any business or transaction or have a financial or other personal interest,
310 direct or indirect, which is incompatible with the proper discharge of official duties or
311 which would tend to impair the independence of his or her judgment or action in the
312 performance of official duties;

313 (2) Engage in or accept private employment or render services for private interests when
314 such employment or service is incompatible with the proper discharge of official duties
315 or would tend to impair the independence of his or her judgment or action in the
316 performance of official duties;

317 (3) Disclose confidential information concerning the property, government, or affairs of
318 the governmental body by which engaged without proper legal authorization or use such
319 information to advance the financial or other private interest of himself or herself or
320 others;

(4) Accept any valuable gift, whether in the form of service, loan, object, or promise,
from any person, firm, or corporation which to his or her knowledge is interested, directly
or indirectly, in any manner whatsoever in business dealings with the governmental body
by which he or she is engaged; provided, however, that an elected official who is a
candidate for public office may accept campaign contributions and services in connection
with any such campaign;

327 (5) Represent other private interests in any action or proceeding against the city or any 328 portion of its government; or 329 (6) Vote or otherwise participate in the negotiation or in the making of any contract with 330 any business or entity in which he or she has a financial interest. (b) Disclosure - Any elected official, appointed officer, or employee who has any private 331 332 financial interest, directly or indirectly, in any contract or matter pending before or within 333 any department of the city shall disclose such private interest to the mayor and council. The mayor or any councilmember who has a private interest in any matter pending before the 334 335 mayor and council shall disclose such private interest and such disclosure shall be entered 336 on the records of the city council, and he or she shall disqualify himself or herself from participating in any decision or vote relating thereto. Any elected official, appointed officer, 337 338 or employee of any agency or political entity to which this charter applies who shall have any private financial interest, directly or indirectly, in any contract or matter pending before or 339 within such entity shall disclose such private interest to the governing body of such agency 340 341 or entity. 342 (c) Use of public property - An elected official, appointed officer, or employee of the city or any agency or entity to which this charter applies shall use property owned by such 343 344 governmental entity in a manner that complies with applicable state law and regulations, or 345 the ordinances and policies of the city. (d) Any violation of this section which occurs with the knowledge, express or implied, of 346

a party to a contract or sale shall render said contract or sale voidable at the option of themayor and council.

#### **SECTION 2.18.**

350 Removal of officers.

(a) The mayor, a councilmember, or other appointed officers provided for in this charter maybe removed from office for any one or more of the following causes:

- 353 (1) Incompetence, misfeasance, or malfeasance in office;
- 354 (2) Conviction of a crime involving moral turpitude;
- 355 (3) Failure at any time to possess any qualifications of office as set forth in Section 2.11
- of this charter or in Article II, Section II, Paragraph III of the Georgia Constitution;
- 357 (4) Knowingly violating Section 2.17 of this charter or any other express prohibition of358 this charter;
- 359 (5) Abandonment of office or neglect to perform the duties thereof; or

360 (6) Failure for any other cause to perform the duties of office as required by this charter361 or by state law.

362 (b) Removal of any officer pursuant to subsection (a) of this section shall be accomplished by the vote of four councilmembers after an investigative hearing. In the event an elected 363 364 officer is sought to be removed by the action of the mayor and council, such officer shall be 365 entitled to a written notice specifying the ground or grounds for removal and to a public hearing which shall be held not less than ten days or more than forty days after the service 366 367 of such written notice. Any elected officer sought to be removed from office as provided in 368 this section shall have the right of appeal from the decision of the mayor and council to the Superior Court of Walker County. Such appeal shall be governed by the same rules as 369 370 govern appeals to the superior court from the probate court.

371 ARTICLE III
372 Organization of government; general authority and ordinances.
373 SECTION 3.10.
374 General power and authority of the mayor and council.

(a) Except as otherwise provided by law or this charter, the mayor and council shall be 375 376 vested with all the powers of government of the city as provided by Article I of this charter. 377 (b) In addition to all other powers conferred upon it by law, the mayor and council shall 378 have the authority to adopt and provide for the execution of such ordinances, resolutions, 379 rules, and regulations, not inconsistent with this charter and the Constitution and the laws of 380 the State of Georgia, which it shall deem necessary, expedient, or helpful for the peace, good 381 order, protection of life and property, health, welfare, sanitation, comfort, convenience, 382 prosperity, or well-being of the inhabitants of the city and may enforce such ordinances by imposing penalties for violation thereof. 383

384 (c) Except as otherwise provided in this charter, the mayor and council, by ordinance, may 385 establish, abolish, merge, or consolidate offices, positions of employment, departments, and agencies of the city as they shall deem necessary for the proper administration of the affairs 386 and government of the city. The mayor and council shall prescribe the functions and duties 387 388 of existing departments, offices, and agencies or of any departments, offices, and agencies hereinafter created or established; except as otherwise provided in this charter, may provide 389 that the same person shall fill any number of offices and positions of employment; and may 390 transfer or change the functions and duties of offices, positions of employment, departments, 391 392 and agencies of the city.

393 (d) The mayor and council are hereby empowered to acquire, construct, operate, and
394 maintain public ways, parks, public grounds, cemeteries, mausoleums, markets, market
395 houses, public buildings, libraries, sewers, drains, sewage treatment, electrical distribution
396 systems, waterworks, airports, mass transit systems, hospitals, and charitable, educational,

recreational, sport, curative, corrective, detentional, penal, and medical institutions, agencies,
and facilities, and any other public improvements inside or outside the city and to regulate
the use thereof, and, for such purposes, property may be condemned under procedures
established under general law applicable now or as provided in the future.

401 (e) The mayor and council may make inquiries and investigations into the affairs of the city
402 and the conduct of any department, office, or agency thereof, and for this purpose may
403 subpoena witnesses, administer oaths, take testimony, and require the production of

All judges shall be appointed by the 714 mayor, with council approval, and shall serve until a successor is appointed and qualified. 715 716 (c) Compensation of the judges shall be fixed by ordinance. 717 (d) Judges serve at the pleasure of the mayor and council. (e) Before assuming office, each judge shall take the oath provided in Section 3.11 of this 718 719 charter. The oath shall be entered upon the journal of proceedings of the mayor and council. (f) The mayor and council shall have the authority to create by ordinance the office of 720 prosecuting attorney of the municipal court. 721 722 SECTION 5.12. 723 Convening.

- 726 Jurisdiction; powers.

727 (a) The municipal court shall try and punish violations of this charter, all city ordinances,

and such other violations as provided by law.

(b) The municipal court shall have authority to punish those in its presence for contempt,

provided that such punishment shall not exceed \$200.00 or ten days in jail.

(c) The municipal court may fix punishment for offenses within its jurisdiction not
exceeding a fine of \$1,000.00 or imprisonment for 180 days, or both such fine and
imprisonment, or may fix punishment by fine, imprisonment, or alternative sentencing, as
now or hereafter provided by law.

(d) The mayor and council shall have authority to establish a schedule of fees to defray the
cost of the municipal court operations and shall be entitled to reimbursement of the cost of
meals, transportation, and caretaking of prisoners.

(e) The municipal court shall have authority to establish bail and recognizances to ensure the presence of those charged with violations before said court and shall have discretionary authority to accept cash or personal or real property as surety for the appearance of persons charged with violations. Whenever any person shall give bail for that person's appearance and shall fail to appear at the time fixed for trial, the bond shall be forfeited by the judge presiding at such time and an execution issued thereon by serving the defendant and the 744 defendant's sureties with a rule nisi at least two days before a hearing on the rule nisi. In the event that cash or property is accepted in lieu of bond for security for the appearance of a 745 746 defendant at trial and such defendant fails to appear at the time and place fixed for trial, the cash so deposited shall be on order of the judge declared forfeited to the city or the property 747 so deposited shall have a lien against it for the value forfeited which lien shall be enforceable 748 749 in the same manner and to the same extent as a lien for city property taxes. 750 (f) The municipal court shall have the same authority as superior courts to compel the production of evidence in the possession of any party; to enforce obedience to its orders, 751

752 judgments, and sentences; and to administer such oaths as are necessary.

(g) The municipal court may compel the presence of all parties necessary to a proper disposal 753 754 of each case by the issuance of summonses, subpoenas, and warrants which may be served 755 as executed by any officer as authorized by this charter or by law.

(h) Each judge of the municipal court shall be authorized to issue warrants for the arrest of 756 persons charged with offenses against any ordinance of the city, and each judge of the 757 municipal court shall have the same authority as a magistrate of the state to issue warrants 758 for offenses against state laws committed within the city. 759

## Appeal.

762 Any person aggrieved by a decision of the municipal court of the City of Chickamauga shall 763 have the right to appeal as provided by law.

776	Property Tax.

The mayor and council may assess, levy, and collect an ad valorem tax on all real and personal property within the corporate limits of the city that is subject to such taxation by the state and county. This tax is for the purpose of raising revenues to defray the costs of operating the city government, of providing governmental services, for the repayment of principal and interest on general obligations, and for any other public purpose as determined by the mayor and council in its discretion.

784 Millage rate; due dates; payment methods.

The mayor and council, by ordinance, shall establish a millage rate for the city property tax, a due date, and the time period within which these taxes must be paid. The mayor and council, by ordinance, may provide for the payment of these taxes by installments or in one lump sum, as well as authorize the voluntary payment of taxes prior to the time when due.

The mayor and council by ordinance shall have the power to levy such occupation or business taxes as are allowed by law. The mayor and council may classify businesses, occupations, or professions for the purpose of such taxation in any way which may be lawful and may compel the payment of such taxes as provided in Section 6.18 of this charter.

796Regulatory fees; permits.

The mayor and council by ordinance shall have the power to require businesses or practitioners doing business within the city to obtain a permit for such activity from the city and to pay a reasonable regulatory fee for such permit as provided by general law. Such fees shall reflect the total cost to the city of regulating the activity, and, if unpaid, shall be collected as provided in Section 6.18 of this charter.

979 The board shall appoint the superintendent of the school district who shall serve either at the 980 pleasure of the board or for such term of office as the board may determine by contract with 981 the superintendent so appointed but not to exceed three years. The superintendent of schools 982 shall have all the duties and responsibilities provided to superintendents appointed by county 983 boards of education by the Constitution and the general laws of the State of Georgia and such 984 other duties and responsibilities as specified by the board. The superintendent shall receive 985 such compensation as the board may provide annually or by contract.

987 Ad valorem taxes.

(a) The board shall annually prepare a budget for the operation of the school system and
shall recommend to the mayor and council a school tax in an amount not greater
than 20 mills per dollar or as authorized in Article VIII of the Constitution of Georgia,
upon 40 percent of the assessed value of all property of the city for the support and
maintenance of education. The millage rate limitation shall be a limitation only upon the
power of taxation and shall not limit or otherwise affect any revenue sharing or other funds
received by the school system from sources other than the local ad valorem tax.

(b) The mayor and council shall have the power and authority to levy and collect a tax
annually, for school purposes, of not more than 20 mills per dollar, or as authorized by
Article VIII of the Georgia Constitution, upon 40 percent of the assessed value of all property

998 of the city. The recommendation of the board of education with respect to the amount of 999 such levy as provided in subsection (a) of this section shall be advisory only; and the number 1000 of mills of school tax to be actually levied shall be determined in the sole discretion of the 1001 mayor and council. Such tax shall be upon all and every species of property, both real and 1002 personal, within the corporate limits of the city, including bonds, notes, debts, choses in 1003 action, moneys employed in banking, and otherwise.
