## A BILL TO BE ENTITLED AN ACT

1 To amend Title 15 and Article 1 of Chapter 13 of Title 40 of the Official Code of Georgia 2 Annotated, relating to courts and the uniform traffic citation and complaint form, 3 respectively, so as to provide for the collection of a fee to defray the costs associated with 4 using electronic citations; to provide for definitions; to provide for the Electronic Citation 5 Fund; to provide for procedures; to provide for a cause of action under certain circumstances; to provide for automatic repeal; to provide for related matters; to repeal conflicting laws; and 6 7 for other purposes. 8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA: 9 **SECTION 1.** 10 Title 15 of the Official Code of Georgia Annotated, relating to courts, is amended by revising 11 Code Section 15-6-95, relating to priorities of distribution of fines, forfeitures, surcharges, 12 additional fees, and cost in cases of partial payments into the court, as follows: "15-6-95. 13 14 Notwithstanding any law to the contrary, a clerk of any superior court of this state who 15 receives partial payments, as ordered by the court, of criminal fines, forfeitures, or costs shall distribute said sums in the order of priority set forth below: 16 17 (1) The amount provided for in Chapter 17 of Title 47 for the Peace Officers' Annuity 18 and Benefit Fund; 19 (2) The amount provided for in Chapter 14 of Title 47 for the Superior Court Clerks' 20 Retirement Fund of Georgia; 21 (3) The amount provided for in Chapter 16 of Title 47 for the Sheriffs' Retirement Fund of Georgia; 22 23 (4) The amounts provided under subparagraphs (a)(1)(A) and (a)(2)(A) of Code Section 24 15-21-73; (5) The amounts provided for under subparagraphs (a)(1)(B) and (a)(2)(B) of Code 25 26 Section 15-21-73;

- 27 (6) The amounts provided for in Code Section 15-21-93 for jail construction and staffing; (7) The amount provided for in Code Section 15-21-131 for funding local victim 28 29 assistance programs; 30 (8) The amount provided for in Code Section 36-15-9 for county law libraries; (9) The balance of the base fine owed to the county; 31 32 (10) The amount provided for in cases of driving under the influence for purposes of the 33 Georgia Crime Victims Emergency Fund under Code Section 15-21-112; 34 (11) The application fee provided for in subsection (c) or (e) of Code Section 15-21A-6; 35 (12) The amount provided for in cases of driving under the influence for purposes of the 36 Brain and Spinal Injury Trust Fund under Code Section 15-21-149; (13) The amount provided for in Code Section 15-21-100 for the Drug Abuse Treatment 37 38 and Education Fund; and 39 (14) The amounts provided for in subsection (d) of Code Section 42-8-34; and (15) The amount provided for in Code Section 15-21-200 for the Electronic Citation 40 <u>Fund</u>." 41 42 **SECTION 2.** 43 Said title is further amended by adding a new article to Chapter 21, relating to the payment 44 and disposition of fines and forfeitures, to read as follows: 45 "ARTICLE 11 46 15-21-200. 47 As used in this article, the term: 48 (1) 'Clerk' means the clerk of court or court officer charged with the duty of receiving 49 moneys arising from fines and forfeited bonds for a court. (2) 'Governing authority' means the body that governs the county, consolidated 50 51 government, or municipality, as applicable. 52 <u>15-21-201.</u> In every case in which any court shall impose a fine for any offense prohibited by Title 40, 53 54 wherein the fine includes costs, there shall be imposed an additional fee not to exceed \$5.00 for an electronic citation system, provided that the governing authority for such court 55 has adopted a resolution agreeing to the imposition of such fee. A governing authority's 56 57 resolution shall expire at the end of the fiscal year in which such resolution was adopted.
- 58 The fee imposed pursuant to such resolution and this Code section shall be in addition to

| 73 | (c) The clerk shall remit moneys to the applicable governing authority on a monthly basis       |
| 74 | but not later than the thirtieth day following the last day of the month in which such funds    |

| 76 | (d) The clerk shall prepare a monthly report and accounting of all funds collected pursuant     |
| 77 | to this article and submit a copy of such report to the Georgia Superior Court Clerks'          |
| 78 | Cooperative Authority and to each of the governing authorities that authorized the              |
| 79 | imposition of the electronic citation fee. The Georgia Superior Court Clerks' Cooperative       |
| 80 | Authority shall promulgate reporting forms that shall be used by the clerk.                     |
