

**ADOPTED**

Senators Williams of the 19th, Golden of the 8th, Stone of the 23rd, Hill of the 4th, Chance of the 16th and others offered the following amendment:

1 *Amend the amendment (AM 28 1357) to the House floor amendment (AM 41 0040) to the*  
 2 *Senate Judiciary Non-civil Committee substitute to HB 60 (LC 29 6007S) by inserting after*  
 3 *line 65 the following:*

4 *By replacing lines 100 through 121 with the following:*

5 courthouse, jail, prison, or place of worship, ~~or bar~~ that has been designated by such  
 6 government entity, courthouse, jail, prison, or place of worship, ~~or bar~~ for the parking of  
 7 motor vehicles at a government building or at such courthouse, jail, prison, or place of  
 8 worship, ~~or bar~~.

9 (b) Except as provided in subsection (d) or (e) of this Code section, a ~~A~~ person shall be  
 10 guilty of carrying a weapon or long gun in an unauthorized location and punished as for a  
 11 misdemeanor when he or she carries a weapon or long gun while:

12 (1) In a government building;

13 (2) In a courthouse;

14 (3) In a jail or prison;

15 (4) In a place of worship, unless the governing body or authority of the place of worship  
 16 permits the carrying of weapons or long guns by license holders;

17 (5) In a state mental health facility as defined in Code Section 37-1-1 which admits  
 18 individuals on an involuntary basis for treatment of mental illness, developmental  
 19 disability, or addictive disease; provided, however, that carrying a weapon or long gun  
 20 in such location in a manner in compliance with paragraph (3) of subsection (d) of this  
 21 Code section shall not constitute a violation of this subsection;

22 ~~(6) In a bar, unless the owner of the bar permits the carrying of weapons or long guns by~~  
 23 ~~license holders;~~

24 ~~(7)(6)~~ On the premises of a nuclear power facility, except as provided in Code Section  
 25 16-11-127.2, and the punishment provisions of Code Section 16-11-127.2 shall supersede  
 26 the punishment provisions of this Code section; or

27 ~~(8)(7)~~ Within 150 feet of any polling place, except as provided in subsection (i) of Code

28 *By inserting "(1)" after "(e)" on line 147, by deleting the quotation mark at the end of line*  
 29 *157, and by inserting between lines 157 and 158 the following:*

30 (2) Any license holder who violates subsection (b) of this Code section in a place of  
 31 worship shall not be arrested but shall be fined not more than \$100.00. Any person who

32 is not a license holder who violates subsection (b) of this Code section in a place of  
33 worship shall be punished as for a misdemeanor."
