

## SENATE SUBSTITUTE TO HR 1544:

## A RESOLUTION

**ADOPTED SENATE**

1 Dedicating and renaming certain portions of the state highway system; repealing a portion  
2 of a resolution dedicating portions of the state highway system approved on May 7, 2013  
3 (Ga. L. 2013, p. 951); and for other purposes.

4 **PART I**

5 WHEREAS, the State of Georgia lost one of its finest citizens and leaders with the passing  
6 of Major Henry Talmage Elrod; and

7 WHEREAS, Major Elrod was born on September 27, 1905, in Turner County, Georgia, and  
8 attended the University of Georgia and Yale University; and

9 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United  
10 States Marine Corps, valiantly and courageously defending his fellow Americans during  
11 World War II; and

12 WHEREAS, Major Elrod single handedly attacked a flight of 22 enemy planes over Wake  
13 Island and executed several low altitude bombings and strafing runs on enemy ships; and

14 WHEREAS, he became the first American to sink a Japanese warship, the *Kisaragi*, with  
15 small caliber bombs delivered from a fighter aircraft; and

16 WHEREAS, when all the U.S. aircraft had been destroyed by hostile fire, Major Elrod  
17 organized the remaining troops into a beach defense unit which repulsed repeated Japanese  
18 attacks; and

19 WHEREAS, Major Elrod was mortally wounded on December 23, 1941, while protecting  
20 his men who were carrying ammunition to a gun emplacement; and

21 WHEREAS, Major Elrod exhibited extraordinary devotion to duty, outstanding loyalty, fine  
22 leadership, and meticulous attention to detail in all his duties, and it is abundantly fitting and  
23 proper that a road be dedicated in his honor.

24 **PART II**

25 WHEREAS, our nation's security continues to rely on patriotic men and women who put  
26 their personal lives on hold in order to place themselves in harm's way to protect the  
27 freedoms that all United States citizens cherish; and

28 WHEREAS, United States military veterans have demonstrated a deep personal commitment  
29 to protecting democracy and a willingness to sacrifice their own personal safety and comfort  
30 to ensure the well-being of their fellow man; and

31 WHEREAS, they have served as guardians of this nation's freedom and liberty and have  
32 diligently and conscientiously undergone intensive and rigorous training in order to serve  
33 their country with honor and distinction during times of war and peace; and

34 WHEREAS, it is important that veterans are thanked for their selfless service to this nation  
35 and honored for their unyielding commitment to protecting the people and ideals of the  
36 United States; and

37 WHEREAS, veterans embody the spirit of service, willing to find meaning in something  
38 greater than themselves, and it is abundantly fitting and proper that the outstanding  
39 accomplishments and sacrifices of these remarkable and distinguished Americans be honored  
40 appropriately.

41 **PART III**

42 WHEREAS, our nation's security continues to rely on patriotic men and women who put  
43 their personal lives on hold in order to place themselves in harm's way to protect the  
44 freedoms that all United States citizens cherish; and

45 WHEREAS, Major Herndon Cummings, Colonel John Whitehead, and Colonel Marion  
46 Rodgers were influential Tuskegee Airmen who valiantly and courageously served this  
47 nation during World War II and were born in or spent years during their childhood in  
48 Laurens County, Georgia; and

49 WHEREAS, a native of Laurens County, Major Herndon Cummings enlisted in the United  
50 States Air Corps on June 25, 1942, and was assigned to the 447th Bomber Group with whom  
51 he served for four years;

52 WHEREAS, upon completion of his service with the Air Corps, Major Cummings enlisted  
53 with the United States Air Force Reserve and dedicated 20 years of additional service to the  
54 nation; and

55 WHEREAS, Colonel Marion Rodgers was raised in Dublin, Georgia, and served with an  
56 anti-aircraft artillery unit and as a radio operator prior to attending flight school; and

57 WHEREAS, Colonel Rodgers was assigned to the 99th Fighter Squadron, the "Red Tails,"  
58 and dedicated 22 years to the Air Force before working in the civil service field for 17 years;  
59 and

60 WHEREAS, Colonel Rodgers spent a year working for N.A.S.A. as a program manager on  
61 the mission for Apollo 13 and was prominent in the development of electronics and  
62 communications procedures with N.O.R.A.D.; and

63 WHEREAS, Colonel John Whitehead spent several years during his youth in Laurens  
64 County and flew several missions over Europe during World War II; and

65 WHEREAS, known as "Mr. Death" by his fellow pilots, Colonel Whitehead was the first  
66 African American test pilot for the Air Force and during his 30 year career spent more than  
67 9,500 hours in the air; and

68 WHEREAS, it is abundantly fitting and proper that the extraordinary accomplishments of  
69 these distinguished Georgians be appropriately recognized with the naming of an intersection  
70 in their honor.

71 **PART IV**

72 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law  
73 enforcement officers with the passing of Deputy David W. Gilstrap on October 9, 2008; and

74 WHEREAS, a native of Hapeville, Georgia, Deputy Gilstrap graduated from Rabun Gap  
75 Nachoochee School and served as a guardian of this nation's freedom and liberty with the  
76 United States Armed Forces; and

77 WHEREAS, as a sergeant in the United States Armed Forces, Deputy Gilstrap was  
78 recognized with numerous commendations, including an Army Achievement Medal, Good  
79 Conduct Medal, National Defense Service Medal, NCO Professional Development Ribbon,  
80 Army Service Ribbon, Overseas Service Ribbon, and Expert Marksmanship Badge for M-16;  
81 and

82 WHEREAS, after his 13 year career in the military, Deputy Gilstrap returned home to begin  
83 his career in law enforcement with the Clarke County Sheriff's Office; and

84 WHEREAS, a graduate of the North East Georgia Police Academy, Deputy Gilstrap joined  
85 the Oconee County Sheriff's Office in 2005 where he worked with the traffic enforcement  
86 unit; and

87 WHEREAS, Deputy Gilstrap exhibited extraordinary devotion to duty, outstanding loyalty,  
88 fine leadership, and meticulous attention to detail in all his duties, and it is abundantly fitting  
89 and proper that a road be dedicated in his honor.

90 **PART V**

91 WHEREAS, Mr. William Riley Curry served in the Georgia General Assembly during the  
92 1910s and 1920s and entertained many legislators and governors in his home, and he  
93 organized and was president and majority stockholder of People's Bank of Shellman, now  
94 known as First State Bank of Randolph County, and was a major benefactor of the Georgia  
95 Baptist Children's Home, where he established the Nena Ferguson Curry Children's Fund;  
96 and at the height of the Great Depression, he established the \$100,000.00 Curry Choir of  
97 Christianity at Mercer University, which act of philanthropy allowed Mercer University to  
98 remain open at a time when many private universities were forced to close, and he developed  
99 railroad lines throughout the South with other capitalists, who were also guests at the family  
100 home; and

101 WHEREAS, Mr. Curry built the Curry Home in Shellman, Georgia, in 1906; the home was  
102 designed by the architectural firm of Dennis & Dennis of Macon and was constructed by  
103 W.I. Jay & Co.; and

104 WHEREAS, he remodeled the imposing, two-story, white clapboard home in 1926, and in  
105 1963 James Riley Curry, Sr., inherited the property and commissioned a vast renovation,  
106 which was undertaken by the Hugh Gaston Architecture Co. of Albany; and

107 WHEREAS, the current owner, William Scott Curry II, purchased the home from the heirs  
108 of the J. R. Curry, Sr., Estate in 2012, and in April of 2013 he began an extensive renovation  
109 and remodel of the home; and

110 WHEREAS, the many interesting historic features of the house include fluted ionic columns,  
111 unusually fine, leaded cut-glass windows surrounding the massive front doorway, richly  
112 colored stained-glass windows, intricately designed bronze ceilings, mahogany wainscoting  
113 of the front entrance hall and formal dining room, and the crystal chandelier in the foyer; and

114 WHEREAS, the home in Randolph County stands as a fine monument to Mr. William Riley  
115 Curry, a successful Georgia entrepreneur and great philanthropist.

116 **PART VI**

117 WHEREAS, Mr. Bobby Eugene Parham has long been recognized by the citizens of this  
118 state for the vital role that he has played in leadership and his deep personal commitment to  
119 the welfare of the citizens of Georgia; and

120 WHEREAS, after graduating from the University of Georgia College of Pharmacy, Mr.  
121 Parham's interest in politics was piqued as he worked as a pharmacist for Representative  
122 Culver Kidd at the Culver & Kidd Drugstore; and

123 WHEREAS, Mr. Parham successfully ran for the Baldwin County School Board and served  
124 as a Baldwin County Commissioner before he was elected to the Georgia House of  
125 Representatives; and

126 WHEREAS, he ably and adeptly served his constituents and the State of Georgia as a  
127 Representative from 1974 until his retirement in 2009; and

128 WHEREAS, as a member of the House of Representatives, Mr. Parham served on the House  
129 Committees on Appropriations, Rules, and Health & Ecology and as chairperson of the  
130 House Committee on Transportation; and

131 WHEREAS, upon his retirement from the House in 2009, Mr. Parham was elected to the  
132 State Transportation Board of the Department of Transportation, representing his hometown  
133 of Milledgeville and Baldwin County; and

134 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
135 remarkable and distinguished Georgian be appropriately recognized with the naming of a  
136 bridge in his honor.

137 **PART VII**

138 WHEREAS, our nation's security continues to rely on patriotic men and women who put  
139 their personal lives on hold in order to place themselves in harm's way to protect the  
140 freedoms that all United States citizens cherish; and

141 WHEREAS, United States military veterans have demonstrated a deep personal commitment  
142 to protecting democracy and a willingness to sacrifice their own personal safety and comfort  
143 to ensure the well-being of their fellow man; and

144 WHEREAS, they have served as guardians of this nation's freedom and liberty and have  
145 diligently and conscientiously undergone intensive and rigorous training in order to serve

155 WHEREAS, the McDougald family, William Alexander and Catherine Buie McDougald  
156 with their youngest child Dougald, immigrated to America in 1841 from the Island of Jura,  
157 Great Britain, and settled in North Carolina; and

158 WHEREAS, Dougald and his sons, John Alexander, Duncan, and William, were successful  
159 farmers and turpentine producers and were active in civic projects, especially in Bulloch  
160 County, Georgia; and

161 WHEREAS, John Alexander McDougald was a major donor in the bid to establish the First  
162 District A&M School, which later was named Georgia Southern University, and as a member

163 of the city council and mayor helped the City of Statesboro obtain improved water and  
164 sewerage and a complete sanitary system; and

165 WHEREAS, John Alexander McDougald's mansion on South Main Street is listed on the  
166 National Register of Historic Places, and he generously gave land to an African American  
167 Baptist church on Highway 67 for the benefit of his workers and their families, a church  
168 named St. John the Second; and

169 WHEREAS, a most notable achievement of John Alexander McDougald is that he attracted  
170 to Statesboro and was host to the internationally acclaimed chemist, Dr. Charles Holmes  
171 Herty, who in the year 1900 performed experiments on pine trees located on land now  
172 occupied by Georgia Southern University and whose research led to the production of Naval  
173 Stores shipped from Statesboro around the world; and

174 WHEREAS, in honor of John Alexander McDougald, the General Assembly created the  
175 Herty Advanced Materials Development Center which relocated from Savannah to Georgia  
176 Southern University in 2012; and

177 WHEREAS, other members of the McDougald family who have a rich history in Statesboro  
178 and Georgia include Bernard McDougald, who served 30 years as a member of the  
179 Statesboro City Council; Ruth McDougald, author of a popular local newspaper column;  
180 Walter McDougald, an active spokesperson for the growth of the college and of the  
181 community of Clito; Worth McDougald, a noted professor at the University of Georgia who  
182 shaped the famed Peabody Awards program; Don McDougald, who brought the first FM  
183 radio station to Statesboro, developed WWNS Radio, and established the community's cable  
184 television system; Maggie McDougald, one of the early communications lawyers in Georgia;  
185 Sally Quinn, a noted television commentator and author of several major books, who married  
186 Ben Bradley, former editor of the *Washington Post*; Michael McDougald, who has served  
187 eight years as chairman of Georgia Public Broadcasting; and William McDougald, editor of  
188 *Southern Living Magazine*; and

189 WHEREAS, it is abundantly fitting and proper that a road be dedicated in honor of this  
190 important and notable Georgia family whose talents and influence stretch from the islands  
191 of Scotland to the Pine Forests of Bulloch County, Georgia.

**PART IX**

193 WHEREAS, Mr. Ray C. Anderson graduated from the Georgia Institute of Technology and  
194 spent over 14 years learning the carpet trade with Deering-Milliken and Callaway Mills  
195 before founding Interface, a company that produced the first free-lay carpet tiles in America;  
196 and

197 WHEREAS, since the company's establishment in 1973, Interface has grown to be the  
198 world's largest producer of modular commercial flooring with sales in 110 countries and  
199 manufacturing facilities on four continents; and

200 WHEREAS, under the enlightened and thoughtful vision of Mr. Anderson, Interface adopted  
201 a Mission Zero promise, which aims to eliminate any negative impact it may have on the  
202 environment by the year 2020 and to reduce or eliminate waste and harmful emissions while  
203 increasing the use of renewable materials and sources of energy; and

204 WHEREAS, a pioneer of conscientious business practices, Mr. Anderson and his dedication  
205 to improving the environment have been recognized with numerous awards, including a  
206 Design for Humanity Award from the American Society for Interior Designers, a Lifetime  
207 Achievement Award from GreenLaw, and a River Guardian Award from the Upper  
208 Chattahoochee Riverkeeper organization, just to name a few; and

209 WHEREAS, Mr. Anderson served as a co-chair on President Clinton's Council on  
210 Sustainable Development and the 2008 Presidential Climate Action Plan; and

211 WHEREAS, a sought-after speaker and advisor on all eco-issues, Mr. Anderson was named  
212 one of *TIME* magazine's Heroes of the Environment in 2007, was honored with an inaugural  
213 Millennium Award from Global Green, and earned recognition as Entrepreneur of the Year  
214 in 1996 from Ernst & Young and *Forbes Magazine*; and

215 WHEREAS, his leadership was instrumental to the numerous boards on which he served,  
216 including The Georgia Conservancy, the Ida Cason Callaway Foundation, Rocky Mountain  
217 Institute, the David Suzuki Foundation, Emory University Board of Ethics Advisory Council,  
218 the ASID Foundation, and Worldwatch Institute; and

219 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
220 remarkable and distinguished Georgian be appropriately recognized by naming a road in his  
221 memory.

223 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated public  
224 servants with the passing of Judge Arthur M. Kaplan on January 1, 2010; and

225 WHEREAS, a native of Covington, Georgia, Judge Kaplan was born on January 5, 1925, the  
226 beloved son of Nathan Kaplan and Lena Mischelevich Kaplan; and

227 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United  
228 States Navy, valiantly and courageously protecting America during World War II in five  
229 invasions in the Pacific theater of war; and

230 WHEREAS, a John Marshall School of Law graduate, Judge Kaplan practiced civil and  
231 criminal law for 50 years and was appointed to the Atlanta Municipal Court in 1973 by  
232 Mayor Sam Massell; and

233 WHEREAS, he used the life-saving skills he obtained in the Navy to teach members of the  
234 Georgia Bureau of Investigation, Federal Bureau of Investigation, United States Secret  
235 Service, Atlanta Fire Rescue, and nursing students at Grady Memorial Hospital emergency  
236 medical care techniques at the Atlanta Police Academy; and

237 WHEREAS, Judge Kaplan taught more than 15,000 people in emergency medical care and  
238 rendered emergency first aid to more than 30,000 people; and

239 WHEREAS, it is abundantly fitting and proper that the extraordinary accomplishments of  
240 this distinguished Georgian be appropriately recognized by naming an intersection in his  
241 memory.

**PART XI**

243 WHEREAS, the State of Georgia lost an icon of strength with the passing of twelve-year-old  
244 Kenneth Webster Stewart III after a five-year battle with medulloblastoma; and

245 WHEREAS, his suffering brought together his community with a renewed love and sense  
246 of doing the right thing; and

247 WHEREAS, throughout his journey more than 800 people followed his progress through his  
248 Facebook prayer-group page and more than 1,012 people came to pay their respects to his  
249 family upon his passing; and

250 WHEREAS, Kenneth, who one day hoped of serving in the Army, was given the nickname  
251 "Soldier Boy" by the community that also dedicated Rock Creek Park Field #12 to his  
252 memory by renaming it Kenneth Stewart III Field "Soldier Boy"; and

253 WHEREAS, his true love of baseball was further celebrated when he had the opportunity to  
254 serve as a bat boy during a baseball game held at Turner Field benefiting Children's  
255 Healthcare of Atlanta; and

256 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
257 remarkable and distinguished Georgian be appropriately recognized by dedicating an  
258 intersection in his memory.

259 **PART XII**

260 WHEREAS, Mr. Marcus Byrd was born in Dawson County, Georgia, a beloved son of C.B.  
261 and Annie Byrd; and

262 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United  
263 States Army, attaining the rank of sergeant;

264 WHEREAS, Mr. Byrd was dedicated to enriching and uplifting the lives of young people in  
265 Dawson County, where he started volunteering with the Boy Scouts of America program in  
266 1958; and

267 WHEREAS, he started the first Cub Scout pack in Dawson County and served as pack  
268 master before later serving as a leader for a Boy Scout troop; and

269 WHEREAS, Mr. Byrd dedicated three decades to the Boy Scouts of America organization,  
270 and under his leadership and tutelage numerous young men went on to earn Eagle Scout  
271 rankings and become productive adults; and

272 WHEREAS, his commitment to the organization was recognized with a Silver Beaver  
273 Award; and

274 WHEREAS, a community leader, Mr. Byrd was a member of Bethel Methodist Church, the  
275 Board of Trustees for Lumpkin Campground, and the Etowah Masonic Lodge; and

276 WHEREAS, it is abundantly fitting and proper that the extraordinary accomplishments of  
277 this distinguished Georgian be recognized by dedicating a bridge in his honor.

278 **PART XIII**

279 WHEREAS, Mr. Albert Sidney "Sid" Newton has long been recognized by the citizens of  
280 this state for the vital role that he played in leadership and his deep personal commitment to  
281 the welfare of the citizens of Georgia, and his passing left a void in the hearts of his family,  
282 friends, and neighbors; and

283 WHEREAS, Mr. Newton was born in Jenkins County, the beloved son of the late John Cleve  
284 and Ruby Aycock Newton, and he graduated from the University of Georgia; and

285 WHEREAS, one of Jenkins County's most successful farmers and dairymen, Mr. Newton  
286 was a member of the Jenkins County Farm Bureau and the Georgia Dairy Association; and

287 WHEREAS, he ably and adeptly served three terms in the Georgia House of Representatives  
288 and one term in the Georgia Senate, championing the interests of his constituents; and

289 WHEREAS, prior to joining the Georgia Senate in 1961, Mr. Newton was a member of the  
290 Jenkins County Board of Commissioners for 20 years and served as chairperson for 14 years;  
291 and

292 WHEREAS, his leadership was invaluable as vice president and director of the Bank of  
293 Millen, director of Millen Warehouse Company, president of Millen Industrial Development  
294 Company, president of the Jenkins County Authority, and vice president of John Wilson  
295 Company; and

296 WHEREAS, a man of deep and abiding faith, Mr. Newton was a member of Millen  
297 Methodist Church, where he was active in Bible Class, and was a member of the Millen  
298 Rotary Club; and

299 WHEREAS, it is abundantly fitting and proper that the extraordinary life of this  
300 distinguished Georgian be appropriately recognized by dedicating a road in his memory.

301 **PART XIV**

302 WHEREAS, Eurith Dickinson "Ed" Rivers has long been recognized by the citizens of this  
303 state for the vital role he played in leadership and his deep personal commitment to the  
304 welfare of the citizens of Georgia; and

305 WHEREAS, Governor Rivers served in both chambers of the General Assembly, adeptly  
306 representing the interests of his constituents in Lanier County; and

307 WHEREAS, as a member of the Georgia State Senate, Governor Rivers demonstrated  
308 invaluable leadership and was elected to serve as President Pro Tempore by his colleagues;  
309 and

310 WHEREAS, he was elected Governor by the citizens of Georgia in 1936 and won reelection  
311 in 1939; and

312 WHEREAS, Governor Rivers served the State of Georgia with honor and distinction, and  
313 his vision and unyielding commitment set the standard for public service; and

314 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
315 remarkable and distinguished Georgian be appropriately recognized by naming a road in his  
316 memory.

317 **PART XV**

318 WHEREAS, it is fitting and proper that the late Dr. Martin Luther King, Jr., influential pastor  
319 and leader of the civil rights movement in the 1950s and 1960s, be honored by his home state  
320 for his many contributions to the greater good of this state and the nation.

321 **PART XVI**

322 WHEREAS, the Sledge family has been part of Peach County since the county's formation,  
323 and generations of the Sledge family have been integral leaders in the community; and

324 WHEREAS, Mr. Carlton Harmon "Bud" Sledge was a lifelong resident of Peach County and  
325 patriarch of the Sledge family; and

326 WHEREAS, Mr. Sledge donated land to the county which allowed for the construction of  
327 a bridge and interchange at the intersection of Interstate 75 and Russell Parkway; and

328 WHEREAS, the lives of countless Peach County residents and visitors have been improved  
329 thanks to Mr. Sledge's generous donation; and

330 WHEREAS, it is abundantly fitting and proper that the extraordinary charity of this  
331 distinguished Georgian be recognized by dedicating a bridge in his honor.

332 **PART XVII**

333 WHEREAS, Stanton Springs spans 1,620 acres of gently rolling countryside near Covington,  
334 Social Circle, Monticello, and Madison, Georgia; and

335 WHEREAS, Stanton Springs incorporates specific areas for residential, light  
336 business/industrial/distribution, commercial/retail, and office uses in mid- to low-rise  
337 buildings that blend gracefully with their surrounding environment; and

338 WHEREAS, this development stands as one of Georgia's premier economic development  
339 achievements, and it is abundantly fitting and proper that a road be dedicated in its honor.

340 **PART XVIII**

341 WHEREAS, Mr. Johnny "Eric" Purvis was the last in a long line of Purvis men devoted to  
342 building bridges in Georgia; and

343 WHEREAS, for 59 years, members of the Purvis family built bridges and ensured the safety  
344 of countless Georgians traveling on local and state roads; and

345 WHEREAS, Mr. Purvis was the chief crane operator for Rodgers Bridge Company for 26  
346 years; and

347 WHEREAS, he worked on bridges from Charlton County to Valdosta, including the  
348 Savannah Port, Savannah, Eulonia, Darien, and Dock Junction; and

349 WHEREAS, Mr. Purvis was working on the bridge at Horse Stamp Church Road in Glynn  
350 County when he passed away of a heart attack; and

351 WHEREAS, a dedicated working man and salt of the Earth gentleman, Mr. Purvis left behind  
352 many who cherish his memory and admired his work ethic, including his wife, family, and  
353 numerous friends and co-workers; and

354 WHEREAS, it is abundantly fitting and proper that the extraordinary accomplishments of  
355 this distinguished Georgian be recognized by dedicating a bridge in his honor.

356 **PART XIX**

357 WHEREAS, Mr. Olief Wainwright was a lifelong resident of the Crowell/Fickling Mill  
358 Community in Taylor County; and

359 WHEREAS, Mr. Wainwright served as a guardian of this nation's freedom and liberty with  
360 the United States Armed Forces, valiantly and courageously protecting his fellow citizens  
361 during the Korean Conflict; and

362 WHEREAS, a man of deep and abiding faith, Mr. Wainwright was actively involved in his  
363 church's ministry, served on mission trips to South America and throughout the United
