- 1 Honoring the life and memory of Eston Wycliffe "Wyc" Orr, Sr.; and for other purposes.
- 2 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens
- 3 with the passing of Eston Wycliffe "Wyc" Orr, Sr., on May 28, 2014; and
- 4 WHEREAS, Wyc was born on October 28, 1946, in Tifton, Georgia, and graduated from Tift
- 5 County High School in 1964; and
- 6 WHEREAS, he went on to earn a bachelor's degree with high honors from Auburn
- 7 University, graduating first in his business school class, Phi Kappa Phi, and as a
- 8 distinguished military graduate; and
- 9 WHEREAS, in addition, Wyc earned a juris doctor degree from the University of Tennessee
- 10 College of Law, where he graduated first in his class, Order of the Coif, and was a law
- 11 review editor; and
- 12 WHEREAS, he had a long and distinguished legal career, practicing law for 43 years,
- including service as a captain of the United States Army Judge Advocate General's Corps,
- 14 West Germany, followed by 40 years of private practice; and
- 15 WHEREAS, as a legal advocate, Wyc focused intensely on providing and ensuring
- 16 representation for the poor, injured, those treated unjustly, and individuals less fortunate than
- 17 himself; and
- 18 WHEREAS, his work on behalf of indigent defense manifested itself in his spearheading the
- 19 creation of the Georgia Public Defender Standards Council, for which he served as a charter
- 20 board member from 2003 to 2011; and

21 WHEREAS, in 2008, he was named a fellow of the American Bar Foundation and was

- 22 awarded the Georgia Association of Criminal Defense Lawyers' Indigent Defense Award;
- 23 his work on behalf of indigent defense culminated with his 2014 receipt of the Southern
- 24 Center for Human Right's Lifetime Achievement Award; and
- 25 WHEREAS, among Wyc's numerous legal accomplishments and accolades are his service
- on the State Bar of Georgia Board of Governors, as member of the Georgia House of
- 27 Representatives from 1989 to 1993, and as vice chair of Common Cause Georgia; and
- 28 WHEREAS, his unwavering dedication to his wife, Lyn Harden Orr, their daughter, four
- 29 grandchildren, and his law firm displays his high morals, ideals, and deep concern for his
- 30 fellow man; and
- 31 WHEREAS, a compassionate and generous man, Wyc will long be remembered for his love
- of family and friendship, and this loyal gentleman and friend will be missed by all who had
- 33 the great fortune of knowing him.
