## A RESOLUTION

- 1 Recognizing and commending Ms. Patricia S. King, of the Department of Human Services,
- 2 Division of Aging Services, Forensic Special Investigations Unit, based upon her
- 3 contributions to the law enforcement profession in Georgia; and for other purposes.
- 4 WHEREAS, Ms. King has been employed by the Georgia Department of Human Services
- 5 since December, 2006, and has worked to increase primary and secondary responders'
- 6 awareness of and response to abuse, neglect, and exploitation of at-risk adults in Georgia
- 7 through education, technical assistance, research, and case consultations; and
- 8 WHEREAS, Ms. King met with Georgia Bureau of Investigation Director Vernon Keenan
- 9 on March 26, 2012, in reference to forming the Abuse, Neglect, and Exploitation Work
- 10 Group, and that work group has had regular meetings since its first meeting on April 19,
- 11 2012; and
- 12 WHEREAS, Ms. King was first introduced to cases involving adult abuse while employed
- by the Gwinnett County Solicitor's Office 15 years ago, and has worked on issues related to
- 14 at-risk adult abuse since that time; and
- 15 WHEREAS, Ms. King is a registered nurse and a POST certified law enforcement officer,
- and she has continued her nursing studies in order to be able to perform her job duties better;

- 18 WHEREAS, Ms. King was a major contributor to the development of, and is one of the
- 19 primary instructors of, a 16-hour certification curriculum titled At-Risk Adult Crime Tactics
- 20 (ACT) Specialist, which was first deployed in April, 2011, and has certified over 1,500
- 21 personnel; and
- 22 WHEREAS, Ms. King was one of the members of the white paper committee that spent
- 23 several months putting together a paper titled *At Risk Adult Abuse*, *Neglect and Exploitation*

24 in Georgia: Review and Recommendations, which has been approved by the executive board

- of the Georgia Association of Chiefs of Police and published on its website; and
- 26 WHEREAS, Ms. King worked with legislators and law enforcement officials to make
- 27 suggestions and assist with the passage of House Bill 78, a bill that expanded the protection
- 28 of disabled adults and elder persons; and
- 29 WHEREAS, Ms. King has served the Georgia law enforcement community and the people
- 30 of Georgia in an exemplary manner.
- 31 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 32 commend Ms. Patricia S. King for her contributions to the law enforcement profession in
- 33 Georgia.
- 34 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
