A RESOLUTION

1 Recognizing and commending Judge Cliff L. Jolliff on the grand occasion of his retirement;
2 congratulating him for being appointed a Senior Juvenile Court Judge; and inviting him to
3 be recognized by the House of Representatives; and for other purposes.

4 WHEREAS, Judge Cliff L. Jolliff, who was appointed to the juvenile court of the
5 Northeastern Judicial Circuit in 1990, has long been recognized by the citizens of this state
6 for the vital role that he has played in leadership and his deep personal commitment to the
7 welfare of the citizens of Georgia; and

8 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,
9 talents, and energy toward the betterment of his community and state as evidenced
10 dramatically by his superlative service as a Juvenile Court Judge of the Northeastern Judicial
11 Circuit; and

12 WHEREAS, Judge Jolliff retired from the bench in December, 2014, and was designated a
13 Senior Juvenile Court Judge by Governor Nathan Deal on January 7, 2015; and

14 WHEREAS, he was the recipient of the 2011 Council of Juvenile Court Judges Judge Aaron
15 Cohn Award, which is awarded annually to a juvenile court judge who has made significant
16 contributions to the Council or the field of juvenile justice and child welfare; and

17 WHEREAS, he was appointed to the Council of Juvenile Court Judges Executive Committee
18 in 1995 and served as its president from 1999-2000; and

19 WHEREAS, Judge Jolliff has served with honor and distinction in the Northeastern Judicial
20 Circuit, and his vision and unyielding commitment have set the standard for public service;

22 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
23 remarkable and distinguished Georgian be appropriately recognized.

24 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
25 the members of this body commend Judge Cliff L. Jolliff for his efficient, effective,
26 unselfish, and dedicated public service to the State of Georgia; congratulate him upon the
27 grand occasion of his retirement and appointment as a Senior Juvenile Court Judge; extend
28 to him their most sincere best wishes for continued health and happiness; and invite him to
29 be recognized by the House of Representatives at a date and time to be determined by the
30 Speaker of the House of Representatives.
