A RESOLUTION

1 Recognizing and commending Pastor Eddie L. Ellison; and for other purposes.

2 WHEREAS, Pastor Eddie L. Ellison has demonstrated his commitment to teaching the
3 Gospel, witnessing Christ through word and deed, and addressing the physical,
4 psychological, intellectual, and spiritual needs of others; and

5 WHEREAS, Pastor Ellison accepted the Lord at the age of nine, and during his teenage
6 years, he served in many auxiliaries of his home church, the Pilgrim Rest Baptist Church in
7 Meriwether County; and

8 WHEREAS, he served at Zion Grove Baptist Church in Atlanta, Georgia, for nine years,
9 during which time he was president of #1 Choir, a member of the Deacon Board, and
10 Associate Minister; and

11 WHEREAS, he was called to serve at Promise Land Baptist Church in Atlanta, where he
12 worked with the pastor to increase the membership tremendously and assisted with
13 renovations and rebuilding of the church; and

14 WHEREAS, he became pastor of Norman Grove Baptist Church in 1979, and he continues
15 to faithfully serve that congregation; and

16 WHEREAS, his vision and direction have helped Norman Grove Baptist Church grow in size
17 and influence, uplifting the community like the light of Bethlehem and serving as a spiritual
18 leader and place for fellowship; and

19 WHEREAS, under Pastor Ellison's tenure, the church has seen an increase in active
20 members, the establishment of over 25 ministries, the licensing and ordination of more than
21 23 ministers, renovations and additions to the church, and the acquisition of land, including
22 the House of Hope and several other plots of land around the church; and

23 WHEREAS, whether the task is preparing a sermon, visiting the sick, counseling the
24 troubled, baptizing a new believer, or acting as a theologian, educator, administrator, or
25 humanitarian, Pastor Ellison serves as a shining example of God's righteous path; and

26 WHEREAS, it is abundantly fitting and proper that this enduring example of God's message
27 of peace and love be recognized and congratulated for his innumerable good works rendered
28 on behalf of persons in need.

29 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
30 commend Pastor Eddie L. Ellison on his many years of faithful service to the Lord and
31 extend best wishes for many more years of successful fellowship and leadership.
