## A RESOLUTION

1 Recognizing Senator Lawrence (Bud) Stumbaugh and dedicating a bridge in his honor; and  
2 for other purposes.

3 WHEREAS, Senator Lawrence (Bud) Stumbaugh has long been recognized by the citizens  
4 of this state for the vital role that he has played in leadership and his deep personal  
5 commitment to the welfare of the citizens of Georgia; and

6 WHEREAS, a graduate of Lipscomb University, Senator Stumbaugh's professional career  
7 includes roles as a professional manager, entrepreneur, motivational speaker, and public  
8 servant; and

9 WHEREAS, Senator Stumbaugh diligently and conscientiously devoted his time, talents, and  
10 energy to the citizens of Georgia as a member of the Georgia State Senate for 16 years; and

11 WHEREAS, during the eight terms Senator Stumbaugh served in the Senate, his leadership  
12 and bi-partisan spirit were evident as chairman of the Senate Insurance Committee; and

13 WHEREAS, he has spoken before sales management groups, civic clubs, political forums,  
14 and school, religious, and business functions in 26 states; and

15 WHEREAS, Senator Stumbaugh grew one of his companies, Team Services, Inc., to 1,500  
16 employees in 39 states and helped make it the 29th fastest growing corporation in America  
17 before selling it on the London Stock Exchange; and

18 WHEREAS, he has served on the Board of Founders for Lipscomb University and the Board  
19 of Trustees for Faulkner University; and

20 WHEREAS, during his tenure with the Georgia Senate, Senator Stumbaugh served as vice  
21 chairperson for the Metropolitan Atlanta Rapid Transit Overview Committee; and

22 WHEREAS, it is abundantly fitting and proper that the extraordinary accomplishments of  
23 this distinguished Georgian be appropriately recognized by dedicating a bridge in his honor.

24 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL  
25 ASSEMBLY OF GEORGIA that the bridge on the MARTA Indian Creek Station exit ramp  
26 to Interstate 285 southbound in DeKalb County is dedicated as the Senator Lawrence (Bud)  
27 Stumbaugh Bridge.

28 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and  
29 directed to erect and maintain appropriate signs dedicating the Senator Lawrence (Bud)  
30 Stumbaugh Bridge.

31 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed  
32 to make appropriate copies of this resolution available for distribution to Senator Lawrence  
33 (Bud) Stumbaugh and to the Department of Transportation.
