276 For the purposes of this plan (LaVista Hills-p1-2015):

277 (1) The term "VTD" shall mean and describe the same geographical boundaries as  
278 provided in the report of the Bureau of the Census for the United States decennial census  
279 of 2010 for the State of Georgia. The separate numeric designations in a district  
280 description which are underneath a VTD heading shall mean and describe individual  
281 blocks within a VTD as provided in the report of the Bureau of the Census for the United  
282 States decennial census of 2010 for the State of Georgia;

283 (2) Except as otherwise provided in the description of any district, whenever the  
284 description of any district refers to a named city, it shall mean the geographical  
285 boundaries of that city as shown on the census maps for the United States decennial  
286 census of 2010 for the State of Georgia;

287 (3) Any part of the City of LaVista Hills which is not included in any district described  
288 in this plan (LaVista Hills-p1-2015) shall be included within that district contiguous to  
289 such part which contains the least population according to the United States decennial  
290 census of 2010 for the State of Georgia; and

291 (4) Any part of the City of LaVista Hills which is described in this plan (LaVista  
292 Hills-p1-2015) as being included in a particular district shall nevertheless not be included  
293 within such district if such part is not contiguous to such district. Such noncontiguous  
294 part shall instead be included within that district contiguous to such part which contains  
295 the least population according to the United States decennial census of 2010 for the State  
296 of Georgia.
