A RESOLUTION

1 Commending Robert L. Crutchfield for his dedicated service; and for other purposes.

2 WHEREAS, Robert L. Crutchfield has been President and Chief Executive Officer of
3 Christian City since 1993, which was founded by members of Independent New Testament
4 Christian Churches in 1962 and is a conglomerate of nine not-for-profit corporations
5 providing residential, health, and social services for children and the aged and infirm; and

6 WHEREAS, Mr. Crutchfield came to Christian City following 15 years of public service,
7 most of which were with the U.S. Department of Justice, and 15 years as a commercial
8 realtor where he received numerous industry awards, including being named the top agent
9 for RE/MAX of Georgia; and

10 WHEREAS, he has been active in the not-for-profit community as a member and chairman
11 of various boards and overseeing activities such as a home for unwed mothers, a private
12 placement adoption agency, a support program for the families of prisoners, a family
13 enrichment program through churches and public schools, and a faith based organization
14 designed to help resolve disputes as an alternative to the courts; and

15 WHEREAS, he is past president of both parent/teacher associations and the Smoke Rise
16 Community Association; and

17 WHEREAS, he is a member of Mount Carmel Christian Church where he has served as
18 Bible School teacher, trustee, and elder; he has also been a church administrator, a consultant
19 to various religious and educational institutions, and an active leader in faith based and civic
20 organizations; and

21 WHEREAS, Mr. Crutchfield is a native Georgian who received his formal education in
22 business management at Georgia State University; he is a graduate of the Georgia Realtor's
23 Institute and was formerly a Certified Commercial Investment Member of the National

24 Realtor's Marketing Institute; he was one of only three Atlanta members of the National Real
25 Estate Exchange; and

26 WHEREAS, he is a member of Vistage, an international organization of chief executives;
27 The Southern Institute for Ethics in Business; The American and Georgia Associations of
28 Homes and Services for the Aging; Georgia Association of Homes and Services for Children;
29 Georgia Health Care Association; and the Evangelical Council for Financial Accountability;

31 WHEREAS, he has been married to his wife, Judi, for 50 years and together they have two
32 sons; and

33 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
34 remarkable and distinguished Georgian be appropriately recognized.

35 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
36 the members of this body commend Robert L. Crutchfield for his dedicated service as the
37 President and Chief Executive Officer of Christian City.
