A RESOLUTION

1 Commending the Annual FNB South Community Golf Classic Tournament; and for other
2 purposes.

3 WHEREAS, FNB South of Alma, Georgia, along with its corresponding branches in
4 Appling, Bacon, Charlton, and Coffee counties of Georgia, have worked passionately each
5 year since August, 1999, to promote an annual FNB South Community Golf Classic
6 Tournament, and investment in young people has been the ever-present pursuit in their
7 efforts to achieve their goals; and

8 WHEREAS, FNB South reached out to countless individuals and businesses throughout their
9 banking area and beyond to help in this worthwhile project; teamwork among the banking
10 staff, the sponsors, and the communities led to more than \$20,000.00 in the first year and
11 \$500,000.00 total; and

13 awarded to students in seven counties throughout southeast Georgia and northeast Florida;
