A RESOLUTION

1 Recognizing and commending Mrs. Gloria B. Lewis on the occasion of her retirement as
2 Executive Director of the CSRA Economic Opportunity Authority, Inc; and for other
3 purposes.

4 WHEREAS, Mrs. Gloria B. Lewis has displayed leadership and a deep personal commitment
5 to the welfare of the citizens of Georgia through her work for the CSRA, a private nonprofit
6 501(c)(3) organization which promotes self-sufficiency and eases the human suffering of
7 individuals, children, and families with low incomes; and

8 WHEREAS, Mrs. Lewis provides leadership and guidance for more than 500 employees of
9 the agency and is responsible for the financial and operational integrity of the organization's
10 40 work sites in 14 counties, which include Bulloch, Burke, Columbia, Emanuel, Glascock,
11 Jefferson, Jenkins, Lincoln, McDuffie, Richmond, Screven, Taliaferro, Warren, and Wilkes;

13 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,
14 talents, and energy toward the betterment of her community, state, and nation as evidenced
15 by her service on many local, regional, and national boards and committees to find solutions
16 for the debilitating effects of poverty; and

17 WHEREAS, under Mrs. Lewis' leadership, CSRA Economic Opportunity Authority has been
18 awarded several prestigious state, regional, and national awards of excellence in the areas of
19 program development and self-sufficiency, including being selected as winner of the Audrey
20 Nelson Community Development Achievement Award, a national competition to recognize
21 an exemplary program that best addresses the needs of low-income families and
22 neighborhoods; and

23 WHEREAS, Mrs. Lewis earned the designation of Certified Community Action Manager
24 after completing the 140 hour, seven module leadership curriculum offered by the
25 Southeastern Association of Community Action Agencies; and

26 WHEREAS, she has participated as board member and trustee for many local, regional, and
27 national organizations including the Augusta Partnership for Children, Inc., Richmond/Burke
28 Workforce Investment Board, Partnership for Community Health, and Head Start
29 Associations; and

30 WHEREAS, Mrs. Lewis and her husband, Dennis, are the proud parents of LaMonica,
31 Tremayne, and Tamarah and the devoted grandparents of two adorable granddaughters,
32 Jamya Areaun and Bella Noelle; and

33 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
34 remarkable and distinguished Georgian be appropriately recognized.
