## A RESOLUTION

- 1 Commending Atlanta Metropolitan State College and recognizing January 22, 2016, as
- 2 Atlanta Metropolitan State College Day at the capitol; and for other purposes.
- 3 WHEREAS, the Board of Regents of the University System of Georgia authorized the
- 4 establishment of a junior college serving the west metropolitan area of Atlanta in June, 1965;
- 5 and
- 6 WHEREAS, the Superintendent of the Atlanta School Board was authorized to develop a
- 7 financial plan to build this new college in February, 1971, and in February, 1973, the Board
- 8 of Regents authorized the plans and specifications for phase one of the construction; and
- 9 WHEREAS, construction on this college's first building began in 1973 and was completed
- in August, 1974, and a month later, this 31st institution of the University System of Georgia
- 11 commenced classes with an initial enrollment of 504 students; and
- 12 WHEREAS, this college was accredited by the Southern Association of Colleges and
- 13 Schools in 1976, construction of the Central Energy Plant was completed in the 1976-1977
- 14 academic year, and two multi-level academic buildings were built during the 1978-1979
- 15 academic year; and
- 16 WHEREAS, this institution changed its name from Atlanta Junior College to Atlanta
- 17 Metropolitan College during the 1987-1988 academic year, a new Health and Physical
- 18 Education Complex opened its doors during the 1991-1992 academic year, and a new
- 19 Student Center was completed during the fall 2000 semester; and
- 20 WHEREAS, the Board of Regents authorized Atlanta Metropolitan College to move from
- 21 being a two-year college to become a state college on May 10, 2011, and the Southern
- 22 Association of Colleges and Schools followed their lead and reclassified this college from

23 a Level I to a Level II institution, which authorized it to offer four-year programs and

- bachelor's degrees; and
- 25 WHEREAS, in spring of 2012, the Board of Regents of the University System of Georgia
- 26 approved a request to change the name of the institution from Atlanta Metropolitan College
- 27 to Atlanta Metropolitan State College.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 29 the members of this body commend Atlanta Metropolitan State College for its growth and
- 30 success and recognize January 22, 2016, as Atlanta Metropolitan State College Day at the
- 31 capitol.
- 32 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 33 and directed to make appropriate copies of this resolution available for distribution to Atlanta
- 34 Metropolitan State College.
