A RESOLUTION

1 Proposing an amendment to the Constitution so as to abolish the existing Judicial
 2 Qualifications Commission; to require the General Assembly to create and provide by
 3 general law for the composition, manner of appointment, and governance of a new Judicial
 4 Qualifications Commission, with such commission having the power to discipline, remove,
 5 and cause involuntary retirement of judges; to provide for the submission of this amendment
 6 for ratification or rejection; and for other purposes.

7 BE IT RESOLVED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Section VII of Article VI of the Constitution is amended by revising Paragraph VI as
 10 follows:

11 "Paragraph VI. *Judicial Qualifications Commission; power; composition.* (a) The
 12 General Assembly shall by general law create and provide for the composition, manner of
 13 appointment, and governance of a Judicial Qualifications Commission, with such
 14 commission having the power to discipline, remove, and cause involuntary retirement of
 15 judges as provided by this Article shall be vested in the Judicial Qualifications
 16 Commission. It shall consist of seven members, as follows:

17 (1) ~~Two judges of any court of record, selected by the Supreme Court;~~

18 (2) ~~Three members of the State Bar of Georgia who shall have been active status~~
 19 ~~members of the state bar for at least ten years and who shall be elected by the board of~~
 20 ~~governors of the state bar; and~~

21 (3) ~~Two citizens, neither of whom shall be a member of the state bar, who shall be~~
 22 ~~appointed by the Governor.~~

23 (b) The Judicial Qualifications Commission which existed on December 31, 2016, is
 24 hereby abolished."

25 **SECTION 2.**

26 The above proposed amendment to the Constitution shall be published and submitted as
27 provided in Article X, Section I, Paragraph II of the Constitution. The ballot submitting the
28 above proposed amendment shall have written or printed thereon the following:

29 "() YES Shall the Constitution of Georgia be amended so as to abolish the existing
30 () NO Judicial Qualifications Commission and require the General Assembly to
31 create and provide by general law for the composition, manner of
32 appointment, and governance of a new Judicial Qualifications Commission,
33 with such commission having the power to discipline, remove, and cause
34 involuntary retirement of judges?"

35 All persons desiring to vote in favor of ratifying the proposed amendment shall vote "Yes."
36 All persons desiring to vote against ratifying the proposed amendment shall vote "No." If
37 such amendment shall be ratified as provided in said Paragraph of the Constitution, it shall
38 become a part of the Constitution of this state.
