## A RESOLUTION

- 1 Recognizing the Georgia Law Enforcement Certification Program and commending the
- 2 commitment to excellence on the part of the employees of state certified law enforcement
- 3 agencies; and for other purposes.
- 4 WHEREAS, in 1990 the Georgia Law Enforcement Certification Program was first created
- 5 in collaboration with the Georgia Association of Chiefs of Police, the Georgia Sheriffs'
- 6 Association, the Georgia Municipal Association, the Association County Commissioners of
- 7 Georgia, the Georgia Police Officer Standards and Training Council, and the Department of
- 8 Community Affairs; and
- 9 WHEREAS, in 1996 a partial committee was formed of law enforcement professionals to
- 10 create a standards manual that would establish a viable, functioning, and workable program;
- 11 the Georgia Law Enforcement Certification Program became administratively attached to the
- 12 Georgia Association of Chiefs of Police, was endorsed by the State of Georgia and its
- 13 honorable Governor, and was fully created; and
- 14 WHEREAS, as of today agencies are required to meet 129 separate standards across eight
- 15 different chapters which cover a wide array of law enforcement activities accentuating the
- 16 most current, practical, and relevant topics and policies, such as role and responsibility,
- 17 organization and management, personnel, legal, operations, support services, communication,
- 18 and holding areas; and
- 19 WHEREAS, the benchmarks, commonly known as standards or best practices requirements,
- 20 provide a description of what must be accomplished by the agency while allowing the agency
- 21 the latitude in determining how it will achieve compliance with the standards; and
- WHEREAS, the Georgia Association of Chiefs of Police administers, refines, and updates
- 23 the standards to reflect the most current and modern public safety trends making the Georgia
- 24 Law Enforcement Certification Program a standard for all agencies to attempt to achieve; and

25 WHEREAS, the public confidence in the agencies that are state certified is often reflected

- 26 in the reduction of some liability costs provided by insurers; and
- 27 WHEREAS, the success of this program is evident in that an aggregate of 124 premier law
- 28 enforcement agencies are now state certified, including some municipal, county, university,
- 29 K-12, and state agencies.
- 30 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 31 the members of this body recognize the Georgia Law Enforcement Certification Program and
- 32 commend the commitment to excellence on the part of the employees of state certified law
- 33 enforcement agencies, thanking them for serving the citizens of the State of Georgia with the
- 34 utmost integrity, and thereby solidifying public confidence in the state certification program
- and all of the law enforcement agencies comprising the program.

- 37 and directed to make an appropriate copy of this resolution available for distribution to the
- 38 Georgia Association of Chiefs of Police.
