## ADOPTED SENATE

## A RESOLUTION

- 1 Creating the Joint Study Committee on Health and Social Services Integrated Data Platform;
- 2 and for other purposes.
- 3 WHEREAS, good data are essential for good policy making in that rigorous evaluations can
- 4 allow effective programs to be taken to scale and ineffective ones to be scaled back or
- 5 discontinued, thereby freeing resources for other services; and
- 6 WHEREAS, in order for the General Assembly to arrive at the most informed understanding
- 7 of the net effects, both direct and indirect, of the various health and social service
- 8 interventions the General Assembly develops and resources, it is essential to consider the
- 9 impacts of any given program across the widest variety of areas; and
- 10 WHEREAS, the development of an integrated data platform, consisting of the system
- architecture, data storage and warehousing, software functionalities, hardware infrastructure,
- 12 and governance structure and processes required for the aggregation and analysis of data
- 13 from multiple sources and agencies, will allow the net effects of these programs to be
- 14 delivered in time frames that allow for effective and efficient resource allocation decisions;
- 15 and
- 16 WHEREAS, data related to the direct and indirect impacts of health and social service
- 17 programs belong to the people of Georgia and their elected representatives; and
- 18 WHEREAS, the submission of data to an integrated data platform on a regular and timely
- 19 basis by the appropriate state agencies, contractors, and other organizations as identified is
- 20 required for effective and efficient resource allocation decisions; and
- 21 WHEREAS, aggregation and analytical capabilities of the data platform will need to be open
- 22 to all potential users and governed by a defined process for the evaluation and selection of

23 questions that are appropriate to the goal of improving the effectiveness and efficiency of

- 24 resource allocation decisions within the state; and
- 25 WHEREAS, it is important to study an integrated data platform, including but not limited to
- 26 the issues outlined herein, so as to best develop and resource various health and social service
- 27 programs in this state and to create the most effective platform.
- 28 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 29 GEORGIA:
- 30 (1) **Creation of joint study committee.** There is created the Joint Study Committee on
- 31 Health and Social Services Integrated Data Platform.
- 32 (2) Members and officers.
- 33 (A) The committee shall be composed of ten members.
- 34 (B) The President of the Senate shall appoint five members of the Senate as members
- of the committee and shall designate one of such members as cochairperson.
- 36 (C) The Speaker of the House of Representatives shall appoint five members of the
- House of Representatives as members of the committee and shall designate one of such
- members as cochairperson.
- 39 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,
- issues, and problems mentioned above or related thereto and recommend any action or
- legislation which the committee deems necessary or appropriate.
- 42 (4) **Meetings.** The cochairpersons shall call all meetings of the committee. The
- committee may conduct such meetings at such places and at such times as it may deem
- 44 necessary or convenient to enable it to exercise fully and effectively its powers, perform
- its duties, and accomplish the objectives and purposes of this resolution.
  - (5) Allowances and funding.
- 47 (A) The legislative members of the committee shall receive the allowances provided
- for in Code Section 28-1-8 of the Official Code of Georgia Annotated.
- (B) The allowances authorized by this resolution shall not be received by any member
- of the committee for more than five days unless additional days are authorized. Funds
- necessary to carry out the provisions of this resolution shall come from funds
- appropriated to the Senate and House of Representatives.

- 54 (A) In the event the committee adopts any specific findings or recommendations that
- include suggestions for proposed legislation, the cochairpersons shall file a report of the
- same prior to the date of abolishment specified in this resolution, subject to
- subparagraph (C) of this paragraph.

(B) In the event the committee adopts a report that does not include suggestions for proposed legislation, the cochairpersons shall file the report, subject to subparagraph (C) of this paragraph.

- (C) No report shall be filed unless the same has been approved prior to the date of abolishment specified in this resolution by majority vote of a quorum of the committee.
- A report so approved shall be signed by the cochairpersons of the committee and filed with the Secretary of the Senate and the Clerk of the House of Representatives.
  - (D) In the absence of an approved report, the cochairpersons may file with the Secretary of the Senate and the Clerk of the House of Representatives copies of the minutes of the meetings of the committee in lieu thereof.
- 68 (7) **Abolishment.** The committee shall stand abolished on December 1, 2016.
