## A RESOLUTION

- 1 Honoring the life and memory of Ms. Naomi Tsipora Walker; and for other purposes.
- 2 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens  
3 with the passing of Ms. Naomi Tsipora Walker on December 19, 2015; and
- 4 WHEREAS, Ms. Walker was born on January 16, 1969, in Chattanooga, Tennessee, a  
5 beloved daughter of Ruth and Ben Walker; and
- 6 WHEREAS, diagnosed with familial dysautonomia, a rare genetic neurological condition,  
7 and battling life-threatening medical complications from birth, Ms. Walker never let her  
8 disability keep her from achieving her personal and professional goals, keeping an optimistic  
9 outlook on life; and
- 10 WHEREAS, deeply influenced by her father, a Holocaust survivor, she grew up in a home  
11 that encouraged her independent spirit and that instilled within her the values of social justice  
12 and tolerance; and
- 13 WHEREAS, upon graduating from Oglethorpe University and receiving her law degree from  
14 Emory University, Ms. Walker landed her dream drop as an attorney with the Georgia  
15 Advocacy Office, a nonprofit organization charged with protecting the rights of the state's  
16 disabled or mentally ill residents, where she became part of a catalyst for change which  
17 helped better the lives of countless Georgians statewide; and
- 18 WHEREAS, "She made every day that she had matter, and worked with a sense of urgency  
19 because she realized that every day of her clients' lives mattered, and that they had worth and  
20 should not be cast aside," said Ruby Moore, executive director of the Georgia Advocacy  
21 Office; and

22 WHEREAS, during her 21 year tenure at the Georgia Advocacy Office, she worked to  
23 improve access to care, jobs, and assistive technology to improve the quality of life for  
24 disabled individuals; she also partnered with Tools for Life, a state program created to help  
25 more disabled individuals gain access to assistive technology devices for independent living;

27 WHEREAS, Ms. Walker is survived by her loving husband, Barbaro Ponce, her parents, and  
28 sister, Ronit Walker; and

29 WHEREAS, a compassionate and generous woman, Ms. Walker will long be remembered  
30 for her love of family, friendship, and public service and will be missed by all who had the  
31 great fortune of knowing her.

32 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
33 join in honoring the life and memory of Ms. Naomi Tsipora Walker and express their deepest  
34 and most sincere regret at her passing.
