A BILL TO BE ENTITLED
AN ACT

1 To amend Title 27 of the Official Code of Georgia Annotated, relating to game and fish, so
2 as to revise definitions, license fees, and license requirements; to amend Code Section 52-7-5
3 of the Official Code of Georgia Annotated, relating to numbering of vessels, requirements,
4 and fees, so as to revise boat registration fees and allow additional methods for reporting the
5 sale of boats; to correct cross-references; to provide for related matters; to provide for an
6 effective date and applicability; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Title 27 of the Official Code of Georgia Annotated, relating to game and fish, is amended in
10 Code Section 27-1-2, relating to definitions relative to game and fish, by revising
11 paragraph (60) and adding a new paragraph to read as follows:

12 "(60) 'Resident' means any citizen of the United States who has been domiciled within
13 the State of Georgia for a period of at least three months. For purposes of issuing or
14 procuring the noncommercial hunting and fishing licenses required by this title, the term
15 'resident' shall include full-time military personnel on active duty and the dependents of
16 such military personnel; provided, however, that requirements for residency as defined
17 in ~~paragraph (5) of subsection (e) of subparagraph (c)(4)(A) of~~ Code Section 27-2-3.1
18 shall apply to such military personnel and their dependents for all lifetime license types
19 listed in Code Section 27-2-3.1 that are only available to residents. Requirements for
20 residency as defined in ~~paragraph (5) of subsection (e) of subparagraph (c)(4)(A) of~~ Code
21 Section 27-2-3.1 shall also apply to such military personnel and their dependents for all
22 honorary or discounted license types listed in Code Section 27-2-4 and to the landowner
23 exemption in subsection (b) of Code Section 27-2-1, provided that the domicile
24 requirement shall be a period of at least three months."

25 "(63.1) 'Seafood dealer' means any person other than the consumer who purchases, ships,
 26 consigns, transfers, barter, accepts, maintains, or packs any marine fishery products
 27 received from commercial seafood harvesters or marine aquaculturists for the first time."

28 **SECTION 2.**

29 Said title is further amended in Code Section 27-2-1, relating to hunting, trapping, or fishing
 30 without a license or permit, by revising subsection (b) as follows:

31 "(b) It shall be unlawful for any resident of this state who has attained the age of 16 years
 32 to hunt, fish in the waters of this state, or trap without a valid hunting license, fishing
 33 license, or trapping license, respectively, as provided in Code Section 27-2-23, except on
 34 premises owned by him or her or his or her immediate family; provided, however, that the
 35 resident owner of any vessel with a valid registration in accordance with Code Section
 36 52-7-5 shall have, as part of the registration fee for such vessel, a paid ~~three-day~~ one-day
 37 resident hunting and fishing license ~~that begins~~ valid only on such owner's date of birth ~~and~~
 38 ~~extends two consecutive days thereafter~~ in accordance with the requirements of this title
 39 and as otherwise specified by the department. It shall be unlawful for any resident of this
 40 state to hunt, fish, or trap in this state without carrying such license upon his or her person,
 41 except on premises owned by him or her or his or her immediate family and except when
 42 otherwise specifically directed by authorized personnel of the department."

43 **SECTION 3.**

44 Said title is further amended by revising Code Section 27-2-3, relating to effective periods
 45 of hunting, fishing, and trapping licenses, as follows:

46 "27-2-3.

47 (a) Except as otherwise specifically provided, all hunting, fishing, and trapping licenses,
 48 including without limitation commercial fishing and commercial fishing boat licenses
 49 issued pursuant to Code Section 27-2-8, shall be effective from April 1 to March 31 of the
 50 following year; except that all annual, two-year, or other multiyear hunting, fishing, and
 51 hunting and fishing combination licenses issued pursuant to paragraphs (1) through (4) of
 52 Code Section 27-2-23 shall be effective through the applicable one-year, two-year, or
 53 multiyear anniversary of the date of issuance. If a person possesses a valid annual,
 54 two-year, or other multiyear hunting, fishing, or hunting and fishing combination license
 55 at the time of sale of one or more annual, two-year, or other multiyear licenses with
 56 identical privileges to the valid license, the new license or licenses shall become effective
 57 when the original license expires and shall remain valid through the full applicable period.
 58 The department may specify the effective dates and term of the following licenses or
 59 permits:

60 (1) The Georgia waterfowl and migratory bird stamp to meet requirements of Code
 61 Section 27-2-20;

62 (2) The free Georgia salt water fishing endorsement to meet requirements of Code
 63 Section 27-2-20.1; and

64 (3) Any permit or requirement authorized by Code Section 27-3-29 regarding harvest
 65 recording and reporting.

66 (b) Multiyear licenses valid for any desired number of years may be purchased through a
 67 single transaction for licenses listed in paragraphs (1) through (4) of Code Section 27-2-23.
 68 The fee for any such multiyear license shall be equivalent to the lowest cost combination
 69 of annual or two-year licenses necessary to form the desired multiyear license period. No
 70 ~~multiyear~~ resident license shall be valid at the time of hunting or fishing unless the licensee
 71 is a resident of this state at such time, except for lifetime licenses."

72 **SECTION 4.**

73 Said title is further amended by revising Code Section 27-2-3.1, relating to hunting and
 74 sportsman's licenses, as follows:

75 "27-2-3.1.

76 (a) The requirements in this title for procuring any paid license or permit for
 77 noncommercial hunting and fishing privileges, except for ~~hunting~~ harvesting alligators,
 78 shall be satisfied by a resident or nonresident who procures a sportsman's license. ~~An~~
 79 ~~applicant for such license shall, prior to the issuance of the license, complete a screening~~
 80 ~~questionnaire associated with the federal Migratory Bird Harvest Information Program.;~~
 81 provided, however, that the department may specify other nonpaid licenses and permits
 82 required by law or by rule or regulation of the board. An applicant for such license shall
 83 furnish all information required by the department prior to the issuance of such license. An
 84 applicant for any paid or nonpaid license who is a resident shall certify and provide
 85 satisfactory evidence of his or her residency as set forth in paragraph (4) of subsection (c)
 86 of this Code section.

87 (b) All licenses, stamps, or permits for noncommercial hunting and fishing privileges shall
 88 be attached to or printed on a form provided by the department which shall include the
 89 applicant's name, address, date of birth, and hunter safety certification number; provided,
 90 however, that each such item of information may be, but is not required to be, printed on
 91 lifetime licenses.

92 (c)(1) The requirements in this title for procuring any paid license, stamp, or permit for
 93 noncommercial hunting and fishing privileges shall be satisfied by a resident or
 94 nonresident who procures a lifetime sportsman's license; provided, however, that the
 95 department may specify other required nonpaid licenses and permits required by law or

96 by rule or regulation of the board for such resident or nonresident and that an applicant
 97 for such license shall furnish all information required by the department prior to the
 98 issuance of such license; and provided, further, that the requirements in this title for
 99 procuring any paid license, stamp, or permit for noncommercial hunting or for
 100 noncommercial fishing privileges, separately, shall be satisfied by a resident or
 101 nonresident who procures a lifetime sportsman's license for hunting only or for fishing
 102 only, respectively, as described in subparagraph (d)(1)(E) of this Code section.

103 ~~(2) An applicant for such license who is a resident shall certify and provide satisfactory~~
 104 ~~evidence of his or her residency as set forth in paragraph (5) of this subsection.~~

105 ~~(3)~~ An applicant for a veteran's lifetime sportsman's license shall, in addition to
 106 satisfactory evidence of residency, be required to provide satisfactory evidence that he
 107 or she served more than 90 days of federal active duty military service and was honorably
 108 discharged.

109 ~~(4)~~(3) An applicant for such a lifetime sportsman's license who is a nonresident shall not
 110 be eligible for issuance of such license unless:

111 (A) He or she is from two through 15 years of age and is the grandchild of a resident
 112 who holds a valid paid lifetime sportsman's license (~~not excluding a no-cost~~ no-cost Type S
 113 lifetime license). The resident grandparent who holds such a lifetime sportsman's
 114 license and who is the sponsor of an eligible nonresident applicant for a lifetime
 115 sportsman's license shall certify the nonresident applicant's relationship to him or her
 116 in writing to the department; or

117 (B) He or she is less than two years of age.

118 ~~(5)~~(4)(A) For purposes of procuring a lifetime sportsman's license, the term 'residency'
 119 means a domicile within Georgia for a minimum of three consecutive months
 120 immediately prior to procuring such license. Satisfactory evidence of residency shall
 121 consist of a current Georgia driver's license or official Georgia identification card
 122 issued by the Department of Driver Services; provided, however, that no license or
 123 identification card issued pursuant to Code Section 40-5-21.1 shall satisfy the
 124 requirements of this paragraph.

125 (B) Minors under 18 years of age shall be presumed to be residents upon proof of
 126 parent's resident status as provided for in this Code section. For purposes of procuring
 127 the Type I (Infant) and Type Y (Youth) lifetime license, a copy of a certified copy of
 128 the birth certificate of the licensee shall be required to show age (Types I and Y) and
 129 parentage (Type Y). A court order or other legal document establishing parental rights
 130 or legal custody may be provided to show parentage.

131 (d)(1) Lifetime sportsman's licenses and fees for residents shall be as follows:

- 132 (A) Type I (Infant), available only to those individuals under two years of age: ~~\$200.00~~
 133 \$425.00;
- 134 (B) Type Y (Youth), available only to those individuals from two through 15 years of
 135 age: ~~\$350.00~~ \$550.00;
- 136 (C) Type A (Adult), available to those individuals 16 years to 49 years of age ~~or older~~:
 137 ~~\$500.00~~ \$750.00;
- 138 (C.1) Type OA (Older Adult), available to those individuals 50 years to 59 years of
 139 age: \$375.00;
- 140 (D) Type SD (Senior Discount), available to those individuals 60 years to 64 years of
 141 age ~~or older~~: ~~\$95.00~~ \$275.00;
- 142 (E) Type S (Senior), available to those individuals 65 years of age or older born on or
 143 before June 30, 1952; no charge;. The lifetime sportsman's licenses and fees available
 144 to those individuals 65 years of age and older born after June 30, 1952, shall be as
 145 follows:
- 146 (i) Type SP (Senior Paid): \$70.00;
- 147 (ii) Type SH (Senior Hunt), for hunting only: \$35.00; and
- 148 (iii) Type SF (Senior Fish), for fishing only: \$35.00;
- 149 (F) Type V (Veterans), available only to those individuals who served more than 90
 150 days of federal active duty military service and were honorably discharged: 80 percent
 151 of the amount of the fee specified for Type A lifetime sportsman's licenses in
 152 subparagraph (C) of this paragraph; ~~and~~
- 153 (G) Type M (Military), available only to those residents currently in active military
 154 service and who are in possession of a valid United States Department of Defense
 155 Common Access Card with a Uniformed Services affiliation. As used in this
 156 subsection, the term 'active military service' means service on active duty with the
 157 armed forces of the United States or service with a reserve component of the armed
 158 forces of the United States, including service in the Georgia National Guard or National
 159 Guard of another state: 80 percent of the amount of the fee specified for Type A
 160 lifetime sportsman's licenses in subparagraph (C) of this paragraph; and
- 161 ~~(G)~~(H) Type SP (Shooting Preserve), available to any individual, resident or
 162 nonresident, and which entitles the holder to hunt pen raised game birds and fish in any
 163 private or state waters within the boundaries of a properly licensed shooting preserve:
 164 \$75.00.
- 165 (2) The fee for any lifetime sportsman's license for a nonresident, Type NR, shall be
 166 twice the amount of the fee for a Type A (Adult) lifetime sportsman's license for a
 167 resident, except that the fee for a nonresident Type I (Infant) license shall be the same fee
 168 as for a resident Type I (Infant) license.

169 (e) Lifetime sportsman's licenses shall be valid for the lifetime of the purchaser, whether
 170 resident or nonresident. Change of residency to another state shall not affect the validity
 171 of the lifetime license when hunting or fishing in Georgia.

172 (f) The commissioner shall revoke the lifetime sportsman's license of any person who
 173 knowingly attempts to or does purchase, obtain, or assist another person to obtain a lifetime
 174 sportsman's license by fraudulent means, without refund of any fees paid.

175 (g) Upon payment of a replacement fee of up to ~~\$10.00~~ \$15.00, any durable plastic card
 176 showing a lifetime sportsman's license or other valid license may be replaced if lost, stolen,
 177 or destroyed, provided that the applicant's name and lifetime license number or other
 178 required license information are in the records of the department.

179 (h) Once a lifetime license is issued, no refunds of fees will be made except in the case of
 180 the death before age 16 years of a Type I (Infant) lifetime license holder or a Type Y
 181 (Youth) license holder, in which case a full refund of fees collected may be made upon
 182 submission of the lifetime license and any other documentation required by the department.

183 (i) The requirements in this title for procuring any paid license, stamp, or permit for
 184 noncommercial hunting and fishing privileges shall be satisfied by a resident youth
 185 younger than 16 years of age who procures an optional annual or an optional multiyear
 186 resident youth sportsman's license. The requirements in this title for procuring any paid
 187 license, stamp, or permit for noncommercial fishing privileges shall be satisfied by a youth
 188 younger than 16 years of age who procures an optional annual or an optional multiyear
 189 resident youth license for fishing only. A resident youth multiyear fishing license or
 190 resident youth multiyear sportsman's license will be valid from the time of purchase until
 191 such person reaches 17 years of age. The department may require satisfactory evidence to
 192 show age and residency before issuing an annual or youth multiyear license."

193 SECTION 5.

194 Said title is further amended by revising Code Section 27-2-4, relating to honorary licenses,
 195 as follows:

196 "27-2-4.

197 (a) The department shall issue ~~an honorary~~ a discounted hunting and fishing license, which
 198 shall entitle a resident to hunt and fish in this state without the payment of fees described
 199 in Code Section 27-2-23, to each resident who is permanently and totally disabled. For
 200 purposes of this Code section, a permanent, total disability shall be a physical or mental
 201 impairment of a total and permanent nature ~~which prevents gainful employment and~~ which
 202 is certified as such by the United States Department of Veteran Affairs, the Social Security
 203 Administration, Medicaid, medicare, the Railroad Retirement System, or a unit of federal,
 204 state, or local government recognized by the board by rule or regulation; provided,

205 however, that persons disabled because of a mental impairment shall be issued ~~an honorary~~
206 a discounted fishing license only. Persons issued ~~an honorary~~ a discounted license under
207 disability provisions shall renew such licenses and recertify their eligibility for such
208 licenses every three years; provided, however, that ~~honorary~~ licenses in effect as of July
209 1, 1998, shall not require renewal. The fee for a discounted three-year license issued
210 pursuant to this subsection shall be \$9.00 for hunting or fishing only and \$15.00 for hunting
211 and fishing combined. The fee for a discounted annual license issued pursuant to this
212 subsection shall be \$3.00 for hunting or fishing only and \$5.00 for hunting and fishing
213 combined.

214 (b) Any resident who is totally blind and who applies to the department shall receive a
215 lifetime honorary fishing license which shall entitle the holder thereof to fish in this state
216 without the payment of any fee whatsoever.

217 (c) Any person holding a valid honorary or discounted license pursuant to this Code
218 section shall not be required to obtain the trout license and big game license otherwise
219 required by Code Section 27-2-6.

220 (d) All honorary and discounted hunting and fishing licenses are subject to all wildlife
221 laws, rules, and regulations with the exception of the provisions requiring the payment of
222 fees described in Code Section 27-2-23 for such licenses. Such honorary and discounted
223 licenses may be revoked in accordance with this title. It shall be unlawful for any person
224 who has an honorary or discounted hunting and fishing license to permit the use of same
225 by any other person. It shall also be unlawful for any person who is not entitled to ~~an~~
226 ~~honorary~~ a discounted hunting and fishing license to use such a license or for any totally
227 and permanently disabled person issued such a license to possess or use such license when
228 the disability is no longer total or permanent. Licenses for the totally and permanently
229 disabled may, upon a determination that the disability is no longer total or permanent, be
230 revoked until such time as the disability is again total and permanent.

231 (e) The commissioner is authorized to make and enter into agreements from time to time
232 with the proper authorities of various states of the United States regarding nonresident
233 hunting and fishing license fees for persons 65 years of age or older so as to provide
234 ~~honorary~~ discounted hunting and fishing licenses to be issued ~~without charge~~ to
235 nonresidents 65 years of age or older where such practice is reciprocated for Georgia
236 residents in that person's state of residence.

237 (f) Persons holding lifetime honorary licenses issued to persons 65 years of age or older
238 prior to April 1, 1999, shall not be required to obtain a lifetime license pursuant to Code
239 Section 27-2-3.1, and such lifetime honorary license shall carry the same rights and
240 privileges as a lifetime license issued pursuant to that Code section.

241 (g)(1) As used in this subsection, the term 'returning veteran' means a person who is
 242 discharged from active duty as a member of the regular or reserve component of the
 243 United States armed forces, the United States Coast Guard, the Georgia National Guard,
 244 or the Georgia Air National Guard and who was on ordered federal duty for a period of
 245 90 days or longer.

246 (2) The department shall issue an honorary hunting and fishing license to any returning
 247 veteran which shall entitle him or her to hunt and fish in this state without the payment
 248 of fees described in Code Section 27-2-23 for a period of one year following issuance.
 249 A returning veteran requesting such an honorary license shall provide proof of his or her
 250 discharge."

251 **SECTION 6.**

252 Said title is further amended by revising Code Section 27-2-4.2, relating to courtesy
 253 nonresident fishing licenses for certain veterans, as follows:

254 "27-2-4.2.

255 The department is authorized to issue a courtesy nonresident fishing license, without fee,
 256 to any person who is not a resident of this state who is a paralyzed or disabled veteran and
 257 who is participating in an organized fishing tournament in this state which is sponsored and
 258 conducted by a nonprofit charitable association of paralyzed or disabled veterans, provided
 259 that such tournament is approved by the department. Such courtesy nonresident license
 260 shall be valid for use only during the specified dates of such tournament and for a
 261 maximum of seven days and shall include all requirements and privileges of a nonresident
 262 fishing license, including the nonresident trout license, for use only in association with such
 263 tournament."

264 **SECTION 7.**

265 Said title is further amended by revising Code Section 27-2-5, relating to required hunter
 266 education courses, as follows:

267 "27-2-5.

268 (a) It shall be unlawful for any person born on or after January 1, 1961, to procure a
 269 hunting license or to hunt by means of weapons in this state unless that person has been
 270 issued a certificate or other evidence the department deems acceptable which indicates
 271 satisfactory completion of a hunter education course as prescribed by the board. Persons
 272 ages ~~16~~ 12 through 25 shall provide such certificate or other evidence to the issuing agent
 273 at the time of purchase of a hunting license. All persons required by this subsection to
 274 complete a hunter education course, by ~~signing~~ buying such license, by receiving a
 275 temporary license identification number, or by receiving a license from a telephone license

276 agent, Internet license agent, or other vendor, shall certify by such action their compliance
277 with this subsection.

278 (b) It shall be unlawful for any person authorized to issue hunting licenses in this state to
279 issue a hunting license to any person age 16 through 25 unless that license agent shall have
280 been provided with a certificate showing the license applicant has satisfactorily completed
281 a hunter education course as prescribed by the board, or to any other person born on or
282 after January 1, 1961, unless such person provides such other evidence of completion of
283 a hunter education course as the department deems acceptable. Internet and telephone
284 license agents may accept a valid hunter education certificate number as fulfillment of this
285 requirement.

286 (c) It shall be unlawful for any person age 16 through 25 who is not required by law to
287 obtain a hunting license to hunt in this state unless that person carries on his or her person
288 while hunting a certificate attesting to that person's satisfactory completion of a hunter
289 education course as prescribed by the board. Such person shall present his or her certificate
290 to a conservation ranger or deputy conservation ranger for inspection upon demand.

291 (d) Any person who is age 12 through 15 shall satisfactorily complete a hunter education
292 course as a prerequisite to hunting with a weapon in this state. It shall be unlawful for any
293 adult to permit his or her child or ward age 12 through 15 to hunt with a weapon unless the
294 child has a certificate attesting to his or her satisfactory completion of such course on his
295 or her person; provided, however, that a hunter education course is not required for a child
296 ~~age 12 through 15 less than 16 years of age~~ who is hunting under adult supervision by a
297 licensed adult hunter.

298 (e) Any person applying for an annual or multiyear nonresident hunting/fishing license
299 may provide a certificate of completion or such other evidence of completion the
300 department deems acceptable of the official hunter education or hunter safety course of
301 such person's state of residence if that course shall have been approved by the department.
302 ~~Those persons~~ No one applying for a hunting license ~~other than a season hunting of less~~
303 than one year in duration or for a lifetime license shall ~~not~~ be required to exhibit such a
304 certificate or to complete a hunter education course in order to obtain the license. Persons
305 holding a lifetime license shall complete an official hunter education or hunter safety
306 course and display proof of completion as specified by the department in order to hunt
307 unless otherwise exempted by this title.

308 (f) By rule or regulation, the board shall prescribe a course of instruction in competency
309 and safety in hunting and in the handling of weapons. The board shall also prescribe
310 procedures whereby competent residents of this state shall be certified as hunter education
311 instructors. The board may provide, by rule or regulation, for charging reasonable fees for
312 the issuance by the department of duplicate certificates of completion of a hunter education

313 course and for hunter education courses in order to defray the expenses of conducting such
 314 courses. Any such fees shall be deemed as 'other income' of the department for purposes
 315 of subsection (c) of Code Section 27-1-13.

316 (g) Any person violating any provision of this Code section shall be guilty of a
 317 misdemeanor; provided, however, that this subsection shall not apply to any person under
 318 the age of 16.

319 (h) The requirements of subsections (c) and (d) of this Code section shall not apply to any
 320 person hunting on his or her own land or that of his or her parents or legal guardian or to
 321 persons permitting a child or ward aged 12 through 15 years to hunt on the parent's or
 322 guardian's own land."

323 **SECTION 8.**

324 Said title is further amended by revising Code Section 27-2-6, relating to trout, waterfowl,
 325 big game, and alligator licenses, as follows:

326 "27-2-6.

327 (a) It shall be unlawful for any person who has attained the age of 16 years to fish for or
 328 possess mountain trout or to fish in any waters designated as trout waters or trout streams
 329 pursuant to Code Section 27-4-51 unless such person has in his or her possession a trout
 330 license in addition to his or her fishing license.

331 (b) It shall be unlawful for any person who has attained the age of 16 years to hunt or
 332 possess big game unless such person has in his or her possession a big game license in
 333 addition to the required hunting license; provided, however, that all nonresidents,
 334 regardless of age, must possess a nonresident hunting/fishing license along with any
 335 harvest records required by law or regulation to hunt big game in this state.

336 (c) It shall be unlawful for any person who has attained the age of 16 years to hunt ducks,
 337 geese, or swans unless such person has in his or her possession ~~an official Georgia~~
 338 ~~waterfowl license~~ a Georgia waterfowl and migratory bird stamp in addition to the required
 339 hunting license; ~~provided, however, that a Georgia waterfowl and migratory bird stamp or~~
 340 ~~a landowner Georgia waterfowl and migratory bird stamp shall be required for any resident~~
 341 ~~of this state to hunt migratory birds on premises owned by him or her or his or her~~
 342 ~~immediate family.~~

343 (d) It shall be unlawful for any person who has attained the age of 16 years to hunt
 344 alligators unless such person has in his or her possession ~~an alligator hunting license in~~
 345 ~~addition to the required~~ a valid hunting license; ~~provided, however, that this subsection~~
 346 ~~shall not apply to lifetime license holders.~~ A resident or nonresident alligator harvest
 347 permit shall be required to harvest an alligator. Such permit shall be free to lifetime license
 348 holders if selected as part of any department quota or lottery.

349 (e) No resident of this state shall be required to obtain a trout license, ~~official Georgia~~
 350 ~~waterfowl license~~, or big game license to hunt, fish, or trap on premises owned by him or
 351 her or his or her immediate family.

352 (f) Any visitor to a state park, whether a resident or nonresident of Georgia, shall not be
 353 required to purchase a trout license when fishing in impounded waters on lands owned or
 354 leased by the department."

355 **SECTION 9.**

356 Said title is further amended by revising Code Section 27-2-8, relating to commercial fishing
 357 boat licenses, as follows:

358 "27-2-8.

359 (a) It shall be unlawful for any person to engage in commercial fishing with a boat or
 360 vessel in the salt waters of this state without first obtaining a valid commercial fishing boat
 361 license for the boat or vessel. The owner or operator of the boat or vessel shall present in

 377 be charged a license fee in addition to that provided by subsection (b) of this Code section

 379 boat or vessel other than a trawler used in commercial fishing or in the taking of seafood,
 380 which boat or vessel is owned, in whole or part, by such nonresident or alien, provided that,
 381 in the event such nonresident or alien applying for the license is a resident of another state
 382 which charges nonresidents a license fee greater than the total license fee charged for
 383 nonresidents in this state, then the additional license fee provided for nonresidents in this

 395 while the trawler is in operation for purposes of the trawler crew license."

 412 questionnaire as provided by the department while hunting migratory birds."

719 (2) Registrations may be renewed any time after October 1 prior to the year of
 720 expiration. If the certificate of number is allowed to expire, a renewal application may
 721 still be filed with the department so long as the applicant pays the registration fee
 722 prescribed in subsection (d) of this Code section along with a \$10.00 late fee.

723 (3) Any application ~~for renewal~~ which, due to failure of the applicant to provide
 724 additional information required by the department, remains incomplete 60 days after
 725 initial receipt of such application shall expire, and a new application and registration fee
 726 shall be required ~~for renewal~~."

727 "(j) The owner shall furnish the department ~~written~~ notice of the transfer of all or of any
 728 part of his or her interest, other than the creation of a security interest, in a vessel numbered
 729 in this state pursuant to this Code section, the theft or recovery of the vessel, or the
 730 destruction or abandonment of the vessel within 15 days thereof, in a manner specified by
 731 the department."

732 **SECTION 20.**

733 This Act shall become effective on July 1, 2017, and shall apply to all offenses occurring on
734 or after such date.

735 **SECTION 21.**

736 All laws and parts of laws in conflict with this Act are repealed.
