## A RESOLUTION

1 Recognizing and commending Dr. Romona Jackson Jones on her outstanding public service;  
2 and for other purposes.

3 WHEREAS, Dr. Romona Jackson Jones took office as chairperson of the Douglas County  
4 Board of Commissioners on January 1, 2017, becoming the county's first African American  
5 woman to hold such position; and

6 WHEREAS, Dr. Jones has long been recognized by the citizens of this state for the vital role  
7 that she has played in leadership and her deep personal commitment to the welfare of the  
8 citizens of Georgia; and

9 WHEREAS, a woman of deep and abiding faith, Dr. Jones is an active member of Word of  
10 Faith Church; and

11 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,  
12 talents, and energy toward the betterment of her community and state as evidenced  
13 dramatically by her superlative 40 years of service in the health care industry; and

14 WHEREAS, she has earned distinction and numerous awards for her dedication to public  
15 service, including the Servant Leadership Award in 2014 from the Georgia Women's  
16 Legislative Caucus and a President Barack Obama Lifetime Achievement Award in 2017;

18 WHEREAS, her significant organizational and leadership talents, her remarkable patience  
19 and diplomacy, her keen sense of vision, and her sensitivity to the needs of the citizens of  
20 this state have earned her the respect and admiration of her colleagues and associates; and

21 WHEREAS, she is a person of magnanimous strengths with an unimpeachable reputation for  
22 integrity, intelligence, fairness, and kindness; and

23 WHEREAS, Dr. Romona Jackson Jones has served her community and state with honor and  
24 distinction, and her vision and unyielding commitment have set the standard for public  
25 service; and

26 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
27 remarkable and distinguished Georgian be appropriately recognized.

28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
29 the members of this body recognize and commend Dr. Romona Jackson Jones for her  
30 efficient, effective, unselfish, and dedicated public service to the State of Georgia and extend
