

Senate Bill 297

By: Senators Tate of the 38th, Fort of the 39th, Orrock of the 36th, Brass of the 28th and Shafer of the 48th

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act to provide a new charter for the City of Atlanta, approved April 15, 1996  
2 (Ga. L. 1996, p. 4469), as amended, so as to change the corporate limits of such municipality;  
3 to provide for the effect on the Atlanta Independent School System; to provide for related  
4 matters; to provide for effective dates; to provide for severability; to repeal conflicting laws;  
5 and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act to provide a new charter for the City of Atlanta, approved April 15, 1996 (Ga. L.  
9 1996, p. 4469), as amended, is amended by designating the current text of Section 1-105 as  
10 subsection (a) and by adding a new subsection (b) to read as follows:

11 "(b) In addition to the territory described in subsection (a) of this section, the corporate  
12 boundaries of the City of Atlanta shall also include the following described territory:

50 **SECTION 2.**

51 This Act shall become effective upon the approval of the Governor or upon becoming law  
 52 without such approval. The annexation of certain territory into the City of Atlanta by this  
 53 Act shall not extend the territory of the Atlanta Independent School System and this Act shall  
 54 have no effect on the charter of such system.

55 **SECTION 3.**

56 In the event that all or any part of Section 2 of this Act shall be finally declared or adjudged  
 57 invalid or unconstitutional, such adjudication shall in no manner affect the other sections,  
 58 subsections, sentences, clauses, or phrases of this Act, which shall remain of full force and  
 59 effect, as if Section 2 were not originally a part hereof. In such event, this Act shall become

60 effective upon a final declaration or adjudication that the amendment to the Constitution of  
61 Georgia providing that, upon extension of the corporate limits of the City of Atlanta into  
62 Fulton County, the territory embraced therein shall become part of the independent school  
63 system of the City of Atlanta and shall cease to be a part of the school system of Fulton  
64 County and that the school property located within the area embraced in the extension shall  
65 become the property of the City of Atlanta (Res. Act No. 73; H. R. No. 182-969j; Ga. L.  
66 1950, p. 458), which was continued under the 1983 Constitution of the State of Georgia by  
67 an Act approved March 26, 1986 (Ga. L. 1986, p. 4812), is invalid, or upon the repeal of  
68 such amendment.

69 **SECTION 4.**

70 All laws and parts of laws in conflict with this Act are repealed.
