

ADOPTED

Senator Fort of the 39th offered the following amendment:

1 *Amend the substitute to HB 430 (LC 33 7066S) by inserting after "definition;" on line 5 the*
 2 *following:*

3 to provide for a pilot program to plan, implement, and improve sustainable community
 4 schools for traditional public schools and charter schools; to provide for grants; to provide
 5 for definitions; to provide for planning and implementation grants; to provide for
 6 applications for grants; to require community school plans; to provide for requirements for
 7 grant recipients; to delineate the purposes for which grant funds may be used;

8 *By inserting after line 243 the following:*

9 **SECTION 4A.**

10 Said title is further amended by revising Article 14 of Chapter 2, which is reserved, as
 11 follows:

12 "ARTICLE 14

13 20-2-640.

14 As used in this article, the term:

15 (1) 'Applicant' means a school or a local board of education proposing to work in
 16 collaboration with one or more community organizations, which is seeking a Sustainable
 17 Community School Operational Grant pursuant to this article for a covered school site.

18 (2) 'Community organization' means a nonprofit organization that has been in existence
 19 for three years or more and has a verifiable track record of working with the community
 20 surrounding the covered school site on education and other issues.

21 (3) 'Community partner' means a community stakeholder including, but not limited to,
 22 parents, parent organizations, students, student organizations, early learning programs,
 23 businesses, civic engagement organizations, local civic and community based
 24 organizations, local governmental agencies, local school employee organizations, and
 25 institutions of higher education.

26 (4) 'Community school plan' means a plan to implement community school programming
 27 at a school submitted pursuant to Code Section 20-2-642.

28 (5) 'Community school programming' means services, activities, and opportunities
 29 pursuant to Code Section 20-2-642.

30 (6) 'Covered school site' means any school site at which an applicant has proposed or has
 31 been funded to provide community school programming pursuant to a grant.

32 (7) 'Grant' means a Sustainable Community School Operational Grant awarded pursuant
 33 to this article.

34 (8) 'Grantee' means an applicant that has been awarded a grant.

35 (9) 'Lead partner agency' means a 501(c)(3) nonprofit organization constituted to manage
 36 and lead the work of developing and sustaining the community school plan. The lead
 37 partner agency shall serve as the fiscal agent. Reserved.

39 (a) Subject to appropriations, the Department of Education may make grants available to
 40 establish a pilot program to plan, implement, and improve sustainable community schools
 41 for traditional public schools and charter schools. Proposals may be submitted by
 42 applicants provided that each covered school site referenced in the proposal is:

43 (1) A Title I school in improvement, corrective action, or restructuring that is among the
 44 lowest-achieving 15 percent of Title I schools in the state;

45 (2) A secondary school that is eligible for, but does not receive, Title I funds and that is
 46 among the lowest-achieving 15 percent of secondary schools in the state; or

47 (3) A high school that has had a graduation rate as defined in 34 C.F.R. 200.19(b) that
 48 is less than 60 percent over three years.

49 (b)(1) Grants may be awarded to applicants that have demonstrated a need to implement
 50 community school programming but are in need of additional planning to establish or
 51 expand existing programming. Schools that are not ready to implement community
 52 school programming immediately are authorized to use up to one year of their grant funds
 53 for planning purposes. At the end of this period, the school must submit a community
 54 school plan pursuant to Code Section 20-2-642.

55 (2) Applicants that have demonstrated readiness to begin operation of community school
 56 programming, submitted a community school plan pursuant to Code Section 20-2-642,
 57 and made available a list of individuals participating in the implementation of the grant
 58 shall not be required to use the first year of the grant for planning purposes and shall be
 59 authorized to begin implementation immediately upon receipt of the grant award. Such
 60 grants shall supplement, not supplant, existing services and funds.

61 (c) The Department of Education may use a request for proposal process in awarding
 62 grants. Technical assistance, including, but not limited to, grant writing and support for the
 63 design of community school programming, may be made available to applicants.

65 Each applicant shall demonstrate how it will transition to positive discipline practices, more
 66 engaging and relevant curriculum, and transformative parent engagement. In addition, each

67 applicant shall propose to provide specific community school programming at each covered
68 school site during the grant period, which may include, but not be limited to, programming
69 relating to early childhood, academic support, parental involvement and family literacy,
70 community involvement, and other programming designed to meet school and community
71 needs, as defined by the Department of Education. In addition, each applicant shall submit
72 a community school plan as delineated by the Department of Education.

74 (a) Upon award of a grant, a grantee shall hire a resource coordinator to coordinate
75 services at each covered school site. If proposing to serve three or more sites, the grantee
76 may also hire a program director to coordinate activities across covered school sites.
77 Resource coordinators and program directors shall work collaboratively with school
78 leadership and school leadership teams to provide the services and programs that meet
79 school and community needs and priorities.

80 (b) A grantee shall submit quarterly progress reports to the Department of Education
81 regarding implementation of community school programming to include financial status
82 and any other items required by the department.

83 20-2-644.

84 Grant funds awarded pursuant to this article may be used to support any of the following
85 activities:

86 (1) Up to a year of grant funds may be used for planning purposes to create a
87 comprehensive community school plan;

88 (2) Where the grantee has received funding to provide community school programming
89 at multiple covered school sites, selection and compensation of a program director to
90 oversee and coordinate programming across multiple covered school sites;

91 (3) Selection and compensation of a resource coordinator at each covered school site;

92 (4) Ongoing convening and consultation of institutional partners;

93 (5) General coordination of programs within and between covered school sites;

94 (6) Ongoing monitoring of the impact of community school programming on
95 participating children;

96 (7) Development of alternative funding strategies to guarantee the long-term
97 sustainability of the community school;

98 (8) Ongoing operation of the school leadership team; and

99 (9) Other activities, both operational and programmatic, which assist in implementation
100 of the community school plan."
