106 For the purposes of this plan (eagleslanding-dist-sd41-2018):

- 107 (1) The term "VTD" shall mean and describe the same geographical boundaries as
 108 provided in the report of the Bureau of the Census for the United States decennial census
 109 of 2010 for the State of Georgia. The separate numeric designations in a district
 110 description which are underneath a VTD heading shall mean and describe individual
 111 blocks within a VTD as provided in the report of the Bureau of the Census for the United
 112 States decennial census of 2010 for the State of Georgia;
- 113 (2) Except as otherwise provided in the description of any district, whenever the
 114 description of any district refers to a named city, it shall mean the geographical
 115 boundaries of that city as shown on the census maps for the United States decennial
 116 census of 2010 for the State of Georgia;
- 117 (3) Any part of the City of Eagle's Landing which is not included in any district
 118 described in this plan (eagleslanding-dist-sd41-2018) shall be included within that district
 119 contiguous to such part which contains the least population according to the United States
 120 decennial census of 2010 for the State of Georgia; and
- 121 (4) Any part of the City of Eagle's Landing which is described in this plan
 122 (eagleslanding-dist-sd41-2018) as being included in a particular district shall nevertheless
 123 not be included within such district if such part is not contiguous to such district. Such
 124 noncontiguous part shall instead be included within that district contiguous to such part
 125 which contains the least population according to the United States decennial census
 126 of 2010 for the State of Georgia.
