## A RESOLUTION

1 Recognizing and commending Joseph Kelly McCutchen III on his outstanding public  
2 service; and for other purposes.

3 WHEREAS, Joseph Kelly McCutchen III has long been recognized by the citizens of this  
4 state for the vital role that he has played in leadership and his deep personal commitment to  
5 the welfare of the citizens of Georgia; and

6 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,  
7 talents, and energy toward the betterment of his community and state as evidenced  
8 dramatically by his superlative service with the Georgia Public Policy Foundation since  
9 1993; and

10 WHEREAS, Kelly has served with honor and distinction as both the executive vice president  
11 and president and CEO of the Georgia Public Policy Foundation, as chairman of the  
12 foundation's board of trustees, and as part of the think tank's network of Senior Fellows; and

13 WHEREAS, Kelly's significant organizational and leadership talents, his remarkable patience  
14 and diplomacy, his keen sense of vision, and his sensitivity to the needs of the citizens of this  
15 state have earned him the respect and admiration of his colleagues and associates; and

16 WHEREAS, he is the executive director of the High Impact Network of Responsible  
17 Innovators and previously served as the board's chairman for ten years; was a member of the  
18 Leadership Georgia Class of 2001; served on the boards of Leadership Georgia, the Georgia  
19 Tech Alumni Association, and the Conservative Policy Leadership Institute; was a founder  
20 and governing board chair of Tech High; co-founded the Georgia Warrior Alliance; served  
21 on the board of the Georgia Chamber of Commerce; and is a policy adviser for the  
22 Technology Association of Georgia; and

23 WHEREAS, he is a person of magnanimous strengths with an unimpeachable reputation for  
24 integrity, intelligence, fairness, and kindness; and

25 WHEREAS, his vision and unyielding commitment to the education, tax, health care, and  
26 economic policies of his community and the State of Georgia as a whole have set the  
27 standard for public service; and

28 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
29 remarkable and distinguished Georgian be appropriately recognized.

30 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
31 the members of this body recognize and commend Joseph Kelly McCutchen III for his  
32 efficient, effective, unselfish, and dedicated public service to the State of Georgia and extend
