

## Senate Resolution 866

## A RESOLUTION

1 Recognizing Mr. John D. Stephens and dedicating a road in his honor; and for other  
2 purposes.

3 WHEREAS, Mr. John D. Stephens may be best known for his long and accomplished career  
4 in construction, real estate, banking, and waste management, but he has also made his  
5 mark on the civic community of the Atlanta region; and

6 WHEREAS, in 2000, a lifetime in the contracting business led Mr. Stephens to take on what  
7 may be his legacy project - the construction of the fifth runway of the world's busiest airport  
8 at Hartsfield-Jackson International Airport; and

9 WHEREAS, needing 17 million cubic yards of fill to build up the runway, he and his three  
10 sons, Mike, Mark, and Mitch, formed Stephens MDS LP and acquired 485 acres of property  
11 adjacent to the airport; and

12 WHEREAS, to complete this mammoth project, the company built a four-mile overland  
13 conveyor system that crossed streams and interstate highways and, over a two-year period,  
14 moved enough dirt and rock to fill the Georgia Dome six times; and

15 WHEREAS, the conveyor system was reliable and cost efficient and hailed for limiting the  
16 project's impact on the environment; and

17 WHEREAS, as that project neared completion, Mr. Stephens recognized that the residential  
18 and commercial development trends in the region would produce a demand for a sustainable  
19 waste management facility, so he opened a construction and demolition disposal facility on  
20 the very land from which he borrowed fill for the runway project; and

21 WHEREAS, by 2005, Mr. Stephens had organized Stephens Rock and Dirt, Inc., an on-site  
22 recycling operation that accepts soil, concrete, and other inert materials which are processed  
23 and resold as raw materials, thereby preserving precious landfill space; and

24 WHEREAS, Stephens MDS continues to provide dirt and aggregate rock fill to the City of  
25 Atlanta for ongoing construction at the world's busiest airport, Hartsfield-Jackson  
26 International Airport; and

27 WHEREAS, his leadership and guidance have been instrumental to numerous organizations,  
28 including on the Board of Trustees of Georgia Gwinnett College, the Board of Directors of  
29 the Gwinnett County Chamber of Commerce, the Georgia Utility Contractors Association,  
30 and the Georgia Board of Industry, Trade, and Tourism; and

31 WHEREAS, he has been recognized with numerous honors and accolades, including the  
32 Citizen of the Year Award in 2006, the Gwinnett Clean and Beautiful Environmental Legacy  
33 Award in 2007, and the naming of the Gwinnett County Chamber of Commerce's Education  
34 Center in his honor; and

35 WHEREAS, Mr. Stephens and his wife, Beverly, reside in Snellville, Georgia, where they  
36 enjoy their five children and nine grandchildren and are active supporters of many charitable  
37 causes, including the American Heart Association, American Cancer Society, Boy Scouts of  
38 America, Hi-Hope Service Center in Lawrenceville, and Gwinnett Children's Shelter; and

39 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
40 Georgian be recognized appropriately by dedicating a road in his honor.

41 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL  
42 ASSEMBLY OF GEORGIA that the portion of GA 123 from State Route 10/US 78 to GA  
43 316 in Gwinnett County is dedicated as the John D. Stephens Highway.

44 BE IT FURTHER RESOLVED that the Department of Transportation is authorized and  
45 directed to erect and maintain appropriate signs dedicating the John D. Stephens Highway.

46 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed  
47 to make appropriate copies of this resolution available for distribution to  
48 Mr. John D. Stephens and to the Department of Transportation.
