## A RESOLUTION

1 Recognizing March 12, 2018, as Jack Murphy Day at the state capitol; and for other  
2 purposes.

3 WHEREAS Jack Murphy has long been recognized by the citizens of Cumming and Forsyth  
4 County for the vital role that he has played in leadership and his deep personal commitment  
5 to the welfare of the citizens of Georgia; and

6 WHEREAS, he resides in Cumming, Georgia, with his wife Linda and is the proud father of  
7 seven children and grandfather of eleven grandchildren; and

8 WHEREAS, he attended the University of Delaware and served four years in the United  
9 States Air Force; and

10 WHEREAS, he has been a very successful businessman, having served as vice president of  
11 the central region for Orkin Pest Control and having founded Radar Exterminating Company;

13 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,  
14 talents, and energy toward the betterment of his community and state as evidenced  
15 dramatically by his many years of superlative service as chairman of the Cumming-Forsyth  
16 Chamber of Commerce; president of the South Forsyth Rotary Club; and board member on  
17 the Atlanta Chamber of Commerce Board of Directors and the Georgia Chamber of  
18 Commerce Board of Directors; and

19 WHEREAS, he also has served on the advisory board for Wachovia Bank and the Regional  
20 Business Coalition Policy Board and is a graduate of the Leadership Forsyth; and

21 WHEREAS, he has long been an active member of the Episcopal Church of the Holy Spirit  
22 in Cumming, Georgia; and

23 WHEREAS, he was elected to the Georgia House of Representatives in 2002 where he  
24 served until he was elected to the Georgia Senate in 2006; and

25 WHEREAS, his combined 12 years of service in the Georgia General Assembly were of  
26 great and lasting benefit to the citizens of his area, as well as the citizens of the State of  
27 Georgia; and

28 WHEREAS, his significant organizational and leadership talents, his remarkable patience  
29 and diplomacy, his keen sense of vision, and his sensitivity to the needs of the citizens of his  
30 community have earned him the respect and admiration of his colleagues and associates; and

31 WHEREAS, he is a person of magnanimous strengths with an unimpeachable reputation for  
32 integrity, intelligence, fairness, and kindness; and

33 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
34 remarkable and distinguished Georgian be appropriately recognized.

35 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
36 recognize March 12, 2018, as Jack Murphy Day at the state capitol in honor of his many
