## ADOPTED SENATE

## A RESOLUTION

- 1 Creating the Senate Study Committee on Evaluating the School Year Calendar of Georgia
- 2 Public Schools; and for other purposes.
- 3 WHEREAS, the tourism industry is a critical component of Georgia's economic
- 4 competitiveness as a state; and
- 5 WHEREAS, the Georgia travel and hospitality industry is the state's fifth largest employer;
- 6 and
- 7 WHEREAS, the travel and hospitality industry supports more than 445,000 jobs for
- 8 Georgians; and
- 9 WHEREAS, the travel industry has a total annual economic impact of \$60.8 billion to the
- 10 State of Georgia; and
- WHEREAS, travel industry companies directly and indirectly generate over \$3.1 billion in
- 12 tax revenue for the State of Georgia and local communities; and
- 13 WHEREAS, the summer travel season is a prime revenue generator for the industry; and
- 14 WHEREAS, many tourism and hospitality companies hire full and part-time summer
- 15 workers from Georgia high schools and colleges and provide them with valuable
- 16 employment experience; and
- 17 WHEREAS, varied school start dates affect both employment and visitation opportunities;
- 18 and
- 19 WHEREAS, the General Assembly needs to fully review and study the issue of varied school
- 20 start dates to determine its economic impact to the travel and hospitality industry.

- 21 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:
- 22 (1) **Creation of Senate study committee.** There is created the Senate Study Committee
- on Evaluating the School Year Calendar of Georgia Public Schools.
- 24 (2) **Members and officers.** The committee shall be composed of 11 members as
- 25 follows:
- 26 (A) The chairperson of the Senate Economic Development and Tourism Committee;
- 27 (B) The chairperson of the Senate Education and Youth Committee;
- 28 (C) The chairperson of the Senate Appropriations Committee;
- 29 (D) One senator and one citizen member appointed by the President of the Senate;
- 30 (E) One member appointed by the Governor;
- 31 (F) One member of the State Board of Education;
- 32 (G) The deputy commissioner of tourism for the Georgia Department of Economic
- 33 Development;
- 34 (H) The president and chief executive officer of the Georgia Chamber of Commerce
- or his or her designee;
- 36 (I) The director of the Georgia Travel Association; and
- 37 (J) The executive director of the Georgia Association of Convention and Visitors
- 38 Bureaus.
- 39 The chairperson of the Senate Economic Development Committee shall serve as
- 40 chairperson of the committee.
- 41 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,
- issues, and problems mentioned above or related thereto and recommend any action or
- legislation which the committee deems necessary or appropriate.
- 44 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee
- may conduct such meetings at such places and at such times as it may deem necessary or
- 46 convenient to enable it to exercise fully and effectively its powers, perform its duties, and
- accomplish the objectives and purposes of this resolution.
- 48 (5) Allowances, expenses, and funding.
- 49 (A) The legislative members of the committee shall receive the allowances provided
- for in Code Section 28-1-8 of the Official Code of Georgia Annotated.
- (B) Members of the committee who are state officials, other than legislative members,
- or state employees shall receive no compensation for their services on the committee,
- but they may be reimbursed for expenses incurred by them in the performance of their
- duties as members of the committee in the same manner as they are reimbursed for
- expenses in their capacities as state officials or employees.
- 56 (C) Members of the committee who are not legislators, state officials, or state
- 57 employees shall receive a daily expense allowance in an amount the same as that

specified in subsection (b) of Code Section 45-7-21 of the Official Code of Georgia Annotated, as well as the mileage or transportation allowance authorized for state employees.

(D) The allowances and expenses authorized by this resolution shall not be received by any member of the committee for more than five days unless additional days are authorized. Funds necessary to carry out the provisions of this resolution shall come from funds appropriated to the Senate; except that funds for the reimbursement of the expenses of state officials, other than legislative members, and state employees shall come from funds appropriated to or otherwise available to their respective agencies.

## (6) **Report.**

- (A) In the event the committee adopts any specific findings or recommendations that include suggestions for proposed legislation, the chairperson shall file a report of the same prior to the date of abolishment specified in this resolution, subject to subparagraph (C) of this paragraph.
- (B) In the event the committee adopts a report that does not include suggestions for proposed legislation, the chairperson shall file the report, subject to subparagraph (C) of this paragraph.
- (C) No report shall be filed unless the same has been approved prior to the date of abolishment specified in this resolution by majority vote of a quorum of the committee.A report so approved shall be signed by the chairperson of the committee and filed with
- the Secretary of the Senate.(D) In the absence of an approved report, the chairperson may file with the Secretary of the Senate copies of the minutes of the meetings of the committee in lieu thereof.
- (7) **Abolishment.** The committee shall stand abolished on December 1, 2018.
