A RESOLUTION

- 1 Naming the forthcoming new state appellate judicial complex the "Nathan Deal Judicial
- 2 Center"; and for other purposes.
- 3 WHEREAS, Governor Nathan Deal has served honorably and excellently as the highest
- 4 executive officer of the State of Georgia since 2011; and
- 5 WHEREAS, Governor Deal will take his place among the state's greatest governors when
- 6 his final term of office ends in January of 2019; and
- 7 WHEREAS, this 2018 special session of the General Assembly of Georgia thus offers an
- 8 appropriate opportunity to reflect upon the Governor's singular and significant contributions
- 9 to his state and her citizens and to honor those contributions; and
- 10 WHEREAS, after graduating with undergraduate and law degrees from Mercer University,
- 11 he began a lifetime of public service in the United States Army at Fort Gordon in Augusta;
- 12 and
- 13 WHEREAS, thereafter, he started a private law practice in Gainesville, then again entered
- 14 into public service, first as a prosecutor, then moving onward and upward to judge, State
- 15 Senator, and Representative of Georgia's Ninth Congressional District in the United States
- 16 House of Representatives; and
- 17 WHEREAS, during his current tenure as Georgia's eighty-second Governor, he guided the
- state through the throes of difficult financial times, grew local small businesses, attracted top
- 19 corporations from around the globe, produced consistently balanced budgets, maintained
- 20 Georgia's AAA bond rating, increased the state's "rainy day" reserve fund to more than
- \$2.5 billion, implemented investment in the state's transportation system, and effectuated
- 22 criminal and educational reforms; and

23 WHEREAS, the State of Georgia consequently enjoys a robust business climate and

- 24 economy that make possible the construction of a new state appellate judicial complex
- worthy of the state's top judges and justices; and
- 26 WHEREAS, it therefore is proper and appropriate to honor Governor Nathan Deal's lifetime
- 27 of public service and dedication to the State of Georgia by naming after him the new home
- and symbol of justice in the state.
- 29 NOW, THEREFORE, BE IT RESOLVED BY THE GENERAL ASSEMBLY OF
- 30 GEORGIA that the new state appellate judicial complex, to be completed in 2019, be forever
- 31 designated and known as the "Nathan Deal Judicial Center."
- 32 BE IT FURTHER RESOLVED that the Legislative Fiscal Officer, under direction of the
- 33 Speaker of the House and the President Pro Tempore of the Senate, is authorized and directed
- 34 to procure and provide for the placement of any and all signs and markings as may be
- 35 determined appropriate by such officers to so designate the building.
- 36 BE IT FURTHER RESOLVED that the Clerk of the House of Representatives is authorized
- 37 and directed to make appropriate copies of this resolution available for distribution to
- 38 Governor Nathan Deal and to the public and the press.
