The House Committee on Retirement offers the following substitute to HB 196:

## A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 1 of Chapter 1 of Title 47 of the Official Code of Georgia Annotated,
- 2 relating to general provisions relative to retirement and pensions, so as to require each public
- 3 retirement system trustee to complete appropriate education applicable to his or her fiduciary
- 4 duties and obligations under the public retirement system; to provide for definitions; to
- 5 provide for removal of trustees who fail to obtain such education; to provide for related
- 6 matters; to repeal conflicting laws; and for other purposes.

## 7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 Article 1 of Chapter 1 of Title 47 of the Official Code of Georgia Annotated, relating to
- 10 general provisions relative to retirement and pensions, is amended by adding a new Code
- 11 section to read as follows:
- 12 "<u>47-1-17.</u>
- 13 (a) As used in this Code section, the term:
- (1) 'Public retirement system' means any retirement or pension system now or hereafter
- created by or pursuant to the authority of Georgia law or the Constitution of Georgia
- which has public employees as members of the retirement or pension system.
- 17 (2) 'Public retirement system trustee' means a member of a board of trustees or other
- 18 <u>administrative body or agency charged with the duty of administering a public retirement</u>
- 19 <u>system.</u>
- 20 (b)(1) Each public retirement system trustee shall complete appropriate education
- 21 <u>applicable to his or her fiduciary duties and obligations under the public retirement</u>
- 22 <u>system.</u>
- 23 (2) Each public retirement system trustee first appointed or elected on or after July 1,
- 24 <u>2019</u>, shall complete a minimum of eight hours of education designated to orient new
- 25 <u>public retirement system trustees in the areas described in this Code section within one</u>
- 26 <u>year of becoming a new public retirement system trustee. If such a trustee fails to</u>

27 <u>complete such requirement within 14 months, he or she shall be removed from his or her</u>

- 28 <u>position as a trustee.</u>
- 29 (3) Each public retirement system trustee who was appointed or elected prior to
- 30 <u>July 1, 2019, or who has served one or more years as a public retirement system trustee</u>
- 31 <u>shall complete a minimum of 12 hours of continuing education every two years in the</u>
- 32 <u>areas described in this Code section. If such a trustee fails to complete such requirement</u>
- within 26 months, he or she shall be removed from his or her position as such trustee.
- 34 (c) Applicable education shall include education and training in the following areas:
- 35 (1) Laws applicable to public retirement systems, which may include federal and state
- 36 <u>laws applicable to specific public retirement systems, laws applicable to public retirement</u>
- 37 <u>system trustees, the applicable common law duties of trustees listed in Title 53, and laws</u>
- related to open meetings and open records;
- 39 (2) Roles, duties, and responsibilities of public retirement system trustees;
- 40 (3) Ethics and conflicts of interest;
- 41 (4) Governance, administration, and funding of public retirement systems;
- 42 (5) Investments; investment management, portfolios, and strategies; and measurements
- 43 <u>of performance; and</u>
- 44 (6) Audit and actuarial principles and methods related to public retirement systems.
- 45 (d) Applicable education may include:
- 46 (1) Seminars, conferences, or schools sponsored by educational institutions or
- 47 <u>professional organizations;</u>
- 48 (2) Online continuing education coursework;
- 49 (3) Continuing education received at any public retirement system meeting; or
- 50 (4) Any other continuing education approved by the public retirement system.
- 51 (e) Each public retirement system shall maintain a record of its public retirement system
- 52 <u>trustee education.</u>"
