**AS PASSED**

**A BILL TO BE ENTITLED**

**AN ACT**

1 To amend an Act providing for the membership of the Toombs County Development  
2 Authority, approved March 2, 1990 (Ga. L. 1990, p. 3640), which authority was created  
3 pursuant to an amendment to the Constitution as contained in Ga. L. 1966, p. 787, and  
4 continued by an Act approved March 20, 1985 (Ga. L. 1985, p. 3962), so as to provide for  
5 the qualifications of members of said authority; to provide for terms of certain members of  
6 District No. 2 of the authority; to provide for related matters; to repeal conflicting laws; and  
7 for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act providing for the membership of the Toombs County Development Authority,  
11 approved March 2, 1990 (Ga. L. 1990, p. 3640), which authority was created pursuant to an  
12 amendment to the Constitution as contained in Ga. L. 1966, p. 787, and continued by an Act  
13 approved March 20, 1985 (Ga. L. 1985, p. 3962), is amended by revising subsection (c) of  
14 Section 2 as follows:

15 "(c)(1) Four members of the authority shall each be residents of Toombs County and hold  
16 at least one of the following qualifications:

17 (A) Reside in Authority District No. 1;

18 (B) Hold an ownership interest of at least 20 percent in a business located in Authority  
19 District No. 1; or

20 (C) Be employed as the primary manager of a business located in Authority District  
21 No. 1.

22 (2) Two members of the authority shall each be residents of Toombs County and hold  
23 at least one of the following qualifications:

24 (A) Reside in Authority District No. 2;

25 (B) Hold an ownership interest of at least 20 percent in a business located in Authority  
26 District No. 2; or

- 27 (C) Be employed as the primary manager of a business located in Authority District  
28 No. 2.
- 29 (3) One member of the authority shall be a resident of Toombs County and hold at least  
30 one of the following qualifications:
- 31 (A) Reside in Authority District No. 3;
- 32 (B) Hold an ownership interest of at least 20 percent in a business located in Authority  
33 District No. 3; or
- 34 (C) Be employed as the primary manager of a business located in Authority District  
35 No. 3.
- 36 (4) Members of the authority appointed pursuant to this Act shall be appointed for terms  
37 of five years. Members of the authority serving as of the effective date of this Act, or any  
38 successors appointed to fill vacancies on the authority thereafter, shall continue to serve  
39 for the duration of their unexpired terms, provided that the current term of Authority  
40 District No. 2 representative John Robison or his successor prior to December 31, 2021,  
41 shall end on December 31, 2021."

**SECTION 2.**

43 All laws and parts of laws in conflict with this Act are repealed.
