

Senator Gooch of the 51st offered the following amendment:

1 *Amend House Substitute to SB 2 (LC 36 4028ERS) by deleting lines 8 and 9 and inserting*

 4 over compliance with the cross-subsidization prohibitions and to provide for expedited
 5 adjudication of any complaints related thereto; to provide

7 (5) Develop and maintain a cost allocation manual, to be filed with the commission,
 8 describing the electric membership corporation's methods of cost allocation and such
 9 other information and policies reasonably required to ensure compliance with this article.

10 Such manual shall:

11 (A) Establish rules for the pricing of transactions between an electric membership
 12 corporation and its gas affiliates and broadband affiliates, as applicable, including the
 13 transfer of assets between such electric membership corporation and its gas affiliates
 14 and broadband affiliates;

15 (B) Require the electric membership corporation and its gas affiliates and broadband
 16 affiliates, as applicable, to maintain separate books of accounts and records which shall
 17 be subject to inspection to confirm compliance with this article and the cost allocation
 18 manual; and

19 (C) Require that all services that an electric membership corporation provides to its gas
 20 affiliates and broadband affiliates, as applicable, be provided at the same rate and on
 21 the same terms and conditions as any other retail customer or communications service
 22 provider. Any such services provided to any communications service provider shall be
 23 on a strictly confidential basis, such that the electric membership corporation does not
 24 share information regarding any communications service provider with any other
 25 communications service provider, including a broadband affiliate.

26 (c) The commission shall have jurisdiction over the compliance of each electric
 27 membership corporation and broadband affiliate within the provisions of this Code section.
 28 The commission shall provide for an expedited adjudication of any complaint as to a failure
 29 to comply with this Code section and may engage an administrative law judge for purposes
 30 of such adjudication.
