

ADOPTED

Senators Gooch of the 51st, Hufstetler of the 52nd and Henson of the 41st offered the following amendment:

1 *Amend the Senate Committee on Finance substitute to HB 365 (LC 43 1357ERS) by*
 2 *replacing lines 2 through 166 with the following:*

3 taxation, so as to exempt certain sales of transportation from sales and use tax; to levy an
 4 excise tax on certain sales of transportation; to provide for related matters; to provide for an
 5 effective date and applicability; to repeal conflicting laws; and for other purposes.

6 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

SECTION 1.

7
 8 Title 48 of the Official Code of Georgia Annotated, relating to revenue and taxation, is
 9 amended in Code Section 48-8-3, relating to exemptions from sales and use taxes, by
 10 revising paragraph (25) as follows:

11 "(25) ~~Reserved~~ Transportation that is subject to the tax imposed by Article 8 of
 12 Chapter 13 of this title;"

SECTION 2.

13
 14 Said title is further amended by adding a new article to Chapter 13, relating to specific,
 15 business, and occupation taxes, to read as follows:

"ARTICLE 8

 17 48-13-140.

18 As used in this article, the term:

19 (1) 'For-hire ground transport service provider' means a limousine carrier, ride share
 20 network service, taxi service, and transportation referral service as such terms are defined
 21 in Code Section 40-1-190.

22 (2) 'For-hire ground transport trip' means a completed journey by vehicle provided by
 23 a for-hire ground transport service provider or any request for such journey for which a
 24 customer is charged, whether completed or not.

25 (3) 'Shared for-hire ground transport trip' means any journey in which an individual is
 26 matched with, or eligible to be matched with, another individual by a for-hire ground
 27 transport service provider for a for-hire ground transport trip.

29 Pursuant to the authority granted by Article IX, Section II, Paragraph VI of the Constitution
30 of this state, there are created within this state 159 special districts. The geographical
31 boundary of each county shall correspond with and shall be conterminous with the
32 geographical boundary of one of the 159 special districts.

33 48-13-142.

34 On and after January 1, 2020, an excise tax in the amount of 50¢ shall be levied upon any
35 for-hire ground transport trip and 25¢ upon any shared for-hire ground transport trip. Such
36 excise tax shall be collected and remitted by the for-hire ground transport service provider
37 itself and not the vehicle driver. Such excise tax shall be due and payable in the same
38 manner as would otherwise be required under Article 1 of Chapter 8 of this title.

41 Any for-hire ground transport service provider that knowingly and willfully violates the
42 requirements of this article shall be assessed a civil penalty of not more than \$10,000.00
43 in addition to the amount of tax due.

44 48-13-144.

45 The department shall be authorized to adopt rules and regulations necessary for the
46 enforcement and implementation of the provisions of this article."

47 **SECTION 3.**

48 This Act shall become effective on January 1, 2020, and shall apply to all sales occurring on
49 or after January 1, 2020.
