5 of the citizens of Georgia; and

19 times; she also served as secretary and treasurer of the Safety Net Hospital Coalition of

22 integrity, intelligence, fairness, and kindness; and

23 WHEREAS, Linda has served with honor and distinction with Northeast Georgia Health  
24 System, and her vision and unyielding commitment will be sorely missed upon the occasion  
25 of her retirement; and

26 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this  
27 remarkable and distinguished Georgian be appropriately recognized.
