A BILL TO BE ENTITLED
AN ACT

1 To amend Article 7 of Chapter 4 of Title 49 and Title 33 of the Official Code of Georgia
2 Annotated, relating to medical assistance and insurance, respectively, so as to replace
3 provisions relating to submission of a Section 1115 waiver request to the federal government
4 with a state plan amendment to authorize Medicaid expansion; to revise provisions relating
5 to submission of a Section 1332 innovation waiver proposal to the federal government; to
6 require a state innovation waiver submission to include specific protections and coverage;
7 to provide for related matters; to provide for an effective date; to repeal conflicting laws; and
8 for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 style="text-align:center">**SECTION 1.**

11 Article 7 of Chapter 4 of Title 49 of the Official Code of Georgia Annotated, relating to
12 medical assistance generally, is amended by revising Code Section 49-4-142.3, relating to
13 waiver request to federal government on income threshold for Medicare and Medicaid
14 services, as follows:

15 "49-4-142.3.

16 The department shall be authorized to submit a ~~waiver request~~ Medicaid state plan
17 amendment, on or before June 30, 2020, to the United States Department of Health and
18 Human Services Centers for Medicare and Medicaid Services ~~pursuant to Section 1115 of~~
19 ~~the federal Social Security Act~~, which ~~may~~ shall include an increase in the income
20 threshold up to a maximum of ~~100~~ 138 percent of the federal poverty level. It is the intent
21 of the General Assembly that appropriations shall be authorized for the purposes of
22 obtaining federal financial participation for medical assistance payments to providers on
23 behalf of Medicaid recipients pursuant to this article and funding the state's portion of the
24 cost to expand the Medicaid program under the federal Patient Protection and Affordable
25 Care Act, Public Law 111-148, as amended by the federal Health Care and Education
26 Reconciliation Act of 2010, Public Law 111-152, and any regulations or guidelines issued

27 under such acts. ~~Further, upon approval of the waiver, the~~ The department shall be
 28 authorized to take all necessary steps to implement the terms and conditions of the waiver
 29 without any further legislative action."

SECTION 2.

31 Chapter 1 of Title 33 of the Official Code of Georgia Annotated, relating to general
 32 provisions regarding insurance, is amended by revising Code Section 33-1-26, relating to the
 33 Governor's request for waiver from federal Patient Protection and Affordable Care Act and
 34 expiration of authority, as follows:

35 "33-1-26.

36 (a) The Governor is hereby authorized to submit one or more applications to the United
 37 States Secretaries of Health and Human Services and the Treasury for waiver of applicable
 38 provisions of the federal Patient Protection and Affordable Care Act (P. L. 111-148) under
 39 Section 1332 with respect to health insurance coverage or health insurance products. Any
 40 such submission to obtain a state innovation waiver ~~may include multiple waiver~~
 41 ~~submissions shall:~~

42 (1) Preserve consumer protections;

43 (2) Maintain comprehensive, quality health coverage; and

44 (3) Prevent increases in out-of-pocket health spending by consumers whose incomes are
 45 between 100 and 400 percent of the federal poverty level.

46 On or after January 1, 2020, upon approval of one or more waivers, the state is authorized
 47 to implement such waiver or waivers as provided under Section 1332 of such federal act
 48 in a manner consistent with state and federal law.

49 (b) The authority granted to the Governor in subsection (a) of this Code section to submit
 50 one or more applications shall expire on December 31, 2021."

SECTION 3.

52 This Act shall become effective upon its approval by the Governor or upon its becoming law
 53 without such approval.

SECTION 4.

55 All laws and parts of laws in conflict with this Act are repealed.
