

The Senate Committee on Rules offered the following substitute to SR 193:

#### A RESOLUTION

1 Creating the Senate Study Committee on Transferring Oversight of Developmental  
2 Disabilities to the Department of Community Health; and for other purposes.

3 WHEREAS, developmental disability services are currently provided through the  
4 Department of Behavioral Health and Developmental Disabilities; and

5 WHEREAS, the Department of Community Health is the sole agency which receives federal  
6 Medicaid funds for Georgia; and

7 WHEREAS, the Department of Community Health contracts with the Department of  
8 Behavioral Health and Developmental Disabilities to provide developmental disabilities  
9 services under Medicaid; and

10 WHEREAS, it would be beneficial to streamline these services and to minimize duplicative  
11 oversight and administrative costs; and

12 WHEREAS, to such ends, it would be prudent to formulate a transition plan to transfer the  
13 Division of Developmental Disabilities from the Department of Behavioral Health and  
14 Developmental Disabilities to the Department of Community Health effective July 1, 2021,  
15 including conducting an analysis by the Department of Audits and Accounts to identify and  
16 implement best practices in areas including, but not limited to, automatic recertification of  
17 waiver recipients, case management reform models, targeted case management reviews for  
18 individuals who have been deinstitutionalized or recommended for services, use of national  
19 accreditation for service providers, and review of contracted services for quality assurance,  
20 delivery of developmental disability services, and other services.

21 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:

22 (1) **Creation of Senate study committee.** There is created the Senate Study Committee  
23 on Transferring Oversight of Developmental Disabilities to the Department of  
24 Community Health.

25 (2) **Members and officers.** The committee shall be composed of five members of the  
26 Senate to be appointed by the President of the Senate. The President shall designate a  
27 legislative member of the committee as chairperson of the committee.

28 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,  
29 issues, and problems mentioned above or related thereto and recommend any action or  
30 legislation which the committee deems necessary or appropriate.

31 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee  
32 may conduct such meetings at such places and at such times as it may deem necessary or  
33 convenient to enable it to exercise fully and effectively its powers, perform its duties, and  
34 accomplish the objectives and purposes of this resolution.

35 (5) **Allowances and funding.**

36 The legislative members of the committee shall receive the allowances provided for in  
37 Code Section 28-1-8 of the Official Code of Georgia Annotated. The allowances  
38 authorized by this resolution shall not be received by any member of the committee for  
39 more than five days unless additional days are authorized. Funds necessary to carry out  
40 the provisions of this resolution shall come from funds appropriated to the Senate.

41 (6) **Report.**

42 (A) In the event the committee adopts any specific findings or recommendations that  
43 include suggestions for proposed legislation, the chairperson shall file a report of the  
44 same prior to the date of abolishment specified in this resolution, subject to  
45 subparagraph (C) of this paragraph.

46 (B) In the event the committee adopts a report that does not include suggestions for  
47 proposed legislation, the chairperson shall file the report, subject to subparagraph (C)  
48 of this paragraph.

49 (C) No report shall be filed unless the same has been approved prior to the date of  
50 abolishment specified in this resolution by majority vote of a quorum of the committee.  
51 A report so approved shall be signed by the chairperson of the committee and filed with  
52 the Secretary of the Senate.

53 (D) In the absence of an approved report, the chairperson may file with the Secretary  
54 of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.

55 (7) **Abolishment.** The committee shall stand abolished on December 1, 2020.
