

The Senate Committee on Transportation offered the following substitute to HR 1163:

#### A RESOLUTION

1 Dedicating certain portions of the state highway system; to provide for an effective date; to  
2 repeal conflicting laws; and for other purposes.

#### 3 **PART I**

4 WHEREAS, Justice Robert Benham has long been recognized by the citizens of this state  
5 for the vital role that he has played in the justice system; and

6 WHEREAS, Justice Benham earned his bachelor's degree in political science from Tuskegee  
7 University in 1967, his Juris Doctorate from the University of Georgia in 1970, and his  
8 Master of Law from the University of Virginia in 1989; and

9 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United  
10 States Army Reserve, valiantly and courageously protecting his fellow Americans and  
11 attaining the rank of captain; and

12 WHEREAS, in 1989, Justice Benham made history as the first African American appointed  
13 to the Georgia Supreme Court in its more than 140 years of existence and, upon his  
14 retirement, holds the honorable distinction of being the longest serving member of the court;  
15 and

16 WHEREAS, he served as chief justice from 1995 to 2001, and during his career on the  
17 bench, he earned a reputation as a clear thinker and hard worker, as a man whose strong  
18 convictions were supported by meticulous research and careful consideration, and as an  
19 equitable, impartial leader whose decisions were governed by the rules of honesty and fair  
20 play; and

21 WHEREAS, Justice Benham's leadership and wisdom have been instrumental to numerous  
22 organizations, as he was president of the Bartow County Bar Association, a chairperson of  
23 the Governor's Commission on Drug Awareness and Prevention, and he is currently a

24 member of the American Judicature Society, the National Criminal Justice Association, and  
25 the Georgia Bar Foundation; and

26 WHEREAS, Justice Benham's service on the Georgia Supreme Court is marked by his vision  
27 and unyielding commitment to justice, and it is abundantly fitting and proper that this  
28 remarkable and distinguished Georgian be recognized appropriately by dedicating a bridge  
29 in his honor.

30 **PART II**

31 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law  
32 enforcement officers with the passing of Mr. Al St. Lawrence on November 24, 2015; and

33 WHEREAS, Mr. St. Lawrence was born in Dover, New Hampshire, the beloved son of Mary  
34 Gagne and John Ovid St. Lawrence; and

35 WHEREAS, he enlisted to serve as a guardian of this nation's freedom and liberty with the  
36 United States Air Force in 1952 and was stationed at Hunter Air Force Base; and

37 WHEREAS, Mr. St. Lawrence began his prestigious career in law enforcement in 1959 with  
38 the Chatham County Police Department, where he served in the positions of corporal,  
39 sergeant, lieutenant, captain, and assistant chief of police before his appointment as chief of  
40 police in 1971; and

41 WHEREAS, after 21 years as Chief of Police for Chatham County, Mr. St. Lawrence was  
42 elected as the county sheriff, a position he was reelected to serve in for five additional terms;  
43 and

44 WHEREAS, during his 23 years as sheriff, Mr. St. Lawrence was highly regarded by the  
45 citizens of his community and state and by local government officials as a person of  
46 unquestioned integrity and dedication to the sound principles of law enforcement; and

47 WHEREAS, his leadership and guidance were recognized with numerous awards and  
48 accolades, including the Georgia Association of Chiefs of Police Dr. Curtis  
49 McClung/Motorola Award of Excellence, Georgia Sheriffs' Association Distinguished  
50 Humanitarian Award, and Sheriff's Leadership Award for 50 years of service; and

51 WHEREAS, Mr. St. Lawrence played an instrumental role in many organizations, including  
52 the Georgia Peace Officer Standards and Training Council, Georgia Sheriffs' Association,  
53 National Sheriffs' Association, Georgia Association of Chiefs of Police, Peace Officers'  
54 Association of Georgia, Peace Officers' Annuity and Benefit Fund, and the 200 Club of  
55 Coastal Georgia; and

56 WHEREAS, he is the only law enforcement officer in Georgia to be named both Georgia  
57 Association of Chiefs of Police Outstanding Chief of the Year and a two-time recipient of  
58 Georgia Sheriffs' Association Sheriff of the Year; and

59 WHEREAS, Mr. St. Lawrence exhibited extraordinary devotion to duty, outstanding loyalty,  
60 fine leadership, and meticulous attention to detail in all his duties, and it is abundantly fitting  
61 and proper that this remarkable and distinguished Georgian be recognized appropriately by  
62 dedicating a bridge in his memory.

64 WHEREAS, the State of Georgia celebrates the life and service of one of its finest citizens,  
65 Mr. James "Jimmy" Allen Petrea; and

66 WHEREAS, Mr. Petrea was born in Savannah, Georgia, the beloved son of Thelma Royal  
67 and Jessie Lewis Petrea; and

68 WHEREAS, he enlisted to serve as a guardian of this nation's freedom and liberty with the  
69 United States Navy in 1964 and joined the crew of the *USS Newport News CA 148* Heavy  
70 Cruiser in support of the Operation Sea Dragon and the 1st Marine Division. The mission  
71 was naval shore bombardment along the Ho Chi Minh trail as well as the interception and  
72 destruction of waterborne craft; and

73 WHEREAS, after three years of service in Vietnam and earning the rank of Engineman E5  
74 Petty Officer Second Class, he was honorably discharged, returned home to Savannah, and  
75 joined the Seaboard Coast Line Railroad as a machinist; and

76 WHEREAS, he was elected mayor of Thunderbolt in 1981 and was reelected for multiple  
77 terms until he resigned on December 31, 2005, after over a quarter-century of service to the  
78 town of Thunderbolt and the Coastal Empire; and

79 WHEREAS, during his 24 years as mayor, Mr. Petrea was highly regarded by the citizens  
80 of his community and state and local government officials as a person of unquestioned  
81 integrity and dedication to his community; and

82 WHEREAS, he was active in various veterans and civic organizations including the  
83 American Legion posts 184 and 26, VFW Post 4392, the Chatham Veteran's Council, the  
84 Lions Club, and Masonic Lodge 693; and

85 WHEREAS, Thunderbolt experienced significant growth under Mayor Petrea's leadership  
86 during which he played a key role in the commercial development of the riverfront and the  
87 opening of the current Wilmington River bridge; and

88 WHEREAS, Mr. Petrea exhibited extraordinary devotion to duty, outstanding loyalty, fine  
89 leadership, and meticulous attention to detail in all his duties, and it is abundantly fitting and  
90 proper that this remarkable and distinguished Georgian be recognized appropriately by  
91 dedicating a bridge in his honor.

93 WHEREAS, Mr. Jimmy Burnsed has long been recognized by the citizens of this state for  
94 the vital role that he has played in leadership and his deep personal commitment to the  
95 welfare of the citizens of Bryan County and the State of Georgia; and

96 WHEREAS, Mr. Burnsed has served as a leader of Bryan County both as a public servant  
97 and leader of the business community; and

98 WHEREAS, he began his career in the banking industry after service with the Coast Guard,  
99 learning the trade at Savannah Bank which he saw merge with Georgia Railroad Bank in  
100 Augusta and later became First Union Bank; and

101 WHEREAS, in 1989, he helped organize Bryan Bank and Trust in Richmond Hill, Georgia,  
102 and dedicated 30 years to serving and leading the community until his retirement; and

103 WHEREAS, he has diligently and conscientiously devoted innumerable hours of his time,  
104 talents, and energy toward the betterment of his community and state as evidenced  
105 dramatically by his superlative service for 12 years as Chairman of the Bryan County Board  
106 of Commissioners, six years on the city council for Garden City, and four years as mayor of  
107 Garden City; and

108 WHEREAS, during his tenure of public service to Bryan County, he increased public access  
109 to government meetings and services, partnered with local developers to open a public park,  
110 and helped achieve a homestead exemption tax for county senior citizens; and

111 WHEREAS, Mr. Burnsed's legacy of cooperation, foresight, and dedication to the people of  
112 Bryan County will be evidenced for generations to come in projects such as the extension of  
113 Harris Trail, the Bryan County Administrative Building, and numerous other capital projects;  
114 and

115 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
116 Georgian be recognized appropriately by dedicating a road in his honor.

118 WHEREAS, Mr. Harold Fowler and Mr. Jimmy Burnsed have long been recognized by the  
119 citizens of this state for the vital role that they have played in leadership and their deep  
120 personal commitment to the welfare of the citizens of Bryan County and the State of  
121 Georgia; and

122 WHEREAS, Mr. Harold Fowler dedicated 18 years to the people of Richmond Hill, Georgia,  
123 serving on the city council from 1995 to 2005 and as the city's mayor for two terms  
124 beginning with his election in 2009; and

125 WHEREAS, during Mr. Fowler's tenure as a leader of Richmond Hill, the city annexed  
126 several parcels of valuable commercial property to increase the city's tax digest, purchased  
127 land for much needed commercial development, and laid the foundation for a new city  
128 complex off of Highway 144 with the purchase of over 50 acres; and

129 WHEREAS, Mr. Burnsed served as a leader of Bryan County both as a public servant and  
130 leader of the business community, serving 12 years as Chairman of the Bryan County Board  
131 of Commissioners, six years on the city council for Garden City, and four years as mayor of  
132 Garden City; and

133 WHEREAS, during his tenure of public service to Bryan County, Mr. Burnsed increased  
134 public access to government meetings and services, partnered with local developers to open  
135 a public park, and helped achieve a homestead exemption tax for county senior citizens; and

136 WHEREAS, it is abundantly fitting and proper that the cooperation, foresight, and dedication  
137 to the people of Bryan County demonstrated by Mr. Fowler and Mr. Burnsed be recognized  
138 appropriately by dedicating a bridge in their honor.

144 appointed fire chief in 1979; and

145 WHEREAS, he led the department as chief until 2007, then stayed on with the department  
146 as a firefighter until 2011, exhibiting over three decades of extraordinary devotion to duty,  
147 outstanding loyalty, and fine leadership; and

148 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
149 Georgian be recognized appropriately by dedicating a road in his memory.

151 WHEREAS, our nation's security continues to rely on patriotic men and women who put  
152 their personal lives on hold in order to place themselves in harm's way to protect the  
153 freedoms that all United States citizens cherish; and

154 WHEREAS, Mr. James Oscar Hardigree, Jr., demonstrated a deep personal commitment to  
155 protecting democracy and a willingness to sacrifice his own personal safety and comfort to  
156 ensure the well-being of his fellow man; and

157 WHEREAS, this brave man served as a guardian of this nation's freedom and liberty,  
158 attaining the rank of Technician Fifth Grade (T/5) and valiantly protecting the people and  
159 ideals of the United States during World War II; and

160 WHEREAS, a native of Oconee County, Georgia, T/5 Hardigree made the ultimate sacrifice  
161 for this nation after he was mortally wounded during combat in Italy on May 31, 1944; and

162 WHEREAS, T/5 Hardigree demonstrated selfless service to this nation, and his unyielding  
163 commitment was recognized with a Purple Heart; and

164 WHEREAS, T/5 Hardigree embodied the spirit of service, willing to find meaning in  
165 something greater than himself, and it is abundantly fitting and proper that this remarkable  
166 and distinguished Georgian be recognized appropriately by dedicating a road in his memory.

**PART VIII**

168 WHEREAS, Sergeant Stanley Thomas Bradley was born on October 15, 1946, in  
169 Cartersville, Georgia, the beloved son of Woodrow and Grace Ross Bradley; and

170 WHEREAS, a graduate of Cartersville High School, Sergeant Bradley attended Southern  
171 Technical College, where he earned an associate's degree in civil engineering; and

172 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United  
173 States Army and defended this country with honor and distinction, as a member of the 5th  
174 Mechanized Infantry Division during the Vietnam War; and

175 WHEREAS, Sergeant Bradley paid the ultimate sacrifice after he was mortally wounded  
176 from mortar fire when his unit was sent in as relief for a United States Marine unit that had  
177 come under a large assault by North Vietnamese soldiers; and

178 WHEREAS, Sergeant Bradley demonstrated selfless service to this nation, and his  
179 unyielding commitment to protecting the people and ideals of the United States is an  
180 inspiration to others; and

181 WHEREAS, Sergeant Bradley embodied the spirit of service, willing to find meaning in  
182 something greater than himself, and it is abundantly fitting and proper that this remarkable  
183 and distinguished Georgian be recognized appropriately by dedicating an intersection in his  
184 memory.

186 WHEREAS, the State of Georgia lost one of its finest citizens and most dedicated law  
187 enforcement officers with the passing of Mr. James Edward Giddens on February 11, 1976;  
188 and

189 WHEREAS, Mr. Giddens was born on November 6, 1946, in Nashville, Georgia, the beloved  
190 son of Lucille Boyd and William Howard Giddens; and

191 WHEREAS, Mr. Giddens began his prestigious career in law enforcement as a Lowndes  
192 County deputy sheriff before assuming the role of chief of police for Ray City in 1975; and

193 WHEREAS, his life was tragically cut short when he lost his life in the line of duty while  
194 pulling over the vehicle of a robbery suspect; and

195 WHEREAS, during his years as chief of police, Mr. Giddens was highly regarded by the  
196 citizens of his community and state and by local government officials as a person of  
197 unquestioned integrity and dedication to the sound principles of law enforcement; and

198 WHEREAS, Mr. Giddens exhibited extraordinary devotion to duty, outstanding loyalty, fine  
199 leadership, and meticulous attention to detail in all his duties, and it is abundantly fitting and  
200 proper that this remarkable and distinguished Georgian be recognized appropriately by  
201 dedicating a road in his memory.

203 WHEREAS, Mrs. Blondean Newman has long been recognized by the citizens of this state  
204 for the vital role that she has played in leadership and her deep personal commitment to the  
205 welfare of the citizens of Georgia; and

206 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,  
207 talents, and energy toward the betterment of her community and state as evidenced  
208 dramatically by her superlative service with Bryan County; and

209 WHEREAS, a native of Bryan County, Mrs. Newman served as county tax commissioner  
210 for 30 years and after her retirement served as a county commissioner; and

211 WHEREAS, Mrs. Newman's significant organizational and leadership talents, her remarkable  
212 patience and diplomacy, her keen sense of vision, and her sensitivity to the needs of the  
213 citizens of this state have earned her the respect and admiration of her colleagues and  
214 associates; and

215 WHEREAS, she is a person of magnanimous strengths with an unimpeachable reputation for  
216 integrity, intelligence, fairness, and kindness; and

217 WHEREAS, Mrs. Newman served Bryan County with honor and distinction, and her vision  
218 and unyielding commitment set the standard for public service; and

219 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
220 Georgian be recognized appropriately by dedicating a road in her honor.

222 WHEREAS, the Honorable Emma Darnell has long been recognized by the citizens of this  
223 state for the vital role that she played in leadership and her deep personal commitment to the  
224 welfare of the citizens of Fulton County; and

225 WHEREAS, she diligently and conscientiously devoted innumerable hours of her time,  
226 talents, and energy toward the betterment of her community and state as evidenced  
227 dramatically by her nearly 30 years of public service as a Fulton County Commissioner for  
228 District 6; and

229 WHEREAS, Commissioner Darnell's legacy spans three decades of service to Fulton County  
230 with her election in 1992 until her passing in 2019; and

231 WHEREAS, during her tenure with Fulton County, Commissioner Darnell served as a  
232 champion of minorities, seniors, and the poor; and

233 WHEREAS, always passionate and often fiery, Commissioner Darnell played a key role in  
234 helping transition the City of Atlanta from an all-white power structure to a predominately  
235 black City Hall as a member of Mayor Sam Massell's administration; and

236 WHEREAS, she was the founding chair of the Woman's Advisory Council of Atlanta City  
237 Government, which formed in the summer of 1973 after a special report made the now  
238 widely accepted conclusion that discrimination based upon sex and gender does exist; and

239 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
240 Georgian be recognized appropriately by dedicating an interchange in her memory.

241 **PART XII**

242 WHEREAS, Scenic Route 9 in Dawson County, Georgia, was once known as Thunder Road  
243 and was used by moonshine runners to haul liquor to Atlanta; and

244 WHEREAS, Dawsonville, Georgia, is known as the "Moonshine Capital of Georgia"; and

245 WHEREAS, during the Prohibition Era, moonshine was made and sold to buyers in Atlanta  
246 and 'trippers' from Dawsonville made a living by hauling moonshine down Highway 9; and

247 WHEREAS, trippers were known to modify cars to make them faster and out of necessity  
248 to outrun enforcement agents known as 'revenuers' who were tasked with enforcing  
249 prohibition laws; and

250 WHEREAS, driving and engineering skills honed by trippers would eventually evolve into  
251 one of America's favorite pastimes, NASCAR; and

252 WHEREAS, Dawsonville is the hometown for many racing legends, including Lloyd Seay,  
253 Gober Sosebee, Raymond Parks, Roy Hall, Bernard Long, and Red Vogt; and

254 WHEREAS, some of NASCAR's most popular drivers are from Dawsonville, including Bill  
255 and Chase Elliott; and

256 WHEREAS, it is abundantly fitting and proper that a road be dedicated to honor the rich  
257 history and tradition of Thunder Road.

### **PART XIII**

259 WHEREAS, Dr. Randy Valimont spent his life committed to teaching the Gospel, witnessing  
260 Christ through word and deed, and addressing the physical, psychological, intellectual, and  
261 spiritual needs of others; and

262 WHEREAS, a native of Johnson City, New York, Dr. Valimont graduated from Southeastern  
263 University and earned a doctor of religious philosophy degree in 2006 from Logos Graduate  
264 School; and

265 WHEREAS, Dr. Valimont was called by the Lord to lead the congregation of Griffin First  
266 Assembly in Griffin, Georgia, in 1993; and

267 WHEREAS, his vision and direction helped Griffin First Assembly grow in size and  
268 influence, uplifting the community like the light of Bethlehem and serving as a spiritual  
269 leader and place for fellowship; and

270 WHEREAS, under his direction, ministries of Griffin First Assembly led more than 30,000  
271 souls to dedicate their lives to Jesus Christ and the church grew from 450 to 5,200 Sunday  
272 morning worshipers with 243 missionaries and ministries across the globe; and

273 WHEREAS, Dr. Valimont was instrumental in the success of the church's radio and  
274 television ministry, Fresh Touch Media Ministries; and

275 WHEREAS, whether the task was preparing a sermon, visiting the sick, counseling the  
276 troubled, baptizing a new believer, or acting as a theologian, educator, administrator, or  
277 humanitarian, Dr. Valimont served as a shining example of God's righteous path; and

278 WHEREAS, the unmatched spiritual assistance offered by Dr. Valimont was a source of  
279 strength and direction for persons in all walks of life and from all economic strata; and

280 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
281 Georgian be recognized appropriately by dedicating a road in his memory.

283 WHEREAS, the State of Georgia continues to mourn the loss of one of its most distinguished  
284 citizens with the passing of Sheriff Van Peavy on January 6, 2015; and

285 WHEREAS, Sheriff Peavy was interested in law enforcement from the time of his discharge  
286 from the United States Army, and he ran for Sheriff in 1984 and took office on January 1,  
287 1985; and

288 WHEREAS, taking over a department that consisted of the Sheriff, two deputies, four  
289 dispatchers who doubled as jailers, and one part-time deputy who doubled as a jailer, Sheriff  
290 Peavy grew the department to more than 60 sworn and civilian personnel; and

291 WHEREAS, Sheriff Peavy was available 24 hours a day, seven days a week, treated every  
292 employee like family, had an open door policy for anyone who wished to speak with him,  
293 and was always firm but fair and full of wisdom; and

294 WHEREAS, touching the lives of many, his impact on those around him and those who met  
295 him is unsurpassable; and

296 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
297 Georgian be recognized appropriately by dedicating a road in his honor.

**PART XV**

299 WHEREAS, the State of Georgia continues to mourn the loss of one of its most distinguished  
300 citizens with the passing of Mr. Asa Charles Daniels, Jr., on April 7, 2014; and

301 WHEREAS, Mr. Daniels served as a guardian of this nation's freedom and liberty with the  
302 United States Maritime Services, valiantly and courageously protecting his fellow  
303 Americans; and

304 WHEREAS, after returning home from the war, he was given the opportunity to purchase  
305 Pinehurst Equipment Company, an International Harvester farm implement dealership, which  
306 was the world's largest manufacturer of farm equipment; and

307 WHEREAS, after a lucrative sale of Pinehurst Equipment Company, Mr. Daniels sold life  
308 insurance to local residents and became a top-producing life insurance salesman; and

309 WHEREAS, Mr. Daniels served as a Dooly County commissioner for 26 years, with eight  
310 of those as chairperson; and

311 WHEREAS, he served his community in various capacities, including Dooly Medical Center  
312 Hospital Authority chairperson, Middle Georgia Technical College board member, and  
313 Dooly-Crisp Empowerment Zone board member; and

314 WHEREAS, his leadership and vision were instrumental on the Small Business Council of  
315 Georgia for four years under Governor Joe Frank Harris and with the formation of the Dooly  
316 County Economic Council; and

317 WHEREAS, he gave inspiration to many through his high ideals, morals, and deep concern  
318 for his fellow citizens, and the devotion, patience, and understanding he demonstrated to his  
319 family and friends were admired by others; and

320 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished  
321 Georgian be recognized appropriately by dedicating an interchange in his memory.

**PART XVI**

323 WHEREAS, Mr. Wallace Lawson Jernigan was born on June 23, 1925, in Jesup, Georgia,  
324 and earned a bachelor's degree in civil engineering from the Georgia Institute of Technology,  
325 where he was a member of Sigma Phi Epsilon; and

326 WHEREAS, Mr. Jernigan worked as an engineer and surveyor, county surveyor, and  
327 licensed funeral director and maintained an oil agency and apiary business; and

328 WHEREAS, he diligently and conscientiously devoted innumerable hours of his time,  
329 talents, and energy toward the betterment of his community and state as evidenced  
330 dramatically by his decades of public service; and

331 WHEREAS, Mr. Jernigan was elected to the Georgia Senate in 1958, where he served as  
332 chairman of the Senate Committee on Educational Matters and earned accolades for  
333 promoting legislation developing criteria for teachers' salaries and qualifications; and

334 WHEREAS, he was elected to the Georgia House of Representatives in 1962 but resigned  
335 shortly thereafter to serve as executive secretary to Governor Ernest Vandiver, administering  
336 the Governor's policies and coordinating between various state departments; and

337 WHEREAS, Mr. Jernigan managed a successful congressional campaign for Williamson S.  
338 Stuckey in 1966 and went on to serve for six years as his administrative assistant in  
339 Washington, D.C., and four years as his district representative in Homerville, Georgia; and

340 WHEREAS, upon Congressman Stuckey's retirement, Mr. Jernigan worked for the United  
341 States Department of Agriculture, where he specialized in making loans for apartments in  
342 rural areas and for water, sewer, and other community facilities for small towns; and

343 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments and  
344 contributions of this remarkable and distinguished Georgian be recognized appropriately by  
345 dedicating a bridge in his memory.

347 WHEREAS, Senator Leroy Johnson was a trailblazer, and his life's work demonstrated his  
348 deep commitment to uplifting the lives of Georgians; and

349 WHEREAS, a graduate of Atlanta University, Senator Johnson earned a law degree in North  
350 Carolina; and

351 WHEREAS, Senator Johnson was elected to the Georgia State Senate in 1962 and was the  
352 first African American elected to the upper chamber since Reconstruction; and

353 WHEREAS, during his 12 year tenure with the Senate, Senator Johnson worked quietly to
