A BILL TO BE ENTITLED  
AN ACT

1 To amend Code Section 40-2-86 of the Official Code of Georgia Annotated, relating to  
2 special license plates promoting or supporting certain worthy agencies, funds, or nonprofit  
3 corporations with proceeds disbursed to the general fund and the agency, fund, or nonprofit  
4 corporation, so as to amend the logo design for special license plates issued to support breast  
5 cancer related programs; to provide for related matters; to repeal conflicting laws; and for  
6 other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 Code Section 40-2-86 of the Official Code of Georgia Annotated, relating to special license  
10 plates promoting or supporting certain worthy agencies, funds, or nonprofit corporations with  
11 proceeds disbursed to the general fund and the agency, fund, or nonprofit corporation, is  
12 amended by revising paragraph (9) of subsection (m) as follows:

13 "(9) A special license plate to support breast cancer related programs for the medically  
14 indigent. The provisions of paragraph (1) of this subsection notwithstanding, from the  
15 additional \$35.00 special license plate fee or special license plate renewal fee charged for  
16 the issuance and renewal of breast cancer license plates authorized under this paragraph,

17 \$12.95 shall be deposited in the general fund and \$22.05 shall be deposited in the  
18 Indigent Care Trust Fund created by Code Section 31-8-152 to fund cancer screening and  
19 treatment related to programs for those persons who are medically indigent and may have  
20 breast cancer. To the extent consistent with Article III, Section IX, Paragraph VI(i) of  
21 the Constitution and Article 6 of Chapter 8 of Title 31, such programs may include  
22 education, breast cancer screening, grants-in-aid to breast cancer victims, pharmacy  
23 assistance programs for breast cancer victims, and other projects to encourage public  
24 support for the special license plate and the activities which it funds. ~~Such design~~ Any  
25 such special license plate issued for the first time on or before June 30, 2021, shall  
26 include a logo the same as the United States postal stamp supporting breast cancer  
27 research and bearing the slogan 'Fund the Fight. Find A Cure.' over the sketch of a  
28 woman and the breast cancer awareness pink ribbon symbol. Any special license plate  
29 featuring such postal stamp design may be renewed after June 30, 2021, as otherwise  
30 provided for by this chapter. On and after July 1, 2021, any special license plate issued  
31 for the first time pursuant to this paragraph shall include the pink ribbon symbol which  
32 designates the fight against breast cancer and such other design as may be approved by  
33 the commissioner without the slogan 'Fund the Fight. Find a Cure.'"

34 **SECTION 2.**

35 All laws and parts of laws in conflict with this Act are repealed.
