

## Senate Resolution 305

## A RESOLUTION

- 1 Creating the Senate University Admissions Study Committee; and for other purposes.
- 2 WHEREAS, postsecondary education is a critical investment by Georgians in Georgia's  
3 future workforce and the health and vitality of Georgia's economy and communities; and
- 4 WHEREAS, several excellent postsecondary educational institutions are located in Georgia,  
5 many of which are renowned nationally and internationally; and
- 6 WHEREAS, competition for admission to Georgia's postsecondary educational institutions,  
7 particularly the research institutions of the University System of Georgia, is significant; and
- 8 WHEREAS, tuition and fees associated with postsecondary education have increased  
9 significantly over the last 30 years; and
- 10 WHEREAS, the average cost of attendance at institutions of the University System of  
11 Georgia increased 77 percent between 2006 and 2015; and

12 WHEREAS, the difference between out-of-state and in-state tuition rates may provide a  
13 financial incentive to postsecondary institutions to prefer out-of-state students to Georgia  
14 residents; and

15 WHEREAS, the General Assembly needs to review the admissions processes of the  
16 institutions of the University System of Georgia and how such admissions processes impact  
17 applicants and potential applicants, particularly those who are Georgia residents, and make  
18 recommendations regarding potential changes to the admissions processes.

19 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE:

20 (1) **Creation of Senate study committee.** There is created the Senate University  
21 Admissions Study Committee.

22 (2) **Members and officers.** The committee shall be composed of seven members as  
23 follows:

24 (A) The President of the Senate shall appoint five members of the Senate, comprising  
25 three members from the majority caucus and two members from the minority caucus,  
26 as members of the committee and shall designate one of such members as chairperson;

27 (B) The chancellor of the University System of Georgia, or the chancellor's designee;  
28 and

29 (C) The State School Superintendent, or the superintendent's designee.

30 (3) **Powers and duties.** The committee shall undertake a study of the conditions, needs,  
31 issues, and problems mentioned above or related thereto and recommend any action or  
32 legislation which the committee deems necessary or appropriate. The committee shall  
33 be authorized to request the assistance of the University System of Georgia to assist the  
34 committee in its study.

35 (4) **Meetings.** The chairperson shall call all meetings of the committee. The committee  
36 may conduct such meetings at such places and at such times as it may deem necessary or

37 convenient to enable it to exercise fully and effectively its powers, perform its duties, and  
38 accomplish the objectives and purposes of this resolution.

39 **(5) Allowances, expenses, and funding.**

40 (A) The legislative members of the committee shall receive the allowances provided  
41 for in Code Section 28-1-8 of the Official Code of Georgia Annotated.

42 (B) Members of the committee who are state officials, other than legislative members,  
43 or who are state employees shall receive no compensation for their services on the  
44 committee, but they may be reimbursed for expenses incurred by them in the  
45 performance of their duties as members of the committee in the same manner as they  
46 are reimbursed for expenses in their capacities as state officials or employees.

47 (C) Members of the committee who are not legislators, state officials, or state  
48 employees shall receive a daily expense allowance in an amount the same as that  
49 specified in subsection (b) of Code Section 45-7-21 of the Official Code of Georgia  
50 Annotated, as well as the mileage or transportation allowance authorized for state  
51 employees.

52 (D) The allowances and expenses authorized by this resolution shall not be received  
53 by any member of the committee for more than five days unless additional days are  
54 authorized. Funds necessary to carry out the provisions of this resolution shall come  
55 from funds appropriated to the Senate; except that funds for the reimbursement of the  
56 expenses of state officials, other than legislative members, and state employees shall  
57 come from funds appropriated to or otherwise available to their respective agencies.

58 **(6) Report.**

59 (A) In the event the committee adopts any specific findings or recommendations that  
60 include suggestions for proposed legislation, the chairperson shall file a report of the  
61 same prior to the date of abolishment specified in this resolution, subject to  
62 subparagraph (C) of this paragraph.

63 (B) In the event the committee adopts a report that does not include suggestions for  
64 proposed legislation, the chairperson shall file the report, subject to subparagraph (C)  
65 of this paragraph.

66 (C) No report shall be filed unless the same has been approved prior to the date of  
67 abolishment specified in this resolution by majority vote of a quorum of the committee.  
68 A report so approved shall be signed by the chairperson of the committee and filed with  
69 the Secretary of the Senate. Any member of the committee may file a minority report  
70 that shall accompany the majority report.

71 (D) In the absence of an approved report, the chairperson may file with the Secretary  
72 of the Senate a copy of the minutes of the meetings of the committee in lieu thereof.

73 (7) **Abolishment.** The committee shall stand abolished on December 1, 2021.
