

## Senate Resolution 311

## A RESOLUTION

1 Recognizing March 25, 2021, as Healthy Foundations Day of Awareness and Recognition;  
2 and for other purposes.

3 WHEREAS, many communities throughout the State of Georgia are at risk due to families  
4 and individuals living in the shadows of crisis; and

5 WHEREAS, individuals and families in crisis endure substance use disorder, PTSD, poor  
6 behavioral and physical health, trauma, poverty, and more; and

7 WHEREAS, Healthy Foundations is an organization established to restore lives through an  
8 integrated system of services on one campus, supporting communities with health care,  
9 housing, education, and employment; and

10 WHEREAS, Healthy Foundations will serve various communities throughout Georgia,  
11 including adults with substance use and co-occurring behavioral health disorders; veterans  
12 with substance use and co-occurring behavioral health disorders and employment issues as  
13 well as those in need of affordable housing; children and families connected to child welfare  
14 services; young adults at risk of becoming homeless; and families living in poverty requiring  
15 employment, education, and health services; and

16 WHEREAS, Healthy Foundations is a collective integrated health care initiative designed  
17 to meet the integrated primary health, behavioral health, and social needs of a community,  
18 in the community; and

19 WHEREAS, by integrating care through collective community based partnerships,  
20 individuals and families are more satisfied with their care, are more accepting of care, and  
21 ultimately demonstrate improved outcomes; and

22 WHEREAS, outcomes improve when the community recognizes the challenges and suffering  
23 of those in crisis and supports efforts to restore lives and ultimately improve the community  
24 at large; and

25 WHEREAS, Healthy Foundations shares a priority with community leadership throughout  
26 Georgia to engage residents, restore lives, and strengthen communities; and

27 WHEREAS, Healthy Foundations is joining with leaders in Georgia to raise awareness and  
28 encourage community support on the Healthy Foundations Day of Awareness and  
29 Recognition on March 25, 2021.

30 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
31 recognize March 25, 2021, as Healthy Foundations Day of Awareness and Recognition to  
32 promote awareness of those who endure conditions of crisis in our communities, to recognize  
33 individuals and organizations that presently serve those in need of restorationm, and to  
34 encourage residents to support community based organizations that collectively address the  
35 needs of those who suffer.
